Preliminary Population and Housing Unit Counts

This report is based on preliminary counts of population and housing units as compiled in the 1980 census district offices. The series consists of 56 reports—number 1 for the United States; numbers 2 through 52 for the States and the District of Columbia in alphabetical order rather than in order of publication; and numbers 53 through 56 for Puerto Rico, Guam, Virgin Islands, and American Samoa. Preliminary counts for the Northern Mariana Islands and the remainder of the Trust Territory of the Pacific Islands are not part of this series of reports. These counts will be made available in a separate press release issued for each area.

This report presents a summary of the preliminary 1980 census population and housing unit counts for the United States, its regions and divisions, each State, and the District of Columbia. Figures for States and the District of Columbia were previously published in

the individual reports of this series. The 1980 counts given in this report incorporate the changes shown in the correction notes in 26 State reports.

These preliminary figures will be superseded by the final counts to be shown in Advance Reports, series PHC80-V. The Advance Reports, which will be published a State at a time, will be issued within the next few months. The final counts are subject to further processing and review and may differ from these preliminary figures.
