Squatterism in San Francisco.

In another portion of this day's paper, will be found an account of an affray occurring yesterday morning, between Capt. Folsom and a Mr. PAGE, in regard to the occupancy of a lot, originating in an attempt on the part of the latter to "squat" upon a lot heretofore conceded to be in the possession---by what title we do not know, unless the lot belonged to the Leidsdorff estate---of Capt. Fol-

The open violence on the occasion, the summary punishment attempted to be inflicted, is but the beginning of what may be anticipated as the result of the decision of the Supreme Court, in regard to land titles, and yet the justice and correctness of that decision receives the sanction and concurrence of the clearest legal heads of the State. That one man possesses as good a title as another to much of the land surrounding San Francisco, and many of the lots in the city, is an undeniable fact; but that reason or law will justify the practice so extended for the past three weeks of locating upon every unoccupied piece of land, is quite another question. Much of the domain attempted to be seized and appropriated by squatter possession, is in the hands of innocent holders, who have purchased it, in many instances, at enormous rates, and who should be protected in their rights, by force of arms, if necessary, within the range of lawful authority. Their title, in fact, may not have that basis and form of legality which is demanded in older States, where record settles the point definitely, but at least they have as good a right to possession as those who would appropriate the land to their own purposes and superadded, is the fact, that they have honestly purchased, and been conceded proprietorship, even though they have not had literal possession by erecting a cabin, or driving stakes.

We are no advocates of lawless violence on any occasion, having entire confidence in the power of the law to right all wrongs, even though they be suffered for a time ; but we will be frank to say that we have an equal abhorrence of the prevalence of such attempts to make a show of title, as originated the difficulty of yesterday morning, and which came so near terminating disastrously. We repeat, violence is objectionable, but we have far more respect for the man who boldly and eterminedly defends his rights, than for that meaking midnight operation which shuns the light of noonday, and which should mantle the cheeks of those engaged in them with shame.

The only apology for these proceedings is the decision of the Supreme Court, that certain land titles are not valid, because of informality as compared with custom regulating such matters under our own government, and, per consequence, these lands must fall into the hands of any body who chooses to run a brush fence, or erect a cabin, even though another has paid full value. But it might with the same propriety be claimed that a cargo of goods that had been purchased and paid for by a third party, were subject to be laid under contribution by whoever pleased, because they had passed the customs irregularly. There is justice in every thing, and although our course would be to appeal to the laws for protection where a wrong was attempted, we cannot but respect the man who is determined enough to deliberately fire upon the miscreants who would despoil him of his rights, with the only apology that he coveted the possessions of another. We trust that there is sufficient moral sentiment in community to prevent a resort to violence upon such occasions, in any future time but we confess we are not without fears for the result of all this lawless business. "Land for the landless, and a home for the homeless," are the dictates of wisdom and humanity, and so long as it is confined within proper bounds, where there is none to interfere who have not the show of title by purchase or descent, it is sound policy, but when men get so bold as to disregard, in their rapacity, the rights of others, where they have not even a shadow of any themsvlves, we can hardly anticipate that the peace and quiet of community will remain undisturbed

Homestead Exemption Law. The Hon. Mr. TINGLEY, from the Judiciary

Committee of the Senate, introduced a bill on the 28th inst., to exempt the homestead and other property from forced sale, from which we make the following synopsis.

The homestead, consisting of, not exceeding eighty acres of land, together with the dwelling house and appurtenances, if out of any city or incorporated town, shall be exempt from prosecution, or any other forced process of law, the owner having the privilege to select the part he wishes exempted. If in any city or incorporated town, the homestead shall consist of a quantity of land not exceeding fifty feet. front and rear, and fifty varas in breadth, together with all improvements. The exemption does not extend to any mechanic's, laborer's, or vendor's lien, or any mortgage lawfully obtained. Any person in the rightful occupation of any land or house, though not owned by him, is privileged to claim the same as a homestead.

The property of a householder, exempt from forced sale under the provisions of this act, consists of all spinning-wheels, looms, pews in place of worship, books, pictures, arms and accoutrements, required by law to be kept by any person, wearing appaoel, &c. There is also allowed to each householder. ten sheep, two cows, five swine, with all decessary provisions for three months, together with tools, furniture, implements, household goods, &c., not exceeding five hundred dollars.

The homestead and other property exempt from forced sale, shall, upon the death of the head of a family, be set apart by the Probate Court for the use of the surviving wife and children, but nothing in the act shall be construed as exempting any real or personal estate from taxation or sale for taxes.

A Squatter Fight.

A Mr. NATHANIEL PAGE had taken posession of a water lot, on a line with Sacramento street, which belongs to the Leidsdorff estate, of which Capt. Folsom is the agent, and at an early hour in the morning, (Sunday) was proceeding with a number of men to erect a structure of some kind on it, when the clerk of Capt. Folsom, a Mr. Wakeman, repaired to the place, and ordered them to lesist and vacate the premises. They not paying any attention to him, he fired four shots at them from a Colt's revolver, but without effect. Shortly afterwards, Capt. Folsom, accompanied by a superior force of men, came to the rescue of his charge from the possession of the squatters, and immediately commenced demolishing the work that had been raised. While doing this, he was commanded by Mr. Page to desist, and on his continuing, Page struck at the Captain with a heavy broad-axe, narrowly missing him. Capt. F. returned the blow with another axe, which just grazed the knee of Page, cutting his pantaloons. Capt. F. then drew a pistol, and on Page making further demonstration of violence, he fired at him, the ball striking a heavy gold watch in Mr. P.'s pocket, and shattering it into fragments. Mr. P. immediately remarked, with the utmost coolness, "You have shattered mebroke my watch," and again commenced resisting the demolition of his structure, when he was seized, thrown down, and disarmed of his axe, by several of Capt. F.'s men. This terminated the conflict, and left Capt. Folsom victor of the field, which he improved by throwing the lumber of the structure into the bay at large.

The great battle of the Capitol is fought and-won for VALLEJO. A slight murmur of applause, quickly checked by the loud raps of the impartial Speaker, followed a comparison-the only one I remember him to have made-of Gen. Vallejo, in his princely offer to the people of California, to what he called a similar offer of a reputed prince who took an innocent being once upon a time, into "an exceeding high

mountain," whence he showed him all the kingdoms, &c., if he would fall down and worship him! Bating a few blemishes of this sort, into

which Mr. Campbell was betrayed, I am sure, only by his anxious and too earnest desire to serve the interests of his constituents, the effort of the honorable gentleman was certainly a very creditable one.

He was replied to briefly by Messrs. Moorr and MURPHY, both of whom spoke in the most calm and placid manner, and whose words of truth and soberness" fell out "like apples of gold in pictures of silver." Indeed the calm and deliberate manner of the entire Vallejo interest, could not fail to excite the marked attention of all present. Although conscious of their overmastering strength, and fully resolved on their puroses. they exhibited a disposition altogether inwilling to take the slightest advantage of heir superior numbers. The final vote, exnibiting but eight names out of the thirty-six nembers of the Assembly, shows more plainly than words can describe, that the Legislaure, not less than the people of California, by their free choice, have selected VALLEJO as the site of their Capitol.

I will not occupy your columns in specu lations as fruitless as they are unecessary, as to questions growing out of this choice. For my part, I believe that General Vallejo will promptly and faithfully redeem all his pledges; and that the high-minded and honorable gentlemen who are interested with him in carrying on the undertaking, alike with himself, will not be content to rest satisfied with their efforts, until they have laid broad and deep the foundations of a capitol at Vallejo, such as shall do honor not only to him who gives it his name, but to the Government. Were these identical, nothing would cost more than the air we breathe, the water we drink, and the blessed sun-light; and few things would cost less than the emerald, sapphire, and ruby. But while intrinsic value depends wholly upon utility, commercial value de-pends wholly upon the proportion between supply and demand; and can in no sense be said to be given by law, nor by the sanction of nations, although the demand depends

upon the necessity or inclination of purchasers, as the supply does upon the cost of production. In this respect, gold and silver do not differ in the least from other commodities. Men choose to have them, and they are not so easily got as leather or iron; therefore they cost dearer. Again, that

"the law has made it the *standard* of value," is true; but that it is "by law made the *regulator* of the whole," is not true. Be-

cause in the sense in which coin is a stand-

ard of value, it does not regulate value. For

Surely, then, it is not too much to expect them to have regard for public, opinion in making the laws, as in other things. If indeed they are so fully persuaded of the immeasureably greater guilt of making a loan on hard terms, than of making a sale for rather over the value of the article, that they must speak or be eaten up by remorse, in God's name, let Blackmore vs. Bull. Ordered that plaintiff them discharge their consciences, and take the consequences, whatever these may be. But I hope there is no disrespect in my doubting very much whether any one of their consciences is so extremely over-tender as this supposition would imply, or whether any such motive has impelled them to sanc-

tion the law under consideration. The only other argument is the old one of authority. "From the message of Moses to the message of Gov. Burnett, legislative restraint has been thrown around the usurer, in every land of law except California. Have there been no wise men in any age before ? The message of Moses proves rather too much for Civis, I believe. Unless I am mistaken, Moses forbade, not only what we call usury, or excessive interest, but the taking of interest at all, by one Jew from another. we go a little beyond Moses, and allow the taking of moderate interest, must we therefore conclude that he was not a wise man, or may we not go a little further, and allow interest to regulate itself ? But in fact, the whole argument is childish. The wise man is not he who is possessed of all truth, but he who is possessed of more truth than the mass THE CONSTITUTION.---This fine steamer our fathers as fools because we venture to nor do we set ourselves down as fools when we admit that our children will improve on ours. Saturday, Feb. 1, 1851. The money market has been unfavorably affected by the agitation of the usury law, and money borrowers have been compelled to meet their liabilities by cautious capitalists, who do not choose to be largely extended while this law is under consideration.

State warrants are held with a good degree of firmness, under the impression that the state will grant her creditors interest. An objection is made to the payment of interest by gentlemen in the Senate upon grounds that upon consideration will be found untenable. The passage of the act paying interest upon warrants cannot by the most remote possibility be of henefit to a broker unless he is also a capitalist and buys for investment. It is the man who having confidence in the solvency of the State, buys her evidences of debt and holds them until the State can meet them. It is honorable members themselves who will be benefitted by the passage of the interest bill, which will bring warrants nearer their true value and save members the great depreciation they now submit to. The State has had the money, or its value, and honestly owes interest, and it will not be to her credit it she pleads the strict letter of her constitution as a reason for refusal to grant this simple justice. If this strict construction was right, the government should have suspended operations long ago, for it was a palpable fraud to obtain credit when she knew she could not legally pay. As a matter of self preservation the State should make her debts good, and upon this ground alone do we urge the payment of

interest until the principal can be paid. We are no advocate of a State debt.
