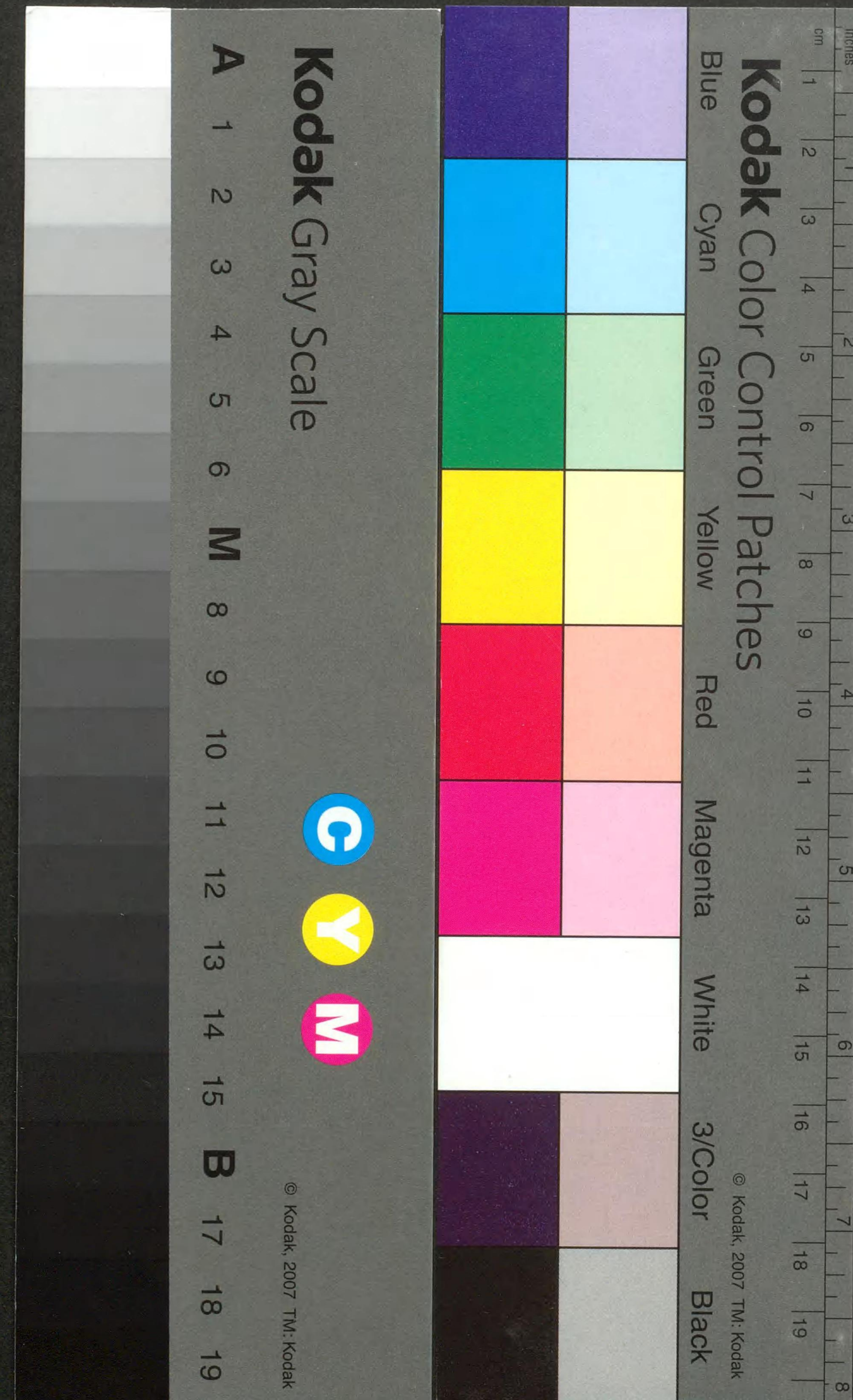

The Ministry of Commerce and Industry, the Min-

istry of Agriculture and Forestry and the Ministry of Welfare have prepared the drafts of the grade, standard, minimum standard, and packaging condition of export goods in accordance with the Law concerning Control of Export Commodities (Law No. 153 of 1948). In this regard, the public hearing will be held according to the following schedule in order to hear the opinions of those who have interests in the matter.

You are kindly requested to submit in your views.

1. Question: The question concerning the grade standard, minimum standard of export, and packaging conditions, etc., of the export goods provided for in Article 3, and Article 4, Law concerning Control of export commodities.
