Your rights

Within the framework of the legal requirements, you have a fundamental claim against Mandalah Europe GmbH:

- Confirmation whether personal data concerning you will be processed by Mandalah Europe GmbH,
- **Information** about these data and the circumstances of the processing,
- Correction where these data are incorrect,
- **Deletion,** insofar as there is no justification for the processing and no obligation to retain (any longer),
- Limitation of processing in specific cases determined by law; and
- **Transmission** of your personal data if you have provided it to you or a third party in a structured, common and machine-readable format.

In addition, you have the right to revoke your consent at any time to **Mandalah Europe GmbH**, with the result that the processing of your personal data, in accordance with your declaration of revocation, by this for the future is inadmissible. However, this does not affect the legality of the processing that has taken place on the basis of your consent up to the point of revocation.

"Personalized data" are defined as any natural person who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person This can be, for example, information on where a person is insured, lives or earns money. The mention of the name is not important. It is sufficient to be able to find out which person it is.
