Gentlemen:

I most respectfully beg to submit to you the following for your kind perusal and consideration. I am a Roman Catholic Polish subject, born in June 1862 and now near 85 years of age. I am a mark master mason A.E. & A.M. My Mother Lodge is: Lodge Saltoun (?) No. 936 Shanghai and was S.D. in the Lodge. Am also a Brother of the Earle of Dunfries Lodge R.A.O.B. Cardiff S. Wales, England.

What I beg of you Gentlemen is: I am very much in need of old, worn warm Under Clothing, Trousers, Stockings, Boots or Shoes, and in need of nourishing food. I am 6 feet tall, of heavy built but now very much reduced owing to Under Nourishment. The number of my boots or shoes is a large No. 10. I'm a permanent Resident of this place for near 25 years, being retired from the Chinese Customs in 1922 where I served for 22 Years owing to the Age Limit of 60 years. I am in poor Health, owing to Under Nourishment and a complicated illness. Last winter I had to live in a cold fireless House and this winter is the same. The Clothing I beg of you Gentlemen may be of the Civilian or military kind and as much of Food as you can spare. On the 12th of November I wrote to his Excl. General MacArthur, also to the Rev. Father H. Fobillard - Fukuoka, but received no Reply. I've written to the Kensho & Relief Agent in Kumamoto, but received only Excuses and empty promises. The Rations of Food I'm permitted to obtain for November and December I have not received yet. Last year, I had an offer of 1 ob. cans of Beef priced at 37 yen a can, but that is too expensive for me, as I am a poor man, my Money savings are nearly gone owing to the inflation. The Income I have is an annuity for 13 L. 6 Shg a Quarter of the Sun Life Assurance Co. Of Canada, and the Japanese Co. that took over from the Sun Life, is paying me for my 13 L. 6 Shg.: 228 Yen a Quarters, that is: 72 yen a month, a very little Amount to live on. I am so cold, I can hardly hold the pen to write.

Hoping and begging that you Gentlemen will grant what I'm asking for: Clothing and nourishing Food, and thanking you in Advance,

P.S. I'm an Old Sailor, came to New York City in 1876. A boy 14 years old and sailed for several years from U.S.A. ports, till I came to Cardiff England from where I sailed for 10 years in Steam. Finally I came to Shanghai-China, where I joined the Customs. IN Margin: I've roamed the 7 Seas for 24 years and so please Gentlemen, take an poor old former sailor in hand and I'm sure our Good God will repay you a thousand fold.

MEMORANDUM FOR RECORD:

430
6 February 1947

Verbal request received from Maj. Jones, Chief of Internal Affairs, Tokyo-Kanagawa Military Government District, concerning 497 sacks of canned goods (estimated from 10 to 12 cans per sack) which are stored in Yokohama under the jurisdiction of Japanese officials. These goods came from Leyte about a year ago and are from U.S. Army sources. They were originally intended to be used as aid for foreign nationals. About six or seven months ago some officials from SCAP "condemned" the canned goods, but no further action has been taken. A sample -- 6 or 8 cans -- was opened on this date and the medical officer found all the cans opened to be fit for human consumption. Since some of the cans are badly bent, it may be that a part of the stock should be destroyed.

Telephoned Mr. Nelson Neff, Welfare Division, SCAP, and gave him the above information. Mr. Neff stated that it is authorized to use the canned food for relief purposes if a medical officer certifies that what is remaining can be used for food.

Subsequently telephoned Maj. Jones and suggested that he work out a plan for the use of the canned goods after it has been thoroughly inspected. He is of the opinion that since the food was originally intended for foreign nationals, it should be turned over to the International Relief Committee for needy foreign nationals. At one time this food was made available for purchase by foreign nationals as a part of the supplementary food ration and some stuff was actually sold and later recalled when it appeared that some of the stuff had been spoiled.

Clearance will be made with the proper Japanese officials before a final decision is made since the local Japanese officials probably do not have authority to release the goods without the approval of their central government.

LATER: Talked with Maj. Sunderville, health officer, who stated that he had heard of the food and that it had been inspected by Col Dixon, Veterinary Officer, SCAP, who had reported that a part of the cans were badly bent and undoubtedly the food had spoiled. Maj. S. does not believe it was intended to condemn all the goods, but only that part which has spoiled. As far as can be determined, there is no written record on this food and the action taken.

We take pleasure in bringing to your knowledge the Distribution Scheme of Relief Committee Supplies to Foreign Nationals in Hokkaido as decided by our Sub-Committee on the 2nd of September 1946, which received its approval as just and fair by the Authorities concerned and to make you acquainted with the members of our Sub-Committee.

In case, that you should feel to have justified claims for reclassification of our class as mentioned below, you are kindly requested to submit your wishes to our Sub-Committee or any member thereof for reconsideration.

- "A" Those who have no savings and own no property & those marked "INSUFFICIENT" with no income.
- "B" Those, who are declared as "INSUFFICIENT" with small incomes or "SUFFICIENT" with no income
- "C" "SUFFICIENT" owning property, real estate, having merchandise in stock or big saving account and sufficient income.
- "D" Those, who are in the employ of the M.G. or other units of the Army of Occupation.
- "A" Will have priority on clothes, shoes and foodstuffs. (Sisters, Fathers Missionaries, and therelike religious, educational and charity workers belong to this class)
- "B" Will receive approximately 10% less than "A"
- "C" Will receive approximately 40% less than class "A"
- "D" Will receive clothes and footgear as class "C" but no foodstuffs.

TO: Commanding General, Eighth Army, APO 343

1. Recommendation for relief from duty with International Relief Committee of Mr Carl Raymon has previously been concurred in by this headquarters.
2. It is understood that there remains to be distributed only one allotment of International Relief Committee supplies. If this is the case, it is believed that the committee currently in operation, because of experience, however slight, can be instructed to make the final distribution in accordance with Operational Directive #8, Headquarters Eighth Army, dated 13 January 1947.
3. It is further recommended that the distribution plan shown as inclosure 1 to basic communication be altered to include only those persons listed as Category "A" subtracting therefrom those religious, charity, or welfare workers in touch with their Mother Church or native country, and basing distribution on needs rather than desires.

4. The distribution plan of the Hakodate Sub-Committee was instigated by the Public Welfare Section, Hakodate Military Government Region in September 1946. (See Incl No 1). This plan was forwarded to the International Relief Committee, Yokohama and apparently approved. A copy has been forwarded to all recipients of IRC supplies. Mr Kravtsoff, the Russian committee member has furnished Mr Raymon with the data for the Russian classifications. Close scrutiny was given Russian receipts. It was found that the Russians received as much as any one else, and that the plan of distribution was being carried out in all cases.

5. The list of recipients in the Hokkaido area was examined. The list contained the names, addresses, number of persons in the family, nationality, occupation, total family income and estimated budgetary deficiencies. The list did not have the amount of supplies issued thereon as required by paragraph 5, letter, file no. AG 475 (MG-I), Headquarters Eighth Army, subj: "Distribution of Relief Supplies to Needy Foreign Nationals", dated 10 January 1947. The amount of supplies issued were on the receipts only. Mr Raymon was advised by the investigating officer to comply with the above mentioned letter. Of the few recipients who fell under the classification of having married Axis nationals not one was to be found that had received more than 20% of the total amount of supplies issued.

6. During a prior investigation of Mr Raymon, mentioned in paragraph 1 above, it was definitely proven that Mr Raymon was a German sympathizer during the past war. It is recommended by this headquarters that Mr Raymon be relieved of his duties with the Hakodate Sub-Committee. It is further recommended that a new committee be elected by the recipients of IRC supplies. It is felt that the present committee is too weak to carry out its functions. This has been proven, as no member of the committee has ever volunteered to give Mr Raymon help, but have been perfectly satisfied to let him do it all. The election of a new committee could be supervised by the Public Welfare Section of this headquarters.

TO : Commanding General, IX Corps, APO 309
(Attn: Military Government)

1. In compliance with paragraph 4, letter your headquarters, file no. MIL GOVT 353.81, subj: "Distribution of International Relief Committee Supplies for Month of April" dated 16 May 1947, an investigation of the Hakodate Sub-Committee, International Relief Committee, Japan, was made by an officer of this headquarters. It was learned that the Sub-Committee was formed in April 1946 at Hakodate, Japan, under the supervision of the Hakodate Military Government Detachment. The committee has four members. They are: Mr Carl Raymon, Czechoslovakian, Secretary; Rev. Father Paul Jamme, French, Committee Chairman; Mr Alexander Kravtsoff, Russian, and Mr Chen Bi Chu, Chinese. Mr Raymon told the investigating officer that he had been appointed to the committee to represent the minority groups in Hokkaido by Lt Rush of the Military Government Hakodate Detachment. Mr Raymon does all of the issuing of supplies and bookkeeping without help and without pay. This seemed to be satisfactory with the rest of the committee, as they have only met three times since it was formed. However, two Russian Foreign Nationals have now accused Mr Raymon of withholding several items of supply. There is no proof of this as the receipts held by the Russians were signed by them as having drawn their full amount. (Attention is invited to letter, this headquarters, subj: "Report of Investigation of Mr Carl Raymon, Secretary of the International Relief Association, Hokkaido Sub-Committee, Hakodate, Japan," dated 15 May 1947)

2. The investigating officer visited the home of Mr Carl Raymon, Hakodate, Japan and checked all of his receipts, method of distribution, register of recipients and monthly reports. The investigating officer could find no discrepancies in any of the records, nor any evidence of wrongful distribution. The monthly report of the Hakodate Sub-Committee for the month of April 1947 shows all items that the Sub-Committee had on hand were issued. As most of the items were issued at earlier dates, the report shows only a small amount issued for the month of April 1947, leaving nothing on hand.

3. The investigating officer compared all of the signed receipts in Mr Raymon's possession with the invoices sent to Hakodate by Relief Headquarters in Yokohama. Several small items that were missing were accounted for by Mr Raymon and Lt Richard Murray of the Hakodate Military Government Detachment, who stated that several boxes of relief supplies had been pilfered en route to Hakodate from Yokohama. Lt Murray has accompanied Mr Raymon each time a shipment arrives in Hakodate and has inventoried the supply items. No major supply items were missing, only some candy etc.

1. Final distribution of International Relief Committee supplies to Hokkaido was made by the Central Committee, Yokohama, without assistance from Mr Carl Raymon or other members of the Hakodate Sub-Committee. The sub-committee was disbanded and its books, records, and funds were turned over to the Central Committee as of 22 July 1947. The funds include voluntary donations to the Hakodate Sub-Committee which will be turned over to the duly authorized agent of a mutual benefit association of foreign nationals in Hokkaido now being organized.

2. The final distribution consisted of clothing which is considered not available on the Japanese market, rationed or otherwise. Supplies were distributed in accordance with established policies for handling International Relief Committee supplies.

SUBJECT: Distribution of German Navy Foodstuffs Now under United States Army Control

TO: Commanding General, Eighth Army, AFO 343

It is desired that the foodstuffs as listed on inclosure and now under control of the Hyogo Military Government Team, AFO 317, be distributed through the International Relief Committee in Kobe as a supplementary ration to foreign nationals in the Kobe-Osaka area on a free (no sale) basis and not distributed in addition to or in excess of the supplemental ration authorized for foreign nationals. This method of distribution is in accordance with Headquarters, Eighth Army, Operation Order No. 8, paragraph 2, dated 13 January 1947, subject, "International Relief Committee" which states: "The International Relief Committee has been designated by the Commanding General, Eighth Army, to handle the distribution to foreign nationals of air-dropped prisoner of war supplies, stocks seized from enemy nationals other than Japanese, and certain Red Cross clothing supplies."

We are in receipt of your letter of the 29th May & note with pleasure that you have been able to co-ordinate the working of your Sub-Committee & that full co-operation of the Russian representative is now assured.

In the opinion of Headquarters Military Government & the Central Committee the dissension which exist in your small community is most unfortunate & the steps taken by some nationals left a disagreeable impression.

While fully appreciating the difficulty in bringing together a cosmopolitan community, if the Sub-Committee had more meetings & consulted the members of the community as a whole, some of the vexing questions that arose could have been avoided.

Your area is the only one from which we have had so many complaints. Although we have more than thirty times the number of foreign nationals you control in this area, we have so far been able to keep clear of any criticism.

We are very grateful to Mr. Carl Raymon for the energetic & disinterested efforts he has put forward in our relief work and we fully sympathize with him in the annoying situation in which he has been placed through lack of co-operation in your community.

The critical period following the end of hostilities having more or less passed we have been asked by the Military Government to take measures to gradually close down our relief work.

We intend therefore to wind up the more distant & small Sub-Committees to start with & Hakodate will have to come under the ax.

We will have one more extensive supply to send you & it will be the last one for your area.

In this connection, we should be glad if you could send us as soon as possible a complete list of names, sex, age & nationality of all those in your community, so that we can prepare from material in hand a complete assortment for distribution.

We should like the list so prepared to enable us to make two separate shipments for Hakodate & Sapporo. It is the intention of our Chairman to personally visit your area at the end of next month to co-operate with you and your Military Government Welfare Officer in the final distribution, in order to satisfy all the members of your community in connection with our work.

Captain Jacobson who is now in charge of HQ. Military Government Welfare Section has kindly consented to visit your area with our Chairman if he can spare the time.

Your proposal regarding remuneration for Mr. Raymon from the Voluntary Contributions to the Monetary Relief Fund, is not authorized.

Collections for the fund in question was permitted only for a definite purpose & that is to give help to really destitute foreign nationals & more especially to build up a fund for a benevolent association to take over the relief work of the Sub-Committee.

Members of the Committee hold honorary positions & are to work without remuneration, therefore Mr. Raymon cannot be a member of the Committee & be paid.

We should appreciate statements of your Expenses Account & Monetary Relief Fund for destitute foreign nationals Account, so that the Central Committee can pass it for approval by the Headquarters Military Government.

You sent us Mrs. Hasegawa, a very worthy lady of Russian birth, who married a Japanese national, with recommendation for help by this Committee.

Mrs. Hasegawa having married & acquired Japanese nationality should not have received relief under the former directive & under the new directive only as a restricted person.


As she was given relief in Hakodate, we have had to deny her further help for the time being.

The duplicate questionnaires you sent us are far from complete therefore we require the list we mentioned in the first part of this letter.

For the Supplementary Ration, as the SCAP Directive makes this a Military Government concern, should the rationing not be satisfactory it would be a matter for the foreign nationals to take up individually or in groups with the Military Government Officer in charge.
