

WHEREAS it has been, generally, found neceffary and convenient in all incorporated Societies, from time to time, to revife their By-Laws; fo the Connetticut Medical Society at their Seffion in October 1801, paffed the following Vote :-viz.

⁵⁶ VOTED—That William B. Hall, Jared Potter, and William Shelton, be a Committee to revife the By-Laws of the Society, and report to the next Convention."

Said Committee made the following Report at the May Seffion 1802, and it was accepted.

The ACTS incorporating a MEDICAL SOCIETY in the STATE of CONNECTICUT.

[ENACTED IN MAY 1792.]

WHEREAS well regulated Medical Societies, have been found to contribute to the diffusion of true Science, and particularly to the knowledge of the healing Art; Therefore,

PAR. 1. BE it enacted by the Governor and Council, and Houfe of Reprefentatives, in General Court affembled, That there be a Medical Society formed within this State, to confift of the following Perfons, viz : James Potter, Leveret Hubbard, Charles Phelps, Joshua Porter, Amos Mead, Charles Mather, Josiah Hart, Eliakim Fish, Samuel Flagg, Eneas Munson, Jared Potter, John Lester, David Rogers, Phillip Tur-

ner, Elisha Perkins, Isaac Knight, Daniel Sheldon, Phinehas Miller, James Schovill, Samuel Woodward, Ichabod Warner, Jeremiah Weft, David Sutton, Elihu Tudor, Timothy Rogers, Joseph Baker, John Watrous, Seth Bird, Minor Grant, Simon Wolcott, John Ofborn, Afa Hamilton, Theophilus Rogers, Lemuel Hopkins, Philemon Tracy, Mason Cogswell, Thaddeus Betts, Thomas Coit, Joshua Downer, Elnathan Beach, John Turner, John Spalding, Levi Ives, James Clark, Albigence Waldo, John Clark, and Elifha Lord, with fuch other Phyficians and Surgeons, as shall hereafter be approved of, and admitted from time to time, as is herein after provided, that is to fay, The Phyficians and Surgeons, living in the respective Counties shall have liberty. to meet together on the fourth Tuesday of September next, and at fuch place within their. respective Counties, as shall be appointed by, Lemuel Hopkins, Eneas Munfon, Simon Wolcott, Albigence Waldo, James Potter, Seth Birda Jeremiah Welt, and John Ofborn ; and by them notified, by advertifing in fome public Gazette in the Counties in which they respectively dwell, and when fo met, they shall have authority by their major vote in such respective Meetings, to. determine the qualifications, and admiffion of their own members, and the perfons who shall thus be admitted, shall have authority to make choice of a Chairman and Clerk, to conduct the. affairs of luch Meetings.

2. Be it further enacted, That fuch County. Meetings formed as aforefaid, and all future County Meetings, which the members fo approyed and admitted as aforefaid, with fuch others as fhall hereafter be duly approved and admitted purfuant to this act, fhall annually hold on the fourth Tuefday in September, which they are

hereby authorifed to do, and at fuch place as they. shall appoint the faid future Meetings, having organized themfelves with a Chairman and Clerk as aforesaid, are hereby authorised and directed to choose by ballot from amongst themselves, five perfons for each County, except for the County of Middlefex and Tolland, and three for. each of those Counties, to compose a Convention, of faid Society; which members fo to be chosen for faid first Convention, shall meet at the Court House in Middletown, on the second Tuesday of October next, at 10 of the clock in the forenoon; and for the future annual Conventions at fuch. time and place as they shall appoint, and being fo met, they are hereby authorized, by ballot to choose a President, Vice-President, Treasurer, and Secretary, and fuch other Officers as they may think proper, and the Convention fo formed, shall be known by the name of the Prefident and Fellows of the Connecticut Medical Society; and shall hold their offices for the term of one year, and shall have full power to make By-Laws to, promote the ends of faid Society, provided they be not repugnant to the Laws of this State, or of the United States, and may expel members from faid Society, for any mildemeanors as relative to, faid Society; to appoint examining Committees in the respective Counties, who shall examine fuch candidates as may offer themfeves for that purpose, and license such as shall be found qualified for the practice of Phyfic or Surgery, and to receive them on their defire as members of faid Society in their respective Counties; to confer Honorary Degrees on fuch of the Faculty as they may from time to time, find of diffir guilhed. merit, to purchase and hold to, and for the benefit of faid Society, property, both real and perfonal, to an amount not exceeding Sixteen Thousand

Six Hundred and Sixty Seven Dollars, and to manage, improve and convey the fame for the common good and interest of faid Society; and may have a common Seal, and the fame alter and renew at their pleasure; and the faid Society, in their corporate capacity, may fue and be fued as other Societies and Bodies corporate may by Law, as relative to the contracts, rights and interests, of faid Society. Twenty members to be prefent to be a Quorum to transact the business of faid Society.

3. Be it further enatted, That it fhall be the duty of the feveral members of the Society, according to their ability, to communicate ufeful information to each other in their refpective County Meetings, and fuch Meetings fhall, from time to time, transmit to the Convention, fuch curious cafes and obfervations, as may come to their knowledge; and it fhall be duty the of the Convention to caufe to be publifhed, fuch extraordinary cafes, and fuch obfervations on the flate of the air, and on epidemical and other diforders as they may think proper; and the faid County Meetings and Conventions fhall have power to adjourn, from time to time, as they may think neceffary, to promote the defign of their inflitution.

4. Be it further enacted, That if this act, or any thing therein contained, fhall be found inadequate or inconvenient, it may by the General Affembly be altered, amended, or repealed.

[ENACTED IN OCTOBER 1793.]

B E it enacted by the Governor and Council, and Houfs of Reprefentatives, in General Court affembled, That in future, the number of members of faid Society, neceffary to conflitute a Quorum to transfact business in Convention, shall be twelve -Any law to the contrary notwithstanding.

[ENACTED IN MAY 1797.]

PAR. 1. **B**^E it enacted by the Governor and Council, and Houfe of Reprefentatives, in General Court affembled, That at the future Conventions of faid Medical Society, for the choice of its officers, they fhall have power to elect them from the Medical Society at large in this State, and not be confined to the members who may compose the Conventions of faid Society.

2. And be it further enacted, That the Prefident of faid Society, or in his abfence the Vice-Prefident, fhall upon any emergent or fpecial occafion, call a Convention of the Fellows of faid Society, upon giving twenty days notice thereof in two of the public Gazettes, at fuch time and place within the State as he fhall judge proper.

3. And be it further enacted, That the Convention of faid Medical Society at their annual Meetings, fhall have power and authority to levy a tax on all the members of faid Society, not ex-, ceeding Two Dollars annually, on each and every member thereof, which tax shall be collected by the Clerks respectively of the County Societies in the feveral Counties : And in cafe of neglect or refufal of any member of faid Medical Society to pay the fame, the Clerk of the County Society within which fuch refufal fhall happen, fhall have authority to inftitute a fuit for the recovery of the fame, in the name of the Treasurer of faid Society, before any Affistant or Justice of the Peace within faid County, where the perfon fo neglecting or refufing as aforefaid fhall dwell; and fuch Affistant or Justice of the Peace is hereby authorifed to hear and determine the fame and grant execution thereon accordingly.

[ENACTED IN MAY 1800.]

PAR. 1. BE it enacted by the Governor and council, and Houfe of Reprefentatives in General Court affembled, That no perfon in future who shall commence or enter upon the practice of Physic or Surgery in this State, who has not been duly licensed, by some Medical Society or College of Physicians shall take benefit of laws for the recovery of any debt or fees for fuch practice:

2. And be it further enacted, That the fees or perquifites for the admiffion of any candidate to the Medical Society in this State shall not exceed the fum of Four Dollars.

Refolved, That when any new Clerk be chosen in any of the Counties, his predecessor is directed to deliver over all the records and papers appertaining to the office, retaining copies of the fame, if he thinks proper; *Provided always*, that the former Clerk shall have access to the records so delivered over, to take attested copies thereof, if he request them.

Voted, That the Fellows be a Committee of Abatement of Taxes in their respective Counties.

Voted, That a Tax of One Dollar be laid on each member of the Medical Society.

Voted, That William B. Hall, Jared Potter, and William Shelton, be a Committee to revife the By-Laws of the Society, and report to the next Convention.

Voted, That the following be prize queftions: 1/t. Scirrhus, its caufes, fymptoms, and modes of iffue; what is the beft method of treatment in its recent state? How treated if it becomes cancerous ?--- Premium, Parkinfon's Noyage to the South Seas.

- 2d. Chronic Rheumatifm, what, how diftinguished from the inflammatory Rheumatifm; allo, how diftinguished from the Gout, its causes, fymptoms, and best method of cure ?--- Premium, Doctor Fothergill's Works.
- 3d. Mercury, its nature, what preparations of it are best, in what difeases, and how to be administered?

N. B. It is expected those gentlemen who are disposed to write on any prize questions, transmiter, their compositions to the Secretary, in the English, Latin or French-language, on or before the first day of fitting of Convention. And the fuccelsful candidates shall receive the thanks of the Connecticut Medical Society, their names published in the public Gazettes of the State, and their Differtations kept on file for publication. And that with each differtation there be delivered a fealed packet, with some motto or device on the outfide, and within, the author's name and designation; and the fame motto or device shall be put upon the differtations, that the Fellows may know who to address as the fuccessful candidate.

No differtation with the name of the author affixed, can be received; and if the author of any differtation shall difcover himself to any Fellow of the Society before the adjudication, such paper shall be excluded from all competition.

All the differtations, the fuccefsful excepted, fhall be returned if defired, with the fealed packets unopened.

Voted, That this Convention be adjourned to the City of Hartford, at the house of John Ripley, on the Wednesday after the second Thursday of May next.

At an adjourned Convention of the Connecticut Medical Society holden the 19th of May, A. D. 1802, at the house of Major John Ripley, in Hartford.

A DISSERTATION was prefented (for the offered premium on the Chronic Rheumatifm) the confideration of which, was postponed to the annual Convention in October next.

Voted, That the Revision of the By-Laws of the Connecticut Medical Society, as reported by the Committee appointed for that purpofe in October laft, be accepted; and that the fame be printed; and that the other doings of the Society from its origin, together with the names of its Officers, Fellows &c. be added by way of Appendix; and that the doings of the prefent Convention be likewife included.

Voted, That five hundred Copies be printed.

Voted, That William B. Hall be a Committee for printing as above.

Voted, That by the application of Doctor Samuel Willard; Doctors E. Tudor, A. Tomlinfon, and T. Mofely be a Committee to examine the waters of Stafford Medicinal fpring, with the evidences of its Medicinal virtues, and make report thereon.

The Committee to examine the qualities of the Mineral waters of the Spring or Pool in Stafford; Report, that faid waters poffels valuable Medicinal properties, and would be highly ufeful to the public under proper regulation.

Doctors James Potter, E. Tudor, T. Mofeley and Samuel Woodward, were appointed a Committee to prepare a bill for the purpofe of meliorating the Medical Treafury fystem. Said Committee reported thereon by memorial to the General Affembly, and a bill thereon, praying further affistance---which report was accepted. Voted, That Doctors Jared Potter and John Befter be a Committee to prefent the above memorial and bill to the General Affembly, at their prefent feffion, and to make fuch alterations as they may find neceffary.

Voted, That a Committee be annually appointed, for the purpofe of recommending to the Convention fuch characters for the degree of Doctor of Medicine as they shall judge worthy of that honor; either by examination, or fuch other testimonials of qualifications as shall be fatisfactory to them; and that the fee for a Doctor's Diploma shall be ten dollars; provided that this refolve have no retrospective view, nor the fee of ten dollars be exacted from any person on whom fuch degree shall be conferred, unfolicited.

James Potter, Elihu Tudor, Thomas Mofeley, Jared Potter, and Thaddeus Betts, Doctors of Medicine, were chofen a Committee for the above purpofe.

Voted, That the Treasurer be directed to call upon those examining Committees, who have not made legal report of their proceedings, to make a report to the Convention in October next; and on failure of making due report; to commence proceffes against such delinquent Committees, to compel them to the performance of their duty.

Voted, That the blank Certificates be lodged with the Treasurer, previously figned and fealed by the Prefident; and that the Treasurer supply the various examining Committees with such certificates when requested.

Voted, That the next Convention of the Prefident and Fellows of the Connecticut Medical Society be holden at Butler's Tavern, in New-Haven, on the Wednefday next fucceeding the fecond Thurfday of October next.

* The BY-LAWS of the CONNECTICUT MEDI-CAL SOCIETY from October 1792 to October 1801 —are as follows—viz.

N. B.—In the Appendix, are to be found, the annual returns of Fellows ;—thofe chofen Officers and Examining Committees in the refpective Counties ;—together with other Doings, from time to time, of the Convention.

October 1792.

Refolved, THAT a Committee be appointed in each County, confifting of three Members of the Connecticut Medical Society, for the examination of Candidates for the practice of Phyfic and Surgery.

Refolved, That the aforefaid Committees, in the feveral Counties, be furnished with blank Licenses figned by the President, with the seal of the Society affixed; to be filled up and counterfigned by faid Committees, and delivered to such Candidates, as shall be found duly qualified.

R folved, That each Candidate receiving a License executed in the aforefaid manner, pay to the Committee of examination the fum of four do lars; to be by faid Committee deposited in the Treafury of the Connecticut Medical Society.

Refolved, That the Clerks of the feveral County Meetings, transmit to the Secretary, the names of all the members of the Connecticut Medical Society, that belong to their respective Counties, by the fixteenth day of May next.

Refolved, That the Prefident and Fellows of the Connecticut Medical Society shall receive a compensation for their attendance in Convention.

* Those of October 1801 and May 1802, see the beginning of the Revision. Refolved, That a tax of three fhillings on each member of the Connecticut Medical Society; and alfo, on fuch Phyficians and Surgeons as fhall become members the current year, be levied, collected and paid into the Treafury, to defray the expences of the Society.

May 1793.

Be it ordained, THAT the Secretary of the Connecticut Medical Society, fhall record all the transactions of the Convention, and conduct their correspondence, and have the custody of the Seal of the Society.

Be it ordained, That the Treasurer shall keep the monies of the Society subject to their orders, and shall annually render an account to the Convention of all monies received and paid by him.

Be it ordained, That it fhall be the duty of the examining Committees in the feveral Counties to make an annual return to the Secretary of the Society, of the feveral perfons by them licenfed, and the date of their Licenfes, and an entry fhall be made in the Records of the Society, of every Licenfe granted, containing the name of the perfon licenfed, and of the Prefident and Examining Committee figning the fame.

Be it ordained, That all communications from members of this State, fhall be made to the Clerks of the County Meetings, and by them fhall be laid before fuch Meetings for examination, and if approved of by the County Meetings, fhall be transmitted to the Secretary of the Society to be laid before the Convention.

Be it ordained, That it shall be highly difreputable for any member to assume or hold the knowledge of any Nostrum, or palm any Medicine or composition on the people as a fecret; and that any such member shall be deemed unworthy to belong to the Medical Society: and that the members of the Society shall hold no medical correspondence with such characters, nor consult with them in any medical case whatever; and that all Pretenders to Nostrums shall be deemed and considered proper subjects for expulsion from this Society.

Be it ordained, That if any member of the Medical Society whole character flands fair and unimpeached fhall afk for a difmiffion from faid Society, he may on application to the County Meeting wherein he refides, have a certificate from the Clerk thereof that he is difmiffed from faid Society, on condition that he pays up his proportion of taxes and expences that have arifen previous to the time of his application.

Be it ordained, That whenever any tax is laid by the Convention, it fhall be the duty of the Clerk of each County Meeting to make returns to the Treasurer, of the names of any of the members who may be deficient in the payment of fuch tax.

Be it ordained, That all Phyficians and Surgeons who pretend to any Noftrums or Secrets, and are willing to communicate their knowledge to the public: that they may do it under the folemnity of an oath before fome proper authority, therein declaring that they have revealed every fimple and composition they are posseffed of, relative thereto, and their method of administering the fame, without the least refervation whatever: and that the Nostrums or Secrets shall be advertifed in the feveral newspapers that circulate in the Counties where they respectively refide.

Refolved, That any member of the Connecticut Medical Society thall have free access to attend and hear the debates of the Convention.

Voted, That the Prefident and Fellows of the Connecticut Medical Society fhall receive fix fhillings per diem, for each memoer while attending in Medical Convention, and fix pence per mile while travelling from their places of abode to the Convention.

Voted, That a Tax of three fhillings be laid on cach member of the Connecticut Medical Society, and be collected on or before the fourth Tuefday of September next, by the Clerks of the refpective County Meetings to which they belong; and faid Clerks fhall be refponfible to the Treafurer for the fame.

*October 1793.

Be it ordained, That the feveral County Meetings have jurifdiction of the accufations that may be made by the members of the Medical Society; and if any accufed member shall think himself injured, by the decision of any of the County Meetings, he shall have liberty of appeal to the State Convention.

. Be it ordained, That the feveral County Meetings in this State be authorifed to make fuch regulations as their local circumftances may render convenient : Provided fuch regulations be not contrary to the laws of the State, or the By-Laws of this Society.

Be it ordained, That it shall be the duty of each member of the Medical Society of Connecticut, to accuse any other member of faid Society, for any mifdemeanor which he deems contrary to the true intent and meaning of the act of the General Affembly incorporating this Society, or contrary to fuch County regulations as are conformable to the By-Laws authorifing fuch regulations. And the acculer shall make a statement in writing of the mifdemeanors aforefaid, and lay the fame before a Fellow of the Medical Society : and the Fellow to whom fuch accufation is made shall issue a notification to the accused to appear before the next County Meeting, stating the time when and the place where it is to be holden, to defend if he fee fit, against the accusation. A copy of the faid accufation and notification shall be left with the accused, or at his usual place of abode, at least twelve days before the holding of faid County Meeting. And the accufer shall caufe the faid accufation and notification to be ferved and returned to faid County Meeting on the first day of their fitting.

And be it further ordained, That the By-Laws confining the jurifdiction of accusations to the State Convention be repealed.

Voted, That a Tax of one dollar be laid on each member of the Connecticut Medical Society, and that the fame be paid by the first day of May next.²

October 1795.

Réfolved, That it be confidered as an indifpenfible requifite, for every young gentleman, who fhall hereafter present himfelf for examination before the Committee of any County, that he read before faid Committee, an Inaugural Differtation on fome medical fubjed, as one of the evidences of improvement in his fludies.

Voied, That a Tax of one dollar be laid on each member of the Connecticut Medical Society, and that the fame be paid by the first day of. May 1796.

Voted, That a Tax of one dollar be laid on? each member of this Society, to be collected before next Convention.

October 1797.

Refolued, That if any Phyfician or Surgeon in the State of Connecticut, who was in Practice previous to the inflitution of this Society, fhould. be defirous of becoming a member of the fame; by procuring a certificate from three of the Fellows of faid Society, of his having fince supported the character of a good Phyfician or Surgeon, he may be enrolled as a member of the Society. If, he commenced his Practice after the inflitution of the Society, it shall be neceffary that he be examined by the Committee of Examination, before he can become a member of the Society.

Voted, That a Tax of one dollar he laid on eachmember of this Society, to be paid by the first of May next.

Voted, That the Secretary be directed to procure the infertion of advertifements for the Society, in the public newspapers, at the expense of he Society.

October 1798.

Refolved, That the Treasurer be directed to collect all the outflanding accounts of this Society, whether due to or from the Society; and report to the next Convention.

Voted, That a Tax of one dollar be laid on each member of the Connecticut Medical Society, payable by the first day of May next.

October 1799.

Voted, That the Prefident of this Society make out Diplomas for those gentlemen on whom honorary degrees have been conferred by this Society, and that a plate be engraved, at the expense of the Society, for that purpose, and that Doctor Eneas Munson be a Committee to procure faid plate.

Voted, That the Secretary have liberty to grant copies to the Clerks of the feveral Counties, of any Differtations or Orations that have been read before this Society, and approved, (being thereto requested) they paying the expence that may arife therefor.

Voted, That a Tax of one dollar be laid on each member of the Medical Society, payable the first of May next.

May 1800.

Voted, To accept the report of the Committee appointed last October, to point out a regular fystem of education to be purfued by Candidates for the practice of Physic and Surgery, which is as follows, viz. That no Candidate for the practice of Physic or Surgery in this State, shall be admitted to examination, until he shall have attained the age of twenty one years, is of good reputation, and shall have had a Collegiate Education, and shall have studied at least two years with fome respectable Physician or Surgeon; or if he has not had such preparatory education, shall have studied at least three years with such Practitioner; and shall not be licensed to practice; unless found qualified as follows, viz.

A general knowledge of natural Philofophy, Chymiftry and Botany, and a thorough knowledge of Materia Medica, Pharmacy, Anatomy, and Phyfiology, Theory and Practice of Phyfic and Surgery.

October 1800:

Voted, That the Clerks of the feveral Counties make annual returns to the Medical Convention, of the names of the members of the Medical Society refiding in their respective Counties.

Voted, That it be the duty of the various Examining Committees, to examine all Candidates who are qualified according to the By-Laws of the Society that make application, whether their refidence be in the fame County or elfewhere.

Voted, That the Secretary transmit to the Clerks of the feveral Counties annually, a copy of the Journals of the Conventions, and publish the fame in the newspapers.

Voted, That a Tax of one dollar be laid on each member of the Connecticut Medical Society, to be paid by the first day of May next.

3d. What are the caufes, fymptoms, varieties of Phthifis Pulmonalis, and the belt method of preventing and curing the fame?

Voted, It having been reprefented to the Society, that one of their members had gleaned up from the miserable remains of animal magnetism, a practice of ftroking with pointed metallic Inftruments, the pained parts of human bodies, giving out that fuch ftrokings will radically cure the most obstinate pain to which our frame is incidenty caufing falle reports to be propagated of the effects of fuch ftrokings, efpecially where they have been performed on some public occasions, and on men of diffinction; also that an excursion has been made abroad, and a patent obtained from under the authority of the United States, to aid fuch delufive quackery; that under fuch aufpices as membership of this Society, and the patent above mentioned, the delufion is progreffing to the fouthward, which may occasion difgrace to the Society and mischiel abroad; wherefore this Society announce to the public, that they confider all fuch practices as barefaced imposition, disgraceful to the faculty, and delufive to the ignorant : and they further direct their Secretary to cite any member of this Society, practifing as above, before them, at their next meeting, to answer for his conduct, and render reasons why he should not be expelled from the Society, for fuch difgraceful practices.

Therefore,

Voted, That the faid Elifha Perkins be expelled from the Medical Society of the State of Connecticut. Voted, That the thanks of the Society be returned to Doctor Lemuel Hopkins, for his hiftory, of a cafe of billious concretion.

Voted, That the thanks of this Society be returned to Doctor Jared Potter, for his Effay delivered at this time.

October 1798.

Veted, That the thanks of this Society be given to the voluntary affociated Medical Society of, New-Haven County, for their prefents this day of a number of valuable books.

Voted, That the Degree of Doctor of Medicine. be conferred on Doctors Jared Potter and Theophilus Rogers.


