INTRODUCTION.

THE MS. called in this publication Liber Elemosinarii possesses no such title in the original, nor in fact any title at all. It is a compilation made by many hands at widely different periods, and some of which additions are introduced by the phrase In tempore . . . Elemosinarii. Thus on the dorse of the first folio we find In tempore Johannis Suddebury, Elemosinarii, 7 Edward IV.

Folio 129. De tempore Fr. Rogeri de Steuyntone.

Folio 160. De tempore Fr. Rogeri de Stiuintone.

Folio 162. De tempore Roberti de Weston.

Folio 163. De tempore Johannis de Muchelneye.

None of these indicate the date of the central and oldest portion of the volume, wherein the script used is large and regular, carefully written, and consists almost wholly of copies of the various charters relating to the estates assigned to the Almoner for the upkeep of his office. This portion can hardly be later than the early part of the reign of Edward I.

The MS. is called Liber Elemosinarii simply because it is obviously a cartulary and precedent book of that Obedientiary containing all the particulars of the endowment, outgoings and receipts of his office. As such it belongs to a rare class of monastic cartularies; the only other Almoner's Book known to the editor being the MS. in two volumes in possession of the Dean and Chapter of Durham.

It is interesting to note in this place the contents of the book, somewhat in the order they occur :---

Profits of manors.

A list of fixed payments to various persons and a list of lights to be provided in the Cathedral Church at the Almoner's expense.

A note of tithes, and payments of bread and corn from various Manors. Copies of episcopal confirmation and records of a suit in the Bishops' Court arising out of a dispute between the Almoner, Henry de Antioch, and Richard de Micham, rector of Iccombe.

A list of payments disbursed by the Almoner for matters relating to his office, on the death of certain Monks, viz., W. Molenys and Thomas Carter, payments for vestments to the Master in Theology and so forth, including dues to his substitute in choir and rents to the King for the use of the Severn Bridge. Clothes for his servants, candles and beer.

A list of the corn paid in kind for the use of the Almoner.

Charters of Ankerdam, Worcester, &c.

The form of Blessing for the Alms of St. Wulstan, of Bishop Blois, and Prior Evesham and others.

Bounds in English of the manors of Shirnak and Iccombe.

Charters of Shirnack, Tolwardine, Bradecote, Worcester, Ancredam, Doddenham.

A list of the Prior's temporalities in the Archdeaconry of Gloucester.

A list of the Almoner's tenants in Doddenham.

A list of dues of the Obedientiaries under the headings Medietas decime—Quarta pars decime—and Quadrans de Marca.

Charters of Lawarne and Hindlip, Timberdene, Shirnak and Astwode. Summary of the Statute of Mortmain.

Account of property in the Hundred of Oswaldeslowe.

Debts due to the Almoner, 3 Henry V.

Brief of King Henry IV.

Brief of Edward III.

Charter of Henry II.

The volume is written upon parchment and retains its original binding of white beech boards covered with sheepskin, and its press number is A IX. in the modern Calendar. The outside measurement is 11 by $8\frac{1}{2}$ inches.

From the above short summary of the contents it will be seen that there is sufficient matter in its pages to make the publication desirable. Perhaps its most interesting feature is the folio containing the English bounds of the two manors of Shirnak and Iccombe, and this has been selected for reproduction. It would appear from the note upon folio 9, That whereas Iccombe was granted to the monastery by King Offa, in the Episcopate of Bishop Athered, 781-798, it was not assigned to the support of the Almoner until the time of Bishop Wulstan, who was perhaps responsible for the arrangement of the several Obedientiaries and instrumental in obtaining fixed endowments for their offices. A pension of one mark was due from Iccombe of ancient right, but Bishop Walter de Cantelupe made a further assignation of $\pounds I \ 13^{s}$. 4d. out of the profits of that church, which no doubt led to the suit between the Almoner and its Rector. Iccombe was apparently at one time a peculiar exempt from Ruridecanal and Archidiaconal visitation. A fact which is also carefully noted.

INTRODUCTION.

The various lists of receipts and expenditure are of interest, especially as serving to illustrate these rolls of the Almoners, already printed in the Society's transactions, and also because they are of far earlier date.

The Almoner of a monastery held an important position in the community, and was therefore usually in Holy Orders. His principal duty, as his name implies, was the distribution of the alms of the monks, including their worn-out clothes and the remnants of their food, as well as a dole of bread and sums of money. It was part of his duty to provide extra clerical help on the death of a monk in order that the long office for the deceased might be fittingly rendered. It was his duty to arrange the Maundy ceremony and choose the persons of the poor, who represented on that occasion the laving of the feet of the Apostles. It was he who disbursed the corody of St. Oswald and St. Wulstan, and paid on one occasion on the death of the Sub-prior, the sum of 7s. 3d. to the precentor, and 6s. each to thirty other monks. He also paid for the tolling of the bells. The Priory schoolmaster in the person of the Master in Theology, whose salary was 20s. per annum, was supported out of his funds, and it was his business to distribute the Maundy money and buy fryze coats for the poor.

In the Cathedral he provided the lights at the Altar of St. John the Baptist, and lamps at night on both his feasts, and also the large processional torches used in the procession and the following High Mass, as well as similar torches for the High Mass at the Altar of St. Oswald celebrated there upon the Feast of St. Thomas of Canterbury, The Invention of the Holy Cross, and the Decollation of St. John the Baptist.

The Editor has to thank the Dean and Chapter for their kindness in allowing this volume to be printed, and Canon Wilson in particular for kind help and advice. He is also greatly indebted to the General Editor for suggestions and emendations.

situated before Wyburnestre and gelded for one hide; part was assigned to the Elemosinarius by Bishop Wulstan.

The said Elemosinarius receives a pension of 1 mark of ancient right, and $2\frac{1}{2}$ by concession of W. de Cantelupe, Bishop. The church is free from all jurisdiction of the courts of the Archdeacon and Dean. There are 8 virgates of land in desmesne. In 1242 there were 13 villeins holding farms for 15 years, and the Almoner receives every year from each, at each of the four quarter-days, 20s. They have besides to find a lodging for the Almoner every year, with all necessaries for horses and hay, &c. There are in villeinage 12 virgates of land, of which quarterly rent is paid, viz. xxs.

The Elemosinarius receives the profit of land-setting, pleas and markets; also the best chattel [of a tenant deceased] and the fine of his successor. He receives for pension of the church of Seggesbarewe, at Michaelmas, 7s. 6d. At Letare Jerusalem, 7s. 6d. From the fulling mill of Overbury on the Feast of the Nativity, 10s. From a certain house at Herforton, 10s. He receives from Calewe about the Invention of the Holy Cross by the hand of the hospitallers of Dunmore, 2s. From lands at Lauwerne Abetot, 40d. quarterly.

10. From a certain house by the Almonry, $10\frac{1}{2}d$.¹ From the next house, 9d. From a furnace, $\frac{1}{2}$ mark. From a toralium², 10s. From two houses in the Angle, 17d. The Elemosinarius is bound to provide a lamp burning every day at every Mass at the Altar of St. John Baptist, and at nigh burning at both his feasts. Item torches (cereos) sufficient at the processions and Masses on both feasts.

He is bound to find a torch as above at the procession and Mass at the Altar of St. Oswald on the Feast of St. Thomas M.

He is bound to find on the Feasts of the Invention of the Holy Cross, the Translation of St. Benedict, and the Beheading of St. John the Baptist, and at each ij^a and iiij^a vi^a fr^a. In Advent and in Lent loaves (worth) 12d., "deportandos ad digitum ¹ ad elemosinam."

He has to find each day loaves for the monks, worth 3s., delivered at the hand of the Almoner.

He receives in each year a *cronnus*² of corn from Humelton, another from Lypard, and one from Cornebury to make bread; for distribution *ad digitum* on the day of the Anniversary of Prior Ralph.

12. OF THE ALMONER'S TITHES. He receives a third part of the tithe from the demesne of Thomas Ruppe of Herforton, and from one virgate which belongs to the mill there. A third part of the tithe of the lands of Hugh Salford at Cleve. A third part of tithes of Lady Emma de Belowe at Cantertun ³. The tithe of the assarts at Humelton "propriis sumptibus excultis."

The tithe of land called Horsham at Seggeberewe. The tithe of the demesne of Alexander de Abetot beyond the brook at Lauwarne, and tithe of two villeins who held of the same lord, and small tithes and tithe of land of W. Buffle, who held of the same lord. He takes tithe of the bakery without "scandum⁴" and the alms of the Prior in Lent, and bread for the poor on Maundy Thursday.

He receives tithe of the bread bought and tithe of the oblations and legacies to the chaplain.

He receives each week "vj justatas de meliore cervisia et totidem de secunda pro relevio cervisie die Sabbati post Collationem."

The Almoner is bound to find on Maundy Thursday in the cloister for every monk two poor men, and to each poor man 13d. without the poor of the prior, to each one of whom he pays 13d.

THE ALMS OF ST. WULSTAN.

Item. He receives from the several hands written below a cronnus or lxii quartern loaves, one loaf to be given to the gatekeeper and to other servants of the Almoner.

That the Prior claimed a messuage and a quarter of a virgate acquired of Richard del Stete, and held the same for 2 years without licence.

Of 12 acres in Hallowe acquired of Wlstan de Salop, the Prior has a royal charter for 6 and no more.

Of 20 acres in Hallow acquired of the daughter of Mathew de Hallow, they have a charter for 9 acquired of Joane his sister.

Of a windmill and plot of land acquired of John Ambroys, that they held it some time before the statute.

For the 4 acres of Walter Cradam in Bedwardyn and 7 acres of Richard the Goldsmith, they have held the past four years without licence. It is worth 21d. yearly.

Of an acre of John Balle, they have held it the past year. It is worth 2d.

A messuage and carucate in Schirnak acquired of William ate Mulne;

they have a charter of the King for c. shillings, and they are worth no more.

Of the Park of Timpeleye, which the Prior acquired of Edward Burnel, they have a licence for 160 acres of wood in Kyderminster, and they swear this wood is called Timpeleye Park.

The remaining 115. rent from tenements of William de Salop, 45. from Henry de Upton, 4d. from a plot of William de Salop. Two years have elapsed without licence of the King.

The curtilage near the Severne obtained of Robert Peet, they have held without licence for 4 years.

For the 11s. rent held of John the Carter in the High Street said to have been acquired after the statute; the Jurors say that it was paid by William, father of John, time out of mind, and that nothing was acquired after the statute.

51s. rent out of La Baileye in Sudbury, &c. 3 years have elapsed without a licence.

Edward III. sailed "from Orwell" in the following month (Feb. 1340), and Levington is a place on the Orwell estuary; so that it can be identified with very little question with this "Levyngton," though another instance of its being called *Bishop's* Levington is still to seek.

² "In meo essarto de Haya Herefordie." The "Hay of Hereford" was an enclosed park, originally a forest, near the city. Note that Kalewe (or Calewe) is described

as situate "in trenchato Herefordie," whatever that may mean. There is a Callow some four miles S. of Hereford; but Habington, in his survey of Worcestershire, describes the parish of Mathon as bounded on the South by "Callow" in Herefordshire, thus identifying Callow with Colwall. Wherever it is to be found, a manor of Callow was bestowed by Richard I. on the Hospital of St. John of Jerusalem, a gift which seems to have involved the displacement of a colony of monks from Worcester. · ·
