# HOUSE JOURNAL

## **SECOND SESSION 1976**

#### ONE HUNDRED EIGHTEENTH DAY

House of Representatives Monday, May 3, 1976

In accordance with the adjournment motion of June 26, 1975, the House is called to order by the Speaker at 12:00 noon on Monday, May 3, 1976.

Prayer is offered by Dr. Albert G. Edwards, House Chaplain.

A leave of absence is granted Representative Hunt for May 3-5.

The Speaker announces that Representative John J. Hunt of the 40th House District resigned on April 14, 1976. Mrs. Edith Lutz was appointed on May 3, 1976, by the Governor to fill his unexpired term. The following oath of office is administered to Mrs. Lutz by The Honorable Thad Eure, Secretary of State.

"I, Edith Lutz, do solemnly swear that I will support and maintain the Constitution and the laws of the United States.

"I, Edith Lutz, do solemnly and sincerely swear that I will be faithful and bear true allegiance to the State of North Carolina, and to the constitutional powers and authorities which are or may be established for the government thereof, and that I will endeavor to support, maintain and defend the Constitution and laws of said State, not inconsistent with the Constitution of the United States, to the best of my knowledge and ability.

"I, Edith Lutz, do solemnly swear that I will faithfully discharge my duties as a member of the House of Representatives of the 1975 General Assembly of the State of North Carolina to the best of my skill and ability, according to law, so help me, God."

The courtesies of the floor are extended to the family of Mrs. Lutz.

It is announced by the Speaker that Representatives David M. Blackwell and James E. Long, of the 22nd House District, resigned as members of the House of Representatives on July 31, 1975. Appointed by the Governor on August 18, 1975, to fill these vacancies were Conrad Riley Duncan and Bertha Merrill Holt, respectively. Oath of office was administered to Mr. Duncan on August 28, 1975, and to Mrs. Holt on August 29, 1975. The Speaker orders that these oaths be entered into today's Journal.

The Speaker appoints Representative Lutz to the following committees: Commissions and Institutions for Blind and Deaf, Manufacturers and Labor, Public Libraries, Base Budget, Highway Safety, Military and Veterans' Affairs, Wildlife.

A quorum having been established, the House proceeds with its business.

Representative Stevens, for the Committee on Rules and Operation of the House reports the Journal of Thursday, June 26, 1975, has been examined and found correct. Upon his motion, the Journal is approved as written.

Representative Stevens explains that the House adjourned in 1975 pursuant to H. J. R. 1283 which governs the procedure to be followed this legislative session: "Sec. 2 That when the Senate and House reconvene pursuant to Section 1 of this resolution, they shall consider only bills and resolutions directly affecting the budget for the fiscal year 1976-1977; provided, that after ratification of a joint resolution passed by a two-thirds majority in each body, the Senate and House may also consider any matters authorized by that resolution."

According to House Rule 32(a), bills and resolutions are filed in the Principal Clerk's Office on the legislative day prior to first reading and reference to committee.

During this legislative session bills pertaining to subjects other than budget must be preceded by enabling legislation. Enabling resolutions will follow the filing procedure; however, the principal bills may be filed with the Principal Clerk but will remain there until their enabling resolutions are ratified.

#### REMARKS BY SPEAKER JAMES C. GREEN

"At this time on the Chair's own motion, I should like to express my gratitude to all of you for your having allowed me to serve as your Speaker in what has been not only a most pleasing assignment, but a great challenge. I commend each of you, individually, and I commend you collectively, for the very keen, and very rare, dedication of your labors on behalf of all of the people of our great State of North Carolina. At the outset of the 1975-76 Session, I stood here and I insisted that all of the Committee Chairmen deal with every matter that came before their respective committees firmly, fairly and expeditiously. I stand here again today to commend all of you for having competently discharged those responsibilities most admirably.

"The very gracious and generous manner in which you have dealt with me as your Speaker certainly has been heartwarming and gratifying, to say the least.

"Today, again I thank you on behalf of my entire family for your generosity which you expressed so beautifully on Wednesday night of this week at our Love Feast. We shall always treasure and enjoy the handsome and very elegant silver service which you presented to us. I personally will enjoy wearing the very smart, colorful and patriotic coats and ties which were given me by you as soon as Craig Lawing gets the right size.

"I want you to know, too, that I shall always treasure each and every kind word and words of encouragement that have been spoken to me by you, as well as the many nice letters and notes I have received from you members during this Session. I know, you must know, that they mean very much to me.

"In chatting with the Honorable Secretary of State, Thad Eure, he has estimated that since I first came to the General Assembly in 1961, I have served with some 450 or more separate individuals from across this great State. This has been a most rewarding experience for me. Having heard some comments from other members today, along these lines, I guess the full realization is just beginning to strike me, that today, barring any unforeseen difficulties which might require a Special Session of this General Assembly, this, May the Fourteenth, 1976, will be the final day of my service as a member of this General Assembly, since after 16 years I did indeed finally state publicly that I would not be a candidate for re-election to the House of Representatives from the 19th House District in North Carolina. I do hope and expect, however, to continue the fast friendships which I have had the privilege and honor of enjoying here.

"I say thank you — and I thank you for all of your support — all of your help — all of your love — and, yes, for all of your constructive criticism which has served to spur me to try to be what you would expect and want your Speaker to be.

"I shall contniue to walk humbly with my God, with the hope that we may all continue to be blessed, beyond our ability to ask. Thank you."


