FROMKIN was then residing at the Embajador Hotel.

According to PCI., FROMKIN has been a resident of the Dominican Republic for the past nine years. He has been an owner and Sperator of the Coney Island Amusement Center, Santo Domingo.

Photographs of JOSEPH STASSI and ANGELO BRUNO were displayed to PCI., however, he advised that these individuals were unknown to him and did not know of any connection between them and NORMAN FROMKIN.

PCI advised that NORMAN FROMKIN is acquainted with PAT SLOTT, casino manager, Embajador Hotel, Santo Domingo.

PCI could furnish no information concerning any associates of NORMAN FROMKIN at San Juan, Puerto Rico. He was specifically questionned concerning the identity of ARTURO LOPEZ and could furnish no information concerning this individual:

Insufficient contacts have been made with PCI to ascertain his reliability.

Characterization of PCI is as follows: A casino manager of one of the larger hotels in the San Juan area.

The indicies of the SJO were reviewed concerning ARTURO LOPEZ and the following is set forth as possibly identical with ARTURO LOPEZ:

San Juan file 97-42 entitled ARTURO LOPEZ ROSSY, Registration Act reflects investigation was conducted during 1957 based upon an allegation that ARTURO LOPEZ ROSSY was acting in the capacity of an agent for the Trujillo government at the Dominican Republic.
