# Ministry of Finance Ordinance No. 1

January 6, 1948

The Ministerial Ordinance concerning the receipt of the non war damaged house tax paid in the form of the 2nd restricted account and others shall be set forth as follows:

The Ministerial Ordinance concerning the Receipt of the Non War Damaged House Tax paid in the Form of the 2nd Restricted Accounts

- Art. 1. The provisions of this Ministerial Ordinance shall apply in respect to the receipt of the non war damaged house tax paid in the form of the 2nd restricted accounts and others as referred to under the Non War Sufferers Special Tax Law (be hereinafter called the 2nd restricted accounts and others).
- Art. 2. The superintendent of the taxation office shall, in case he has received the non war damaged house tax paid in the form of the 2nd restricted accounts and others, deliver Form No. 1 receipt certificate to the taxpayer.
- Art. 3. The superintendent of the taxation office shall make every month Form No. 2 report of payment on and after December 1, 1947.

of the non war damaged house tax in the form of the 2nd restricted accounts and other concerning the amount of the non war damaged house tax paid in the form of the 2nd restricted accounts and others and shall send it attaching thereto relevant documents to the Director of the Regional Financial Bureau by the fifteenth day of the next month.

- Art. 4. The Director of the Regional Financial Bureau shall make every month a general report of payment of the non war damaged house tax in the form of the 2nd restricted accounts and others on the basis of the report prescribed under the preceding Article and shall send it attaching thereto relevant documents to the Minister of Finance within the next month.
- Art. 5. The superintendent of the taxation office shall provide Form No. 3 payment book of the non war damaged house tax in the form of the 2nd restricted accounts and others prescribed hereunder as Form No. 3 and enter therein the amount of the non war damaged house tax paid in the form ot the 2nd restricted account and others and other necessary matters.

#### GOVERNMENT MATTERS Partial Amendment to Regulations governing Departmental Organization of Ministry of Commerce and Industry

A part of the Official Departmental Regulations governing the Ministry of Commerce and Industry was amended as follows and the amendement came into force on December 1st:

Article 55. In the Research and Statistics Bureau shall be set up the Research Section, Basic Statistics Section, Machinery Statistics Section, Chemical Statistics Section, Textile Statistics Section and Living Necessaries Statistics Section.

In Article 56, "Item 6" shall read "Item 7", and next to "Item 5" the following item shall be inserted:

6. Summarization of weekly, monthly and other dynamic statistical research on matters under its jurisdiction.

In Article 57, "First Statistics Section" shall read "Basic Statistics Section".

Article 58. The Machinery Statistics Section, Research and Statistics Bureau shall take charge of matters pertaining to business concerning weekly, monthly and other dynamic statistical research on machineries and tools (inclusive of tele-communication machines, tools and its appliances).

Article 58-3. The Textile Statistics Section, Research and Statistics Bureau shall take charge of business concerning weekly, monthly and other dynamic statistics on textile industrial products (paper and paper goods excluded).

Article 58-4. The Daily Necessaries Statistics Section,
Research and Statistics Bureau shall take charge
of business concerning weekly, monthly and other
dynamic statistics on industrial goods primarily
needed for people's daily living, paper and paper
products.


