



#### PROCLAMATION.



#### THURSDAY, 28TH OCTOBER, 1903.

3:00 O'CLOCK P.M.

This being the First Day of the Second Session of the Fifth Legislative Assembly of the North-West Territories, for the Despatch of Business, pursuant to a proclamation of His Honour Amedée Emmanuel Forget, Lieutenant Governor of the said Territories, dated the 8th day of October, 1903, and the House having met, His Honour entered the House and having taken His seat upon the Throne was pleased to open the Session with the following Speech:

#### MR. SPEAKER AND GENTLEMEN OF THE LEGISLATIVE ASSEMBLY:

I have much pleasure in welcoming you on the occasion of the opening of the Second Session of the Fifth Legislative Assembly of the Territories.

Although, owing to adverse climatic conditions at the critical time of harvest, the expectations formed at the beginning of the season have not all been realised, I can still congratulate you on the continuing growth and prosperity of the country.

It being the opinion of my Government that the public business will be greatly facilitated by a change in the time of the meeting of the Legislative Assembly, I have called you together again at this early date in order to enable your ordinary Sessions to be held hereafter in the autumn instead of, as hitherto, in the early part of the year.

By legislation passed at the late Session of the Dominion Parliament your legislative jurisdiction has been extended so as to enable you to deal with the qualification of Members of the Legislative Assembly, and a Bill dealing with that subject will be presented for your consideration. Your power to legislate with regard to certain matters affecting the administration of justice has also been increased, in consequence of which you will be required to make some provision for the establishment of Judicial Districts and the appointment of Police Magistrates. Bills

concerning these subjects will be presented to you.

The rapid increase in the population of the *Territories*, and the wide area over which that population is scattered, have led my Government to the conclusion that a gradual decentralisation of the work at present performed by the central Government has become necessary. This important matter has been the subject of careful consideration by my Government during the recess, and your co-operation and assistance will be asked with a view to the establishment of a simple, efficient and economical system of rural organisation.

Measures for the creation of a University; dealing with the powers and liabilities of Trustees; and the levying of Succession Duties will be submitted to you; as will a consolidation of the law relating to game;

and Bills amending the Municipal, School and Fence Ordinances.

Estimates for the coming year have been prepared, having regard for the conditions of the *Territories*.

#### GENTLEMEN OF THE LEGISLATIVE ASSEMBLY:

I leave you all these and such other matters as may be brought before you, in full confidence that your earnest endeavours and consideration will be given to them, and in the belief that your labours will be Divinely guided to a successful and satisfactory issue.

His Honour was then pleased to retire.

Mr. Speaker informed the House that, in order to prevent mistakes, he had secured a copy of the Speech of His Honour the Lieutenant Governor, which was laid on the Table.

Ordered, That Mr. Haultain have leave to introduce a Bill to amend Chapter 77 of The Consolidated Ordinances 1898, intituled "An Ordinance respecting Fences."

He accordingly presented the said Bill and the same was received

and read the first time.

Mr. Speaker notified the House that the Clerk of the Assembly had received the following notification from the Clerk of the Executive Council.

Regina, Saturday, September 12, 1903.

This is to give notice, in pursuance of Section 119 of The Territories Elections Ordinance, that, in virtue of a Writ of Election, dated the Nineteenth day of May, 1903, addressed to John A. Tierney, of St. Albert, Esquire, appointed Returning Officer for the Electoral District of St. Albert for the election of a Member to represent the said Electoral District of St. Albert in the Legislative Assembly of the Territories in the room of Daniel Maloney, Esquire, whose election has been declared void, Louis Joseph Alphonse Lambert, Esquire, has been returned as duly elected accordingly; as appears from the Certificate of the Deputy Sheriff of the judicial district in which the said Electoral District of St.

Albert is situated, that all proceedings in any way affecting the election are concluded, provided for by Section 118 of the aforesaid Ordinance and dated the Eighth day of September, 1903, which is now lodged in my office.

On motion of Mr. Haultain, seconded by Mr. Bulyea, Ordered, That a Special Committee consisting of Messieurs Bennett, Patrick, Brown, DeVeber, McIntyre, and the mover and seconder, be appointed to prepare and report with all convenient speed a list of Members to compose the Select Standing Committees ordered by this House.

And then the House adjourned at 3:30 o'clock p.m.

By Mr. Bulyea—Of D. Browne and seventeen others praying that the townsite of Qu'Appelle be not incorporated as a Town Municipality.

By Mr. Annable—Of the Town of Moose Jaw praying for certain additional powers.

Mr. Lake, from the Standing Committee on Standing Orders and Private Bills presented the following Report—

The Standing Committee on Standing Orders and Private Bills beg

to report as follows—

In the case of the petition of the Town of Edmonton for a Private Bill the Rules of the House have been complied with, with the exception of Rule 64, the committee recommend that Rules 60 and 64 be suspended in respect thereto, and permission be granted to introduce the Bill.

In the case of the petition of the Town of Raymond for a Private Bill that Rule 64 has not been complied with and Rule 59 has only partially been complied with, the Committee recommend that Rules 59, 60 and 64 be suspended in respect thereto and permission be granted to introduce the Bill.

Ordered, That the Report be now received and concurred in.

Mr. Lake, from the Standing Committee on Standing Orders and Private Bills, presented the following Report—

The Standing Committee on Standing Orders and Private Bills beg

to report as follows-

The attention of the House is respectfully called to the increasing disregard of the rules regarding applications for Private Bills, especially in respect to advertising and the deposit of a copy of the Bill applied for with the clerk eight days previous to the meeting of the House. The Committee, in accordance with a practice that has become common for some years past, has recommended the suspension of the rules where they have been satisfied that no injury to private interests has been caused thereby, but they recommend that in future, except in very urgent cases, the rules be strictly enforced. They also recommend that after the present Session the practice that has prevailed of returning fees to municipalities asking for Private Bills be discontinued.

Ordered, That the Report be now received and concurred in.

The Select Committee to whom was referred a Bill to enroll John Gaddis Tipton as an advocate of the North West Territories beg to

report as follows—

That in the opinion of the Committee legislation of this kind is not desirable, but that the Law Society should be empowered to deal with all cases of applications to be enrolled as advocates; the Committee therefore recommend that the said Bill be not proceeded with, but that any amendment necessary to empower the Law Society of the *Territories* to consider and deal with applications of this nature should be introduced; and that the fee be returned.

Ordered, That the Report be now received and concurred in and

that the Committee be discharged.

Ordered, That Mr. Haultain have leave to introduce a Bill to Establish and Incorporate a University for the North-West Territories.

He accordingly presented the said Bill and the same was received

and read the first time, and

Ordered, To be read a second time on Friday next.

1. Is there any necessity for more effective organisation than Local Improvement Districts, Large or Small?

This question was unanimously answered in the affirmative.

2. Shall the area of the proposed districts be—

(a) One Township with a small Board, or

- (b) A small group of Townships, 4 to 6, with a small Board or Council, or
- (c) A large group of Townships, 16 to 36, with a Large Board or Council?
- 3. Is there necessity for an arbitrary division of the *Territories* according to the plan which may be adopted—necessary slight readjustments to be made when required?

It was resolved that four Townships be the basis for organisation; and the division be arbitrary, subject to the physical features of the country.

4. Minimum population?

The basis of population shall be one resident ratepayer to every three square miles.

- 5. Is it desirable to make the Township the unit for representation?

  It was resolved that the Township be the basis of representation.
- 6. Shall such organisation be optional or compulsory?

  It was decided that the organisation be optional.
- 7. What powers shall be granted the Councils?

The following powers shall be granted to the proposed new organisations:

1. Appointing constables;

2. Appointing such officials under such names as the Council may deem necessary for the carrying out of the work of the organisation, defining their duties and providing for their remuneration;

3. Expropriation of land (subject to control of Public Works

Department) for highways, roads, bridges, etc.;

- 4. Making and regulating the use of public wells and reservoirs;5. Regulating the rate or pace of riding or driving on bridges;
- 6. Restraining and regulating the running at large of dogs, and imposing a tax on the owners, possessors or harbourers of dogs, and killing dogs running at large;

7. Compelling the destruction of noxious weeds;

8. Providing for the burial of paupers;

9. The laying out, constructing and repairing, maintaining and protecting highways, roads, streets and bridges;

10. Power to licence shows, hawkers and pedlers:

11 Power to provide cemeteries:

12. Granting aid to regularly constituted hospitals.

The following duties should be imposed on proposed organisations:

1. The administration of The Prairie Fires Ordinance, and fire-

quards.

- 2. Enforcing the provisions of The Health Ordinance, The Pound District Ordinance and The Herd Ordinance.
- 8. Shall the mode of assessment be

(a) Straight acreage tax, or

(b) Tax on unimproved value of land, or

(c) General property tax?

This question was answered by the adoption of tax on unimproved value of land by a large majority.

9. What limit to taxing power?

A maximum rate of ten mills.

10. What power to create debt, and under what restrictions as to nature of undertakings and central control.

No power to create debt should be granted.

- 11. Shall the collection and enforcement of taxes be
  - (a) Central, or (b) Local?

A large majority favoured the adoption of central control for the collection and enforcement of taxes.

12. What shall be the method of administration of unorganised Districts?

This question was left unanswered.

you have adopted providing for the establishment of a simple—and for that reason, probably, a not altogether complete—organisation for local government purposes in rural districts, and in the noticeable advance in the number of, and powers given to, the more complex and concentrated communities.

I am especially pleased to be able to refer to your legislation for the foundation of a University in these *Territories*, and I earnestly trust that your efforts will tend to the most satisfactory results in future

years.

I thank you for the supplies you have voted for the public service of the *Territories*, which will be carefully expended by my Government in the manner best calculated to promote the general welfare of our people.

GENTLEMEN OF THE LEGISLATIVE ASSEMBLY-

I bid you farewell on this occasion trusting that you may, one and all, enjoy a full share of the blessings and welfare which form a noticeable part of the general life of the people of these Territories.

Mr. Bulyea then said—

MR. SPEAKER AND GENTLEMEN OF THE LEGISLATIVE ASSEMBLY—

It is His Honour the Lieutenant Governor's will and pleasure that this Legislative Assembly be prorogued until it shall please His Honour to summon the same for the despatch of business, and the Legislative Assembly is accordingly prorogued.
