"Excerpt from Regulations Regarding Military Training"

Article 60. In parallel with the practical training, it is required that relevant matters contained in the Manual for training be explained and their purposes clarified so that they may contribute to the progress of the practical training. Moreover, in accordance with the nature of the class to be trained and their standard of knowledge, adequate training shall be given concerning the necessary matters such as internal administration, ranks and uniforms of military personnel, organization and equipment, garrison service, ordnance, matters pertaining to horses, clothing, characteristics of other branches, espionage, characteristics of hypothetical enemy forces, decorations, badges, medals of honour, punishment, hygiene and first aid, rules of conduct of ex-soldiers, the Red Cross Convention and other necessary matters. All these are termed theoretical trainings.

Article 250. Commanders of respective units are required, taking into due consideration the characteristics of the unit especially its organization and quality, to pay constant attention to the tensity or slackness of military discipline from the beginning of its departure for the front and to take appropriate measures for its enhancement. And it is an indispensable requisite for the enhancement of military discipline to have officers and men drilled so frequently that they will remember by heart the dignity of the military command and that the staff themselves try hard to take the lead in setting up good examples. Furthermore, the guarantee of a severe enforcement of service, an accurate and solemn maintenance of attitude and action especially a strict enforcement of a salute are effective means by which to maintain rigorous military discipline.

Because of the fear that the military unity is apt to be slackened, during the battle, due to frequent replacements of officers and men, the Commanders of respective units are requested to lead his subordinates in such a way that they will strengthen their unity the more as battles are fought one after another.

Article 252. It is most necessary to find out opportunities for such an instruction as the exaltation of virtue towards inhabitants within the zone of operations, measures against enemy propaganda and plots as well as its espionage activities.
