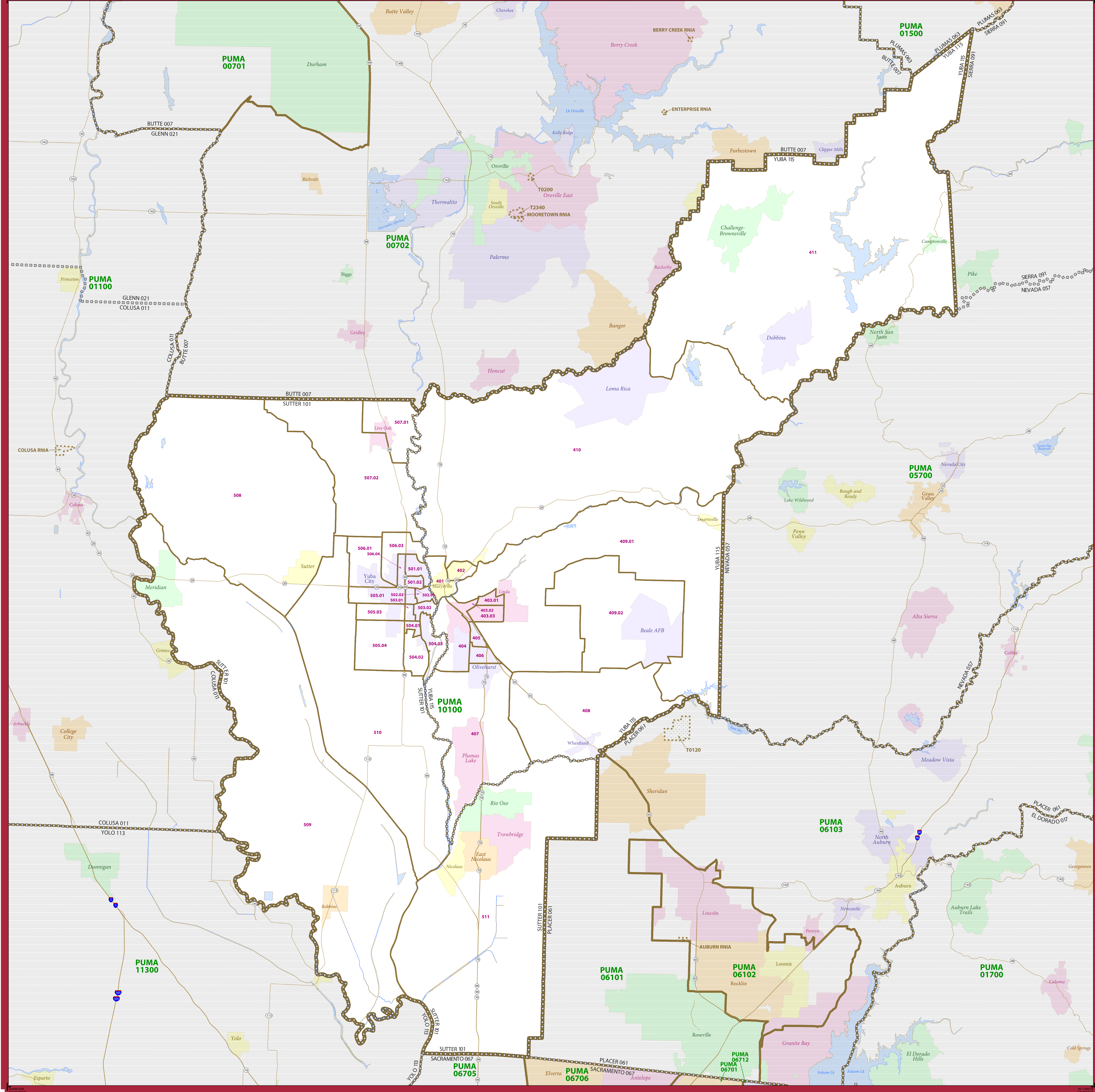


2010 CENSUS - PUMA REFERENCE MAP: Sutter & Yuba Counties--Yuba City
