Lieut. M. R. COOPER in a PB4Y-1P aircraft of Fleet Air Photographic Squadron Five took off from Agana Airfield, Guam, M. I. on 6 May 1945 at 0940 King to photograph enemy installations on Truk Islands. He arrived over his target at 1300 King and found five-tenths cumulus cloud cover in the area. He took vertical photographs of Moen airfields and oblique photographs of Moen, Param and Eten airfields all from an altitude of 19,000 ft. No enemy interception of anti-aircraft fire was encountered. He landed at Agana at 1710 King.
