## Secretary Brannan Speaks.

Speaking before members of the USDA Club in the auditorium of First Methodist Church, the Honorable Charles F. Brannan, Secretary of Agriculture, emphasized his belief in the integrity and high moral standards of Department of Agriculture employees by stating that in his opinion the standards were as high as they have ever been in history. "Over the last four years," Mr. Brannan stated, "we've had about 150 investigations of one kind or another, from outside sources such as the congress, GAO, and others. Out of these there was not one recommendation that either civil or criminal action of any kind be instituted against one employee." Earnestly he added, "I hope that brings you the same kind of pride it does mel"

"We ought to remind ourselves," he continued, that we are not perfect; but we have been our own most severe critic. We have been our own investigator."

Mr. Brannan pointed out that the processes of democracy are undergoing the most severe stress in the history of the United States. He warned against mistaking rumor for fact... Against taking our news from the headlines alone. "Be informed," he said, referring to matters pertaining to, and affecting our work.

used 65 winches (watch that "i" Mr. printer!) to load it. There were the usual medium-sized warts on it which necessitated moving all the telephone posts back 29 feet on each side of the right-ofway, as well as structural changes in the bridges along the route. mission, and the Citizens Committee for the Hoover Report, the last of which has been somewhat critical of Agriculture's cooperation in carrying out the Hoover recommendations regarding USDA. He said that in almost every case where regulations permit the Hoover recommendations have been complied with. On the subject of economy he said that of course he was for it as much as any other taxpayer, but rightly and intelligently applied "We are doing more work-more different things-than we did ten years ago with a much smaller number of employees and at a lower budget cost." Of the present investigations he asserted flatly "We will come out of them with increased prestige!"

Mr. Brannan keynoted his address with these words: "We have the right to stick our chins out and say 'I'm proud to be in public service ... and to be in the Department of Agriculture! " He concluded by saying that the problems confronting the Department will be met forthrightly and intelligently. He expressed his thanks to USDA employees in this area for their cooperation in carrying out the USDA program for the farmer. He was introduced by ir. John Bolish, USDA Club president.

Mr. Secretary is one of the few career employees to attain such eminence in government service, and one of the most able administrators to hold the reins of Agriculture. Born in Denver August 23, 1903, he attended Denver public schools, graduated from the University of Denver Law School in 1929. He entered government service in 1935 with the Resettlement Administration, appointed Director of Region Ten of the succeeding Farm Security Administration in 1941 he held that position until April, 1944 after which he went to Washington as Assistant FSA Administer. Following this he was appointed to Assistant Secretary and then Secretary of Agriculture June 2, 1948. He is the originator of the Brannan Plan, with which we are all familiar. \* \* \* \* \* \* \* \* \* \* \* \* \* \* \* \* \*

### POLIONYELITIS INSURANCE

Many USDA employees are carrying polio insurance with the Pacific Mutual Life Insurance Co. We are advised by that company that the renewal date on those policies is April 28, 1952, and that new applications received will be made effective on that date. Below are some of the facts concerning their policy:-

For single persons the premium payment is \$2.00 annually. If married the policy will cover your family as well as yourself (husband, wife, and all unmarried children under 21) at a cost of \$4.60 annually. The insurance pays for sickness correctly diagnosed as polionyelitis, up to an aggregate of \$5,000 for each member or individual, for treatment, care, and expenses, as follows:-

HOSFITAL EXPENSES: Room, board, service of regular attendants, drugs, medicines, physiotherapy, rental of braces, apparatus, equipment, and miscellaneous needed supplies.

NEDICAL SERVICE: Of legally qualified physician, osteopaths, physiotherapists IRON LUNG: Rental of iron lung or other similar mechanical equipment.

NURSING CARE: Care and attendance by graduate nurses, not members of family. TRANSPORTATION: Ambulance service to and from hospital; air or rail-

way transportation to prescribed hospital or sanitarium.

USDA members desiring this protection, either on a renewal basis or as a new applicant, should execute the application below and forward it, together with a check or money order to FAE RAY, Chairman, Employee Welfare Committee, 318 Interurban Bldg., by April 10. Policies become effective April 28, 1952 on new applicants, with a waiting period of 14 days from that date. Individual policies will be delivered to applicants by a representative of Pacific Mutual Life Insurance Co.
