Kurt and Artur AXMANN

- This organization has an operational interest in the firm Kurt ANHANN.
 This interest dates back to 1955, and we were at one time in contact with Artur ANHANN. This paper summarizes such information as we hold concerning the two men and the firm run by Kurt ANHANN.
- 2. Kurt Alois AMMANN (born 27 June 1907 in Berlin) is the elder brother, and despite the fact that his younger brother outranked him during his NSDAP career, he is definitely the leader of the current business Artur ADMANN can make no expenditures without Kurt's permission. Kurt was an H.J. Ober-zannfuehrer in Land Brandenburg, and was interned in England until 1947. He was then in business in Luebeck until 1951, and was thereafter in Berlin. In 1952 he started a business which at first dealt in tinned fish products, but which now deals in all types of machinery. From at least 1954 until the present Kurt ADMANN has made numerous trips to Warsaw and Prague.
- 3. Artur AXMANN (born 18 February 1913 in Hagen), has had a much more active political career than his prother, and is still more active politically, judging from the rumerous contacts he had and has with right-wing figures. Before 1945 he rose to Reichsjugendfuehrer, and he also saw active service on both Eastern and Western fronts. He was interned until 1949, and subsequently lived in Luebeck and Meustadt/Holstein. We are not entirely certain of his movements and activities between 1949 and the time he joined his brother's firm in Berlin in 1956. In 1951, however, he was reported as attending meetings concerning coordination of right-wing political groups held by Gert SPINDLER (born 9 May 1914), formerly publisher of "Der Foutschritt," and in March 1952 he attended meetings in Hannover led by Herr NAUNANN, formerly Staatssekretser in the Propaganda Ministerium. Some time prior to 1953, while still living in Neustadt/Holstein, he was in touch with one Wolf SCHENKE (born 6 April 1914 in Armstadt), Gottfried GRIESSMEIER, and Col-Gen a.d. STOMPF, formerly of the Luitwaffe. These contacts concerned an organization referred to as "Der Bumi," but their exact nature is unknown to us.
- 4. Since at least 1956, Artur AXMANN has been very active in attempts to further trade relations with Red China. He has been a leading figure in the Deutsche-Chinesische Gesellschaft (DCG), and in May 1958 met and accompanied the Red Chinese Trade delegation to the Hammover Fair. Other contacts of his in the DCG have included Edward J. SCLICH, Albrecht FCCKE, Claude RICKNERS, Joschis G.A. HERTSLET, and Erwin van HAZEBROCK. In the early part of 1958 Artur made a six week trip to Red China, accompanied by SCHEMEE. Although the trip was primarily a business survey, we assume that semi-political discussions were held.
- 5. In this connection, it is interesting to note that Kurt ADMANN, who has also acted for the DCG, has recently established the firm China-Kontor Hamdelegesellschaft mbH in Berlin, to occduot business with Red China. In addition to the ADMANN brothers, a Fritz Hadmich HAMDOR of Hamburg is associated with the enterprise. We understand that a frue HAMDOR and a frue COURAD, previously ADMANN employees, are employed by this new firm, and that Artur ADMANN is planning a new trip to Red China during the course of this year.

- 7. The AXMANN representative for Poland is Gert REIMERT (born 4 December 1917 in Hamburg). REIMERT has made a number of trips to Warsaw for AXMANN, and has many good downestions there, including partonnel in Elektrin, Polimex, Motor-Import, Centralny Urzat Naftowy, and Transactor. REIMERT is at the moment on a trip to Sofie for the AXMANNs, but is expected to travel to Warsaw again. In Berlin in 1956 Kurt AXMANN was in regular touch with Jan CYGAN and Heinrich LOREK (aka LOKOWRSKI) of the Visa Section of the Polish Military Mission.
- 8. We are attaching a photostat of a newspaper interview with Kurt AXNANN printed 6 June 1956 in the (East) Berliner Zeitung, which effectively summarizes his attitude towards East-West trade.
- 9. We would like to receive any information you may hold concerning the AXMANNS. He shall of course keep you informed of any developments we in turn incover which might arrest the security of the Federal Republic.






