DEALERS IN AMPHIBIANS AND REPTILES

Prepared in the Division of Wildlife Research

The following list of dealers in amphibians and reptiles has been prepared for the information of correspondents. The inclusion of names implies no endorsement as to quality and prices of stock handled. Additional names will be included when the list is revised if request is made of the Fish and Wildlife Service.

The names of dealers are arranged alphabetically under the States in which they operate. Column headings indicate the kinds of amphibians and reptiles handled by the various dealers. A cross (X) opposite a dealer's name indicates the item handled.

It is recommended that persons desiring to obtain stock purchase it preferably from dealers operating in their own or in nearby States, in order that the animals may be better acclimated to the area; this will also reduce shipping losses.
