Excerpts from Intra-Bureau Regulations, Personnel Bureau,
Navy Ministry.

(Part IV. Appointment and Promotion).

1. Concerning the constituent members of the promotion council.
(Approved by the Minister on 5 July 1929)
Approval by the minister is hereby requested for the following
alteration in our regulations:

In organizing the Promotion Council as prescribed in Article
11 of the Imperial Ordinance concerning Naval Officers' Promotion,
the ex officio admiral members to be designated by the Navy Minister
shall as a rule be the below listed office-holders subject to the
exceptional rule that other office-holders be designated when espe-
cially needed.

Admirals of the fleet.

War councillors to His Imperial Majesty the Emperor.

Vice-minister of the Navy.

Vice-Chief of the Naval General Staff.

Chief of the Naval Technical Department.

Chief of the Department of Naval Aeronautics.

Chief of the Bureau of Military Affairs.

Chief of Personnel Bureau.

Chief of Education Bureau.

Chief of the Bureau of Stores.

Chief of the Medical Bureau (only when medical and Apothecary
branches are in question).

Chief of the Bureau of Accounts and Supplies (only when Pay-
master branch is in question).

Chief of the 1st Division, Naval Technical Department (only
when Ordnance branch is in question).

Chief of the 4th Division, Naval Technical Department (only
when Constructor branch is in question).

Chief of the 5th Division, Naval Technical Department (only
when Engine Constructor branch is in
question).
