#### MUNICIPAL ORDINANCE NO. 3 – 2022

Sponsored by: Coun. Dyna P. de Guzman and the Committee of the Whole

Ordinance Adopting "Baley Kon Nianakan" as the Official Municipal Hymn of the Municipality of Urbiztondo, Pangasinan

WHEREAS, Section 16 of RA NO. 7160 otherwise known as the Local Government Code of 1991 mandates Local Government Units to ensure and support among other purposes the enrichment and preservation of culture;

WHEREAS, it is the thrust of the Municipal Government of Urbiztondo to inculcate among its people the sense of self-esteem and pride of being residents of Urbiztondo. The crafting of the Urbiztondo Hymn and integrating thereto our history and culture will indeed ensure, preserve and strengthen our identity as Urbiztondonians. Hymns are patriotic symbols that embody our history, struggles, trials, and triumphs that give inspiration to people and sense of belongingness to one's land;

WHEREAS, anent to its being a Public Corporation under Section 22 of Local Government Code, the LGU can adapt a local hymn to become its resounding symbol of unity, pride and identity.

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Urbiztondo that:

Section 1. Title. This Ordinance shall be known as "Urbiztondo Hymn".

#### Sec. 2. Purpose.

To have official hymn that shall provide unique sense of identity for the Municipality, distinct from other Local Government Units.

- c. To provide sense of belongingness, pride, goals and dreams of its inhabitants.
- **Sec. 3. Declaration of Policy.** The Local Government of Urbiztondo recognizes the importance of preserving and promoting the history, culture and traditions of Urbiztondo and its people as vital component in its existence. Reverence and respect shall at all-times be accorded the Urbiztondo Hymn, which embodies the ideals and traditions of the Municipality of Urbiztondo which shall be inculcated in the hearts and minds of every Urbiztondonian.
- **Sec. 4. Official Lyrics.** The Urbiztondo Hymn shall be sang or played in its original language in accordance with its musical arrangement (melody, tempo and beat) as follows:

**Sec. 5. Singing of the Municipal Hymn.** The Urbiztondo Hymn (Baley Kon Niyanakan) shall be sang after the singing of Lupang Hinirang and the Provincial Hymn of Pangasinan during the Flag raising ceremony every Monday morning and other special events of occasions in all Government offices, National, Local and public, private and schools at all levels in the Municipality of Urbiztondo.

The Urbiztondo Hymn shall also be sang during the flag retreat every Friday afternoon in all government institutions, private and public schools at all levels within the Municipality of Urbiztondo.

All persons while singing the Urbiztondo Hymn shall stand in attention show respect to the Municipal Flag with the right hand, palm open at the left chest.

The Municipal Hymn shall not be played and sang for where recreation, amusement or entertainment purposes.

The Urbiztondo Municipal Hymn melody lyrics is property of Municipality of Urbiztondo. Any duplication or copying is a violation of this ordinance and should be punished accordingly.

- Sec. 6. Singing / Playing of Urbiztondo Hymn by the Private Sector, Institutions and Organization. The singing of the Urbiztondo Hymn is encouraged in the flag raising ceremonies, official functions, special occasions, activities and programs in the private sector.
- **Sec. 7. Implementing Office.** The office of the Municipal Mayor through the Municipal Administrator shall be tasked to carry out the implementation of this ordinance. Upon its effectivity thereof, the same office shall circulate copies of this ordinance in print and in audio/digital versions containing the musical arrangement and composition of the Urbiztondo Hymn to all the 21 Barangays of the Municipality, public offices and educational institutions.
- **Sec. 8. Mandatory Review**. The Sangguniang Bayan of Urbiztondo shall conduct a committee meeting for the mandatory review of this ordinance at least once in every (3) years to ensure that the objective of this ordinance remains responsive to the changing circumstances.
- **Sec. 9. Repealing Clause.** All existing ordinances, rules and regulations, as well as orders inconsistent herewith are hereby repealed or modified accordingly.
- **Sec. 10. Separability Clause.** Should any of these clauses or parts of this Ordinance be declared unconstitutional by any court of competent jurisdiction, all other remaining portions not so declared shall remain valid and effective.

**Sec. 11. Effectivity.** This ordinance shall take effect upon favorable review and approval by the Sangguniang Panlalawigan and fifteen (15) days after its publication in a newspaper of local circulation pursuant to and in conformity with pertinent provisions of the Local Government Code of 1991 (R.A. 7160).
