Two F6F-5PT aircraft of Fleet Air Photographic Squadron Five with Ensign A. E. Oldenhoff, flight leader, took off from Agana Airfield, Guam, M. I. on 8 May 1945 at 0830 King to photograph enemy installations on Pagan Island. They arrived over the target at 1120 King and took good vertical photographs of the airstrip and adjacent areas. No enemy interception or anti-aircraft fire was encountered.
