The following list is a selection from a bibliography comprising nearly 4000 titles, which I have almost ready for the press. The works relate, wholly or in part, to British municipal history, in other words, to the governmental or constitutional history of the cities and boroughs of Great Britain. I have tried to make the list a useful guide, not merely to librarians and general readers, but also to investigators of the whole or any particular phase of the subject. For a general criticism of the literature of the subject the reader may consult my essay "A plea for reform in the study of English municipal history" (Papers of the American historical association, vol. v.).

The asterisks indicate a smaller selection of books of prime importance. H signifies that a book is in the Library of Harvard College. Books not in the Harvard College Library which may be found in the Boston Public Library are indicated by a B.

PART I. — GENERAL AUTHORITIES.

Bibliographies.

The following two bibliographies are the most useful, but they are very incomplete, and do not guide the reader through the labyrinth of works on municipal history. For fuller lists of books relating to particular towns, the special county bibliographies should be consulted.

Accounts of General Municipal History.

a. - Principal Treatises.

There is no good general history of English municipalities. Brady is sophistical and antiquated. Honest Madox is still helpful, for he gives us numerous extracts from unprinted public records. The material in Merewether and Stephens is valuable, but many of their general conclusions are untenable. Thompson's little book is readable but fragmentary.

Kemble is fuller and more readable, but should be used with caution; he tends to confuse the municipal history of England with that of the Continent. Coote and Wright attempt (in my opinion, without success) to show the survival of Roman institutions in Anglo-Saxon boroughs. Stubbs and Green maintain the opposite view.

Many documents relating to gilds are printed by Smith and Gross. Walford's book is encyclopaedic and superficial. Brentano's sketch is brilliant but unreliable. Salvioni follows pretty closely in Brentano's tracks. Von Ochenkowski is helpful for the study of craft fraternities. Ashley, Cunningham, and Seligman give good short accounts of the whole subject. For a brief criticism of the principal authorities, see Gross, Gild Merchant, App. A, and Ashley.




