SUBJECT: Korean Denounces Policies of the 24th Division

TO : Assistant Chief of Staff, G-2, Eighth Army, APO 343.

1. The following, evaluated B-3, is forwarded for your information.

2. It is reported that CHO Tei Rei (張貞禮) (Korean) (PM-GP), chairman of the Iwakuni Branch of the Korean Democratic Women's League (Zai Nichi Chosen Minshu Josei Domsai) (在日朝鮮民主女性同盟) has allegedly made the following remarks concerning the policies of the 24th Division:

a. "We are definitely dissatisfied with the policies of the 24th Division. Even the Japanese are not able to achieve their goals without compromising themselves."

b. "With our livelihood becoming more acute each day, we must conduct organized mass struggles against the Japanese government. In doing so, we must not allow the Occupation authorities to interfere with our plans. However, should they attempt to interfere, we are willing to spill blood in order to seek our goal."

c. "An officer of the 24th Division was requested to write the policies of the 24th Division on paper, but he refused. Such action is very perplexing to us."
