1. REFERENCE ARRIVED AT OPPORTUNE MOMENT FOR COMMENT. (UNSNAFU 9)  
 DISMISSAX BY (UNSNAFU 19) AFTER ARGUMENT AT PERUMEN EMBASSY WP MARCH  
 WHICH CULMINATED WITH (U) 19 TAKING SHOT AT (U) 9. SEQUENCE OF EVENTS  
 AS FOLLOWS. (U) 9 TELEPHONED GLOADEN EARLY MORNING 20 MARCH AND  
 STATED HE DETERMINED GO EMBASSY TO "HAVE IT OUT" WITH (U) 19 WHO,  
 AS KNOWN TO PARI, HAS BEEN RIDING (U) 9 PARTICULARLY HARD SINCE  
 DEPARTURE AMLASH 1 IN FEB. C/O MET WITH (U) 9  
 AFTER CONFRONTATION  
 WITH (U) 19. (U) 9 STATED THAT FINAL STRAW WAS AFTERNOON 19 MARCH WHEN  
 (U) 19 ACCUSED (U) 9 OF STUPIDITY IN FRONT OTHER EMPLOYEES AFTER (U) 9  
 HAD FINISHED TYPING SEVERAL HUNDRED COCKTAIL INVITATIONS INSTEAD  
 OF WRITING BY HAND. (U) 9 STATES (U) 19 HAD SEEN HIM START TYPING INVITES  
 AND AHD SAID NOTHING UNTIL HE FINISHED, THUS (U) 19 ACTION INTENTIONAL.  
 (U) 9 DECIDED WORKING CONDITIONS UNBEARABLE AND HAD TO COME TO UNDER-  
 STANDING WITH (U) 19.

2. (U)<sup>02</sup> 9 WENT TO EMBASSY AND GOT (U)<sup>02</sup> 19 OUT OF BED. TOLD (U)<sup>02</sup> 19 THAT THEY  
MGA :9.3 59 7, 5345-, 58, 8 - 7975 7 9 WORK AND THAT THIS UNDERSTAND-  
ING PERSONAL BETWEEN THEM AND NOTHING DO WITH THE REVOLUTION.

(U)<sup>02</sup> 19 COUNTERED BY STATION (U)<sup>02</sup> 9 DID NO WORK AT EMBASSY, WAS "DIRTY  
KUBARK AGENT" AND THAT HE FIRED. (U)<sup>02</sup> 9 REPLIED THAT THIS OK BUT "LETS  
STEP OUTSIDE AND SETTLE THINGS LIKE MEN." (U)<sup>02</sup> 19 REFUSED. AT  
THIS POINT (U)<sup>02</sup> 19 WIFE, WHO HAD BEEN LISTENING OUTSIDE DOOR, RUSHED  
IN HYSTERICAL AND DRAGGED (U)<sup>02</sup> 19 INTO LIVING QUARTERS.

3. (U)<sup>02</sup> 19 RETURNED ALMOST IMMEDIATELY WITH SMALL AUTOMATIC PISTOL  
AND FIRED ONE ROUND INTO FLOOR BY (U)<sup>02</sup> 9 FEET. STAFF WHO PRESENT  
INCLUDING (U)<sup>02</sup> 26, (U)<sup>02</sup> 24 REPLACEMENT, AND OTHERS, RESTRAINED (U)<sup>02</sup> 19  
FROM SHOOTING AGAIN AND (U)<sup>02</sup> 9 BEAT HASTY RETREAT OUT BACK DOOR.

4. C/O PERSUADED (U)<sup>02</sup> 9 GIVE HIM 38 CAL REVOLVER, WHICH AMLASH I  
HAD GIVEN (U)<sup>02</sup> 9 FOR USE IN POSSIBLE FUTURE TROUBLE, FOR SAFEKEEPING  
IN OFFICE ON BASIS POLICE MIGHT BE SUMMONED BY (U)<sup>02</sup> 19 AND SEARCH  
(U)<sup>02</sup> 9 HOME.

5. (U)<sup>02</sup> 9 MET WITH (U)<sup>02</sup> 13 ON 22 MARCH. (U)<sup>02</sup> 14 STATED THAT (U)<sup>02</sup> 19  
HAD SAID NOTHING IN EMBASSY THAT MORNING BUT HAD SENT LONG CODED  
CABLE TO FOREIGN MINISTRY, UNDOUBTEDLY DEALING WITH (U)<sup>02</sup> 9 CASE.  
(U)<sup>02</sup> 13 WENT WORK (HB ITEMIZE) AS USUAL AND APPEARS SHE WILL STAY AT

LEAST THRU END MARCH. (U)<sup>02</sup>9 HOPES GET FURTHER INFO ON WHAT ACTION (U)<sup>02</sup>19  
TAKING VIA (U)<sup>02</sup>13 AND (U)<sup>02</sup>14 AND POSSIBLY AMEALD 2.

6. DIFFICULT AT THIS POINT PREDICT WHAT IF ANY ACTION (U)<sup>02</sup>19  
MIGHT TAKE AGAINST (U)<sup>02</sup>9 IN FRANCE. UNDOUBTLY DIPLOMATIC PASSPORT WILL  
BE DECLARED INVALID BUT (U)<sup>02</sup>9 HAS VALID ORDINARY PBRUMEN PP ALSO.  
(U)<sup>02</sup>9 PRIMARILY CONCERNED POSSIBLE EFFECT HIS OUSTER ON AMLASH I. ESP  
(U)<sup>02</sup>19 CHARGE THAT (U)<sup>02</sup>9 KUBARK AGENT WHICH MIGHT BLOW BACK ON AMLASH I  
AND ASKS IF KUBARK CAN ADVISE AMLASH I ABOUT ABOVE DEVELOPMENTS VIA  
TRUSTED COURRIER I.E. VISITING MUTUAL FRIEND; IN VIEW COMPLI-  
CATIONS AMLASH I CASE REQUEST HQS GUIDANCE THIS ASPECT.

7. PENDING FURTHER DEVELOPMENTS, PLAN USE (U)<sup>02</sup>9 AS POSSIBLE  
RECRUITER DIRECTED AGAINST SUCH TYPES AS (U)<sup>02</sup>14 WITH WHO HE  
FRIENDLY AND SELECTED VISITORS. JUDGING (U)<sup>02</sup>9 PERSONALITY, INTELLI-  
GENCE AND PAST PERFORMANCE, NOT SANGUINE THAT HE WILL MAKE GOOD PA  
AND AMLASH I EQUITY ALWAYS LURKING IN BACKGROUND. ON BASIS PAST  
(U)<sup>02</sup>9 AND OTHER SOURCE STATEMENTS, BELIEVE (U)<sup>02</sup>19 WAS LOOKING FOR OPPOR-  
TUNITY SACK (U)<sup>02</sup>9 AND EVENTS OF 20 MARCH PROVIDED PERFECT OPPORTUNITY  
EXCEPT THAT (U)<sup>02</sup>19 LOST HEAD IN THE PROCESS.
