FRANK EDWARD WILLIAMS.

My full name is Frank Edward Williams. My home address is Douglas Street, Port Augusta, South Australia.

I was first captured in February 1942 at Singapore.

We formed a draft there to go to Japan, and we left in June 1944 aboard the "Aramis", the voyage taking ten days. We were confined in the hold, where we were very much overcrowded. There were 1100 on the ship, and we were accommodated in four holds. There was not sufficient room for us to lay down. The food was reasonable, we received a pint of rice per meal and about the same quantity of fish shoup. The men suffered from heat rash and one Dutchman suffocated. There were a few bashings on the ship, the main reason being that men were on deck trying to get water when they should have been below.
