COMMANDING OFFICER'S COMMENTS

PART I

The battle history of the U.S.S. SAN JACINTO is unique. She has fought in more battles and steamed more miles in combat during the past year than any other CV, CVL, or CVE in the U.S. Fleet. Without interruption or respite she has fought continuously and contiguously with either the THIRD or FIFTH FLEET in every operation in the Pacific from the attacks on MARCUS and WAKE ISLANDS in May 1944 through the assault and invasion of OKINAWA, April 1945.

MARCH 22.

The U.S.S. SAN JACINTO operating tactically as a UNIT of Task Group 58.2, rendezvoused with Task Group 50.8, the Fueling and Replenishment Unit. After fueling and replenishment of ammunition the SAN JACINTO reported to Task Group 58.1 (Rear Admiral CLARK, ComCarDiv FIVE) for duty, in obedience to orders of Task Group 58.2 and ComCru-Div 16 who was in Tactical Command. Air Operations for the day consisted of launching three (3) VF to return to the HANCOCK and recovering two (2) VT and two (2) VF replacement planes. On completion of Replenishment Operations, Task Group 58.1 in company with Task Group 58.3 set a northwesterly course toward the operating area east of OKINAWA.

MARCH 23.

Task Groups 58.1 and 58.3 operated approximately one hundred thirty (130) miles southeast of OKINAWA JIMA. SAN JACINTO provided two (2) Combat Air Patrols, one (1) Sweep and two (2) Strikes. The target for the Sweep, armed with rockets, was shipping in the area near the submarine base of ONTENKO, OKINAWA JIMA. Two Sampans were sunk there and four (4) large luggers and three (3) camouflaged landing barges heavily strafed in TOGUCHI KO. The target for the two (2) Strikes armed with rockets and 100# G.P. bombs, was TOKASHIKA JIMA in KERAMA RETTO. Buildings and military installations were destroyed and seven (7) luggers as well as many whale boats, were heavily strafed.

No enemy air-borne opposition was encountered and AA fire was negligible. The weather was overcast, ceiling below 1000 feet, smooth sea.

At dusk, the Task Force retired in a southeasterly direction.

MARCH 24.

The Carriers of Task Group 58.1 launched Strikes and Sweeps in support of minesweeping and Underwater Demolition Operations at OKINAWA, in addition to participating in the sinking of an enemy Convoy and Escort approximately two hundred and forty miles northwest of the Task Force in the East China Sea. Battleships and cruisers were detached from the Task Group for Bombardment Mission. The SAN JACINTO provided two (2) Combat Air Patrols over the Task Group, two (2) Combat Air Patrols as cover for minesweeping and Underwater Demolition Operations and two (2) Strikes. The targets for the first Strike, armed with rockets and 100# G.P. bombs, were TOKASHIKA JIMA, VAKAN JIMA and KOBA JIMA, all in the KERAMA RETTO. Buildings were destroyed including a radio station at YAKAN JIMA.

Extensive saturation strafing was done at each of the above targets. No enemy airborne opposition was encountered and AA fire was negligible. The target of the second Strike armed with rockets, and torpedoes was the Japanese Convoy and Escort. All ships had been sunk when the SAN JACINTO Strike arrived on the scene, except one Destroyer and one cargo ship which were sunk by two torpedo hits and

and bombs of Air Group 45. The weather was fair, scattered clouds and smooth sea. Late in the afternoon Task Group 58.1 was joined by the Bombardment Group from our own Task Group and Task Group 58.3, which retired southward for fueling.

MARCH 25.

Task Group 58.1 continued to provide Air Cover for minesweeping and Underwater Demolition Operations at OKINAWA. The SAN JACINTO provided four (4) Target Combat Air Patrols, one (1) Special Dusk Combat Air Patrol over the Task Group, three (3) Strikes and one (1) Reconnaisance Sweep. The target for the first Strike was the reveted area near KADENA town, OKINAWA, where fires were started, the target for the second Strike was the small boat basin at NAHA town, OKINAWA. A waterfront AA position was destroyed by bombs, and six to eight luggers on the beach were destroyed and an estimated ten others were severely damaged by bombs and rockets. The targets for the third Strike were KUNISHI town and the western coast of OKINAWA. Fires were started throughout the area. The target for the Sweep was NOBARA and HIRARA airfields at MIYAKO JIMA where a radio station was severely damaged and one or two planes on the ground were strafed Apparently the Japs were taken by surprise as a truckload of soldiers was strafed on its way out to one of the AA positions. The weather was overcast, sea, a slight swell. On completion of Air Operations,

Task Group 58.1 retired southwestward, the heavy units having been detached prior to our departure.

MARCH 26.

Task Group 58.1 rendezvoused with the Fueling and Replenishment
Unit at 21° 55° N. Long. 127° 55° E. The SAN JACINTO provided one
(1) Anti-submarine Patrol over the Task Group, in addition to launching two (2) VT for tow service for AA Gunnery Exercises. SAN JACINTO refueled and rearmed in the afternoon and on completion of operations the Task Group set a northeasterly course to return to the operating area off OKINAWA.

MARCH 26-27.

During the nights of Merch 26 and March 27 while enroute northwerd, Task Group 58.1 was under continuous observation by enemy planes. Prior to dewn several enemy planes closed the formation. The Task Group Night Combat Air Patrol shot down two unidentified enemy aircraft and the MURRAY, a destroyer in the screen shot down one. One enemy plane was observed diving on the BENNINGTON, but pulled out and retired without causing any damage. The SAN JACINTO provided two (2) Combat Air Patrols and one (1) Strike, target KIKAI JIMA. Ensign B.J. PETTIGREW, A-1, File No. 326442 was hit by AA fire, made a forced landing in the water near AMAMI O SHIMA and was found to be dead when picked up by an OS2U from the PITTSBURCH. The target for

The Strike was WAN Airfield and AMAMI SHIMA. One enemy plane was destroyed and one damaged and seven or eight buildings adjacent to WAN Airfield were damaged by 500# bombs. AA was heavy, intense and accurate at KIKAI. Two SD's were set afire by rockets at AMAMI O SHIMA. Three of our planes were damaged by AA fire. After Air Operations were completed, Task Groups 58.3 and 58.4 retired southeastward to fuel and replenish.

MARCH 28.

Task Group 58.1 in position approximately fifty-five (55) miles southeast of OKINAWA launched Strikes and Support Missions against OKINAWA and Islands in the vicinity. The SAN JACINTO provided one (1) Combat Air Patrol over the Task Group, two (2) Target Combat Air Patrols and one (1) Strike over OKINAWA. The Target Combat Air Patrols burned three (3) camouflaged landing barges and sank three (3) small motor boats.

At 1109 word was received from the Task Group Commander that Units of the Jap Fleet had been sighted coming out of the Inland Sea, Japanese Empire, proceeding south along the coast of KYUSHU and that it was intended to stop them before they reached OSUMI KAIYO, to the south of KYUSHU. Course was set to the north and high speed run in was commenced. At 1426, SAN JACINTO launched a Special Strike, VF armed with rockets and VT with torpedoes. The

Jap Fleet was not found, but SAN JACINTO planes sank one (1) small freighter, probably sunk three (3) more and damaged three (3) others by strafing.

Sunset was at 1833 and the first plane from the Special Shipping Strike did not return until 1851, landings in complete darknass being accomplished by all other planes. SAN JACINTO recovered four (4) VT from the BELLEAU WOOD, there being considerable difficulty in distinguishing between the green glow lights of our ship and the blue lights of the BELLEAU WOOD. At 1946, one of SAN JACINTO VF crashed on deck, carried away all barriers, crashing into the planes spotted forward damaging four so seriously that they had to be jettisoned, seriously injured one man and inflicted minor injuries to several others. One (1) of the SAN JACINTO VF damaged by AA fire, with one wheel and large hole in one wing, landed on the HORNET. Four (4) VF were instructed to land on the BELLEAU WOOD after our deck crash. After recovery of planes had been completed, Task Group 58.1 retired southward to rendezvous with Task Force 58.

MARCH 29.

Task Group 58.1 rendezvoused with Task Force 58 at 29° 20' N.,

131° 15' E. The SAN JACINTO provided two (2) Combat Air Patrols and
one (1) Search for enemy Picket Boats. The Search results were nega-

tive and Task Group 58.1 retired southwest to refuel.

MARCH 30.

Task Group 58.1 rendezvoused with Task Group 50.8 at 24° 30° N., 133° E. to refuel, re-arm and replenish stores. The SAN JACINTO had no scheduled Air Operations except the delivery of one (1) VT flyable replacement plane to CVE WYNDHAM BAY and the landing of five (5) VT and three (3) VF replacement planes. On completion of this operation Task Group 58.1 headed northeast to return to the operating area east of OKINAWA.

MARCH 31.

At dawn, Task Group 58.1 was at approximately 26° 10' N., 129° 40' E. SAN JACINTO provided two (2) Combat Air Patrols over the Task Group and two (2) Sweeps over KIKAI JIMA. Only two (2) planes were observed at WAN Airfield, KIKAI, and they were both strafed.

Camouflaged buildings south of the airfield were rocketed and strafed and two (2) radio buildings at AMAMI were rocketed and strafed on the return trip.

April 1 Task Group 58.1 was approximately sixty (60) miles east of Central OKINAWA. The assult and invasion of OKINAWA commenced with Task Force 58 provided Air Support. The SAN JACINTO furnished two (2) Combat Air Patrols over the Task Group and Launched two (2) strikes, armed with rockets, napalm bombs and 500# A.P. bombs. The targets assigned to the Strikes were the towns of CHATAN and MACHINATO on OKINAWA. Gun emplacements, artillery, pill boxes, barracks and a block house were saturated and extensively damaged. The outstanding occurance of the day was the absence of enemy aircraft. After recovery of all aircraft Task Group 58.4 retired southward for replenishment.

April 2, Support Operations on OKINAWA continued, the SAN JACINTO providing one (1) Combat Air Patrol, three (3) Strikes and one (1) Sweep. At MINAMI DAITO, target for the Sweep, barracks were destroyed and the runway cratered. The assigned area for the Strikes, South Central OKINAWA, was bombed and rocketed, destroying artillery positions, eleven (11) trucks, warehouses and other buildings.

Ensign Carleton L. SHARP, Jr., A-1, (#378938), Pilot of a VT with a crew of two crashed in the target area and it is believed there were no survivors. At dusk Task Group 58.1 proceeded southwest to Strike SAKISHIMA GUNTO.

April 3, Task Group 58.1 in position approximately eighty (80) miles east of MIYAKO JIMA. The SAN JACINTO provided one (1) Combat Air Patrol over the Task Group and two (2) Strikes armed with 500# bombs over HIRARA Airfield area, MIYAKO JIMA and YERABU JIMA. Runways were fratered barracks and dock bombed,

five (5) fishing vessels sunk, power boats strafed in the HIRARA area, MIYAKO JIMA, and three (3) luggers were probably sunk at YERABU JIMA, in addition to burning several waterfront buildings. One (1) VF was forced to make a water bading. The Pilot was picked up in good condition by a destroyer of the screen, Lieutenant (jg) C. W. DYSERT, A-1, (#325530), was hit by AA fire at MIYAKO JIMA and made a water landing. The rescue plane sent by the VINCENNES was unable to recover pilot or aircrewmen. After completion of Air Operations, Task Group 58.1 retired southeastward.

April 4. Task Group 58.1 rendezvoused with Task Unit 50.8 for replenishment at Lat. 22 45 N., Long. 128 40 E. The SAN JACINTO provided one (1) Combat Air Patrol over the Task Groups, launched one (1) VF replacement and recovered three (3) VF and two (2) VT replacement planes. On completion of operations, course was set for returning to OKINAWA area.

April 5. Task Group 58.1 in position approximately ninety (90) miles east of OKINAWA. The SAN JACINTO provided two (2) Search Missions for possible approach of enemy surface units, two (2) Sweeps, and three (3) Strikes. The target for the Sweeps was MINAMI, and for the Strikes were MINAMI, TSUKEN JIMA, and OKINOYERABU. The Sweeps and Strikes were armed with rockets and 500# G.P. bombs. Barracks and other buildings were badly damaged, fuel storage burned, and the airfield at MINAMI was hit by bombs as well as a sun position on TSUKEN JIMA. The second Search Mission shot down one (1) enemy plane.

April 6. Task Group 58.1 operating east of OKINAWA in the same area as the previous day. Information that concentrated enemy attacks might be ex-

pected, let to the substitution of augmented Combat Air Patrols over OKINAWA and the Task Force in place of the scheduled Strikes and Sweeps. The enemy attack commenced before noon with many planes reported in the vicinity. At 1330, while under attack the SAN JACINTO was the target of a KAMIKAZE dive bomber. carrying a bomb was first seen dead ahead at about 6000 yards making a high speed approach directly toward the ship, at an altitude of about 1000 feet. Left full rudder was executed immediately. The plane was taken under fire instantly by ing 20mm guns point him out, followed immediately by all forward battery guns which were able to bear on the target. The plane was shot down and crashed approxime : 1 mately 50 feet off the starboard bow, littering the for ecastle, the flight deck to abaft the forward elevator and the island structure with plane wreckage, bomb missiles and pieces of the pilot. Six (6) men were injured, one critically, who subsequently died. Damage to the ship was slight. The attacks continued throughout the day, ship's AA fire destroying three (3) enemy planes. Aircraft of Air Group FORTY FIVE destroyed a total of twenty-two (22) enemy planes on the three (3) patrols over OKINAWA, the destroyer Picket Line and patrols over the Task Group.

7 April:

Task Group 58.1 was at approximately 27° 20' N., 129° 30' E, east of OKINAWA. COMCRUDIV TEN (10) with the BALTIMORE and the PITTSBURGH were detached together with DESDIV 106. Information was received that units of the enemy fleet were on the move south of KYUSHU and a Strike was bunched to destroy them. The U.S.S. SAN JACINTO provided two (2) Patrols and also one Sweep in addition to bunching one of the Strikes. The

Patrols shot down three (3) enemy planes. The target for the Sweep was KAKAI

JIMA where two (2) single-engined planes were destroyed on the ground by rockets.

The Special Strike of seven (7) VT, one (1) VFT and six (6) VF were armed with

torpedoes and 1000# bombs. One (1) TAKANAMI class destroyer was sunk by two (2)

torpedoes in attack by Air Group FORTY-FIVE planes (see photographs in the report).

At dusk Task Group 58.1 retired for replenishment.

April 8, at dawn, Task Group 58.1 rendezvoused with Task Group 50.8, the fueling and replenishment unit, at 24° 30' N., 132° 30' E. The SAN JACINTO provided two (2) Combat Air Patrols. On completion of fueling Task Group 58.1 set course to return to operating area east of OKINAWA.

APRIL 11.

Rendezvoused with Task Group 50.8 for Replenishment. The SAN JACINTO launched one (1) VT tow plane for gunnery exercises and recovered two (2) VT and two (2) VF replacements. After refueling rearming and replenishing GSK stores, course was set northward to return to operating area east of OKINAWA.

APRIL 12.

All Groups of Task Force 58 were present in the operating area east of OKINAWA. There were numerous enemy planes in the vicinity. Three were shot down by Night Combat Air Patrols. There were indications of enemy planes throughout the morning: one was shot down by the Combat Air Patrol of Task Group 58.3. Intercept Combat Air Patrols were flown over AMAMI and KIKAI one hundred miles to the north of the Task Force to prevent surprise attacks. These Patrols intercepted several groups of enemy planes in the afternoon before they reached OKINAWA or the Task Force. Three planes broke through these patrols and the Destroyer Picket line and were shot down by AA fire from ships in the Task Force. At dusk three more enemy planes were shot down by the Combat Air Patrol in the vicinity of the Task Group. At about 2000 enemy planes again appeared; one plane was shot down by a BENNINGTON night fighter; one undentified enemy plane was shot down by a destroyer picket of Task Group 58.3. The SAN JACINTO provided two (2) Combat Air Patrols over the Task Group, two (2) Intercept Combat Air Patrols, and one (1) Special Combat Air Patrol over KIKAI JIMA.

April 13 Task Force 58 in position approximately ninety (90) miles off OKINAWA. There was no enemy air activity in the vicinity during the day. Five replacement VF pilots were received on board. The SAN JACINTO provided two (2) Combat Air Patrols and two (2) Intercept Combat Air Patrols over AMAMI O SHIMA. Task Group 58.3 retired after operations were completed to rendezvous with the fueling group.

April 14 Task Groups 58.1, 58.3 and 58.4 in operating area east of OKINAWA. During the morning no enemy planes were in the vicinity of the Task Groups. At 1325 ten raids appeared on our radar screen to the north and northeast. The main attack was against the destroyer Picket Line, the SIGSBAE and the HUNT being hit by enemy planes. Sixteen (16) enemy planes were shot down by Combat Air Patrols and two by ship's AA fire. The SAN JACINTO launched two (2) Target Combat air Patrols, two (2) Destroyer Picket Line Combat Air Patrols and one (1) Combat Air Patrol over the Task Group, this Patrol shot down three (3) enemy planes.

April 15 Task Group 56.1 remained in the operating area east of OKINAWA. The SAN J.CINTO launched two (2) Sweeps over KIKAI JIMA, one sweep over KYUSHU and one (1) Target Combat Air Patrol. The Sweeps were armed with rockets and 500# G.P. bombs. Two large fuel fires were started at KIKAI south of WAN airfield. At KANOYA airfield KYUSHU, eleven (11) twin engine and nine (9) single engine enemy planes were destroyed on the ground, in addition to bomb hits on one saw-toothed building and adjacent hangar.

APRIL 16.

Task Group 58.1 was in the operating area cast of OKINAWA.

Enemy planes began appearing on our radar screen at 0400 and continued with only slight interruptions until 2100. One enemy plane closed the formation about noon and was shot down by AA fire. Many different types of enemy planes were observed. The SAN JACINTO provided two (2) Target Combat Air Patrols, one (1) Strike and one (1) Combat Air Patrol over the Destroyer Picket Lines. S.N. JACINTO Second Combat Air Patrol over OKINAWA shot down fourteen (14) enemy planes. The Strike on TANABARU town, OKINAWA, hit five or six artillery positions with 500# bombs and rockets. Lt.(jg) Robert L. TAYLOR, A-1 USNR, #337144 made an unobserved water landing and was not recovered. After enemy attacks had ceased, Task Group 58.1 retired southeastware APRIL 17.

Task Group 58.1 and 58.3 rendezvoused with Task Group 50.8 at approximately Lat. 26°N., Long. 132°E. ComCruDiv 10 in BALTIMORE with QUINCY, PITTSBURGH and DesDiv 106 reported to CTG 58.1 for duty. S.N JACINTO refueled, rearmed, and replenished supplies in addition to providing one (1) Combat Air Patrol over the Task Groups. 6 VF replacement planes were recieved and two (2) flyable VF were delivered to a CVE. After completion of replenishment operations, course was set northwestward.

Task Group 58.1 in company with Task Group 58.4 in operating area east of OKINAWA. The SAN JACINTO provided three (3) Target Combat Air Patrols over assigned areas in OKINAWA and launched two (2) Strikes. There was no opposition.

APRIL 19.

Task Group 58.1 in company with Task Groups 58.3 and 58.4 in position approximately thirty-five miles southeast of the southern tip of OKINAWA. Launched heavy Support Strikes for the Army in an all-out attack on enemy positions on OKINAWA. The SAN J.CINTO launched one (1) Combat Air Patrols over the Destroyer Picket Line. The target for the Strike was YONABARU TOWN, on the southeast coast of OKINAWA. Buildings in the barracks area were destroyed and a warehouse hit. APRIL 20.

Task Group 58.1 in company with 58.3 in position approximately forty-five miles southeast of OKINAWA. The SAN JACINTO provided two (2) Intercept Combat Air Patrols over AMAMI and three (3) Strikes armed with rockets and 500# bombs. The targets for the Strikes were AMAMI and KIKAI JIMA. At AMAMI, the radio station at AKAOGA town was strafed by our Fighters and boulded by the Avengers. The radio tower at SUKO SAKI was left in flames by rocket hits at KIKAI, SHIT-OOKE airfield was rocketed and hit by bombs. Barracks and installations, southwest of the field were hit and burned at TORI SHIMA, two (2) fifty-foot water launches on the southwest coast were damaged by the Intercept Combat Air Patrol.

Barracks and buildings southwest of the airfield were hit by rockets. One runway of the airfield was cratered by 500# G.P. bombs. On completion of air operations, Task Group 58.1 retired southeastward.

APRIL 22.

Task Group 58.1 rendezvoused with the fueling and replenishment Group, 50.8 and fueled and rearmed. No flight operations were carried out by this Task Group. No enemy planes appeared in the vicinity. The Destroyer COLLETT was detached from the Task Group to return to ULITHI.

APRIL 25.

Task Group 5%.1 in company with Task Groups 58.3 and 58.4 continued to operate east of OKINAWA. The SAN JACINTO was scheduled to launch five (5) Intercept Patrols and two (2) Strikes, in support of ground operations on OKINAWA. The schedule, however, was disrupted by inclement weather, low ceilings and poor visibility throughout the area. The Strikes were cancelled and only two (2) Intercept Combat Air Patrols were launched. After operations for the day were completed the Task Group retired towards the fueling area.


During the late forenoon and early afternoon fuel, aviation gasoline, provisions and other supplies were taken aboard. Two (2) VF's unfit for combat were launched and two (2) replacement VF's were landed aboard. The Task Group then proceeded to rejoin Task Force 58 in the area east of OKINAWA.

APRIL 27.

Task Group 58.1 rendezvoused with Task Group 58.4 east of OKINAWA in Lat. 26°20' N., Long. 129°47' E. The SAN JACINTO was originally scheduled to launch five Combat Air Patrols over the target area and did furnish four. One was cancelled and in the bays and coves along the southern shore of AMAMI O SHIMA and along the shores of KAKEROMA SHIMA. Numerous small boats, principally landing craft, were discovered and were bombed, rocketed, and strafed. Several were believed to have been destroyed. This was the last Combat mission scheduled for Air Group FORTY-FIVE embarked in this vessel. Retirement towards ULITHI was commenced. During the night the Task Group was joined by the U.S.S. NORTH CAROLINA (BB-55), the U.S.S. HALE (DD-642), and the U.S.S. KICKOX (DD-673).

PHOTOGRAPHIC OFERATIONS

The photographic missions assigned this ship during the operation were for the purpose of obtaining damage assessment pictures. An F6F-5P was used to obtain the desired coverage.

During the operation, a total of sixteen assigned missions was flown. The missions were flown over the following places:
Tokashiki Jima, Yakan Jima, and Kuba Jima in Okinawa Gunto;
Miyako Jima, Sakishima; Kikai Jima and Amami O' Shima in
Amami Gunto; and Minami Daito Jima. The photographic plane
also accompanied two strikes made against shipping, one against
a Japanese convoy near Okinawa, the other against a portion of
the Japanese Flect which was sunk by aircraft near Kyushu.

On the whole, the weather over the targets during the operation was rather unfavorable for photography. Most aerial pictures had to be taken from altitudes of two thousand to three thousand feet in order to avoid cloud cover over the target. The K-17 6-inch and K-17 12-inch cameras were used almost exclusively during the operation. Using this combination in the photographic plane, it was possible to obtain good to excellent pictures of each target assigned. Widest lens aperture, top shutter speed, and a minus blue filter with Sxx film were used in making most of the pictures, although at times the prospect of bad weather over the target made it necessary to remove the filter and use a slower shutter speed in order to obtain adequate exposure.


On each mission the photographic pilots obtained the desired coverage of the target area.

In addition to the assigned photographic missions, all TBM's carried K-20 or F-8 cameras on all strikes; all fighters carried gun cameras, and one fighter plane (F6F÷5FK) was equipped with dual K-25 cameras mounted obliquely to port and starboard.

On 6 and 7 April, Task Group 58.1 was attacked by Japanese planes. The ship's photographers recorded the action with both still and motion pictires.



on April 6th. an enemy plane crashed and exploded off the SAN JAC's starboard bow, littering the flight deck with fragments of the plane (and of the Jap). Here the crew is seen clearing the deck so that planes, already in the landing circle, can land.



This attacking enemy plane, prodded by AA fire from the SAN JACINTO and other ships in the task group, writes its own "finis" in the sky.

Coming in low from almost astern to make his attack on the SAN JACINTO he was hit and then shot upward in a loop as if trying to shake the fire from his belly.





















The photograph shows almost completely the small island of KUBA JIMA which is 22 miles west of OKINAWA JIMA. The few houses and living quarters on the island were destroyed by strikes prior to the time the photograph was taken.

This photograph shows about all that remained of an eight ship convoy after it was attacked by planes from task group 58.1. Japs can be seen clinging to the wreckage and in the lifeboat.

This photograph shows the main section of YAKAN JIMA which is 22 miles west of OKINAWA JIMA. Mining is the main activity of this small island. Ninety per cent of the buildings, including ore crushers, radio station and living quarters were destroyed prior to the time the photograph was taken. The smoke seen near the center of the picture is from buildings set after by SAN JAC-INTO planes.

This cargo ship burns vigorously after it was attacked by SAN JACINTO and other planes of task group 58.1. It was the last ship of an eight ship Jap convoy, and was left burning from stem to stern as planes departed. This shows what Naha City (population 65,000) on Okinawa looked like on April 2sd. after accumulated raids had burned it down.

The two concrete buildings in the center and left center are elementary and high schools.

Note shipping sunk in the harbor in the background. The city is on the SW coast, about eight miles south of the beaches where the U.S. Army and Marines landed on April lst.

This photograph shows a portion of the small island of OKINO DAITO JIMA which lies 200 miles east of OKINAWA and 320 miles south of KYUSHU.

It is very heavily defended, as the photograph illustrates. Note the numerous anti-tank ditches and trenches with which the entire island is laced. Many rifle pits and machine gun positions are incorporated in the trenchwork. In the lower right portion of the photograph is a battery of four heavy AA and nine medium AA.

This plane made a shallow glide from about 8,000 to 9,000 yards distance straight for the BELLEAU WOOD. He had been under observance for about two or three minutes by our starboard battery, but he had a belly tank exactly like an F6-F and resembled

an F6-F to such an extent that we did not recognize him as a Jap plane until he was well in his glide towards the BELLEAU WOOD. It is believed that practically all ships in the formation also believed him to be a friendly fighter because 40MM. Mount XI on the SAN JACINTO was the first gun in the group to open fire on the attacking plane. The Jap fell into the water without burning about 75 yards off the BELLEAU WOOD's starboard beam. We claim an assist and credit for pointing the plane out as enemy to the formation.
