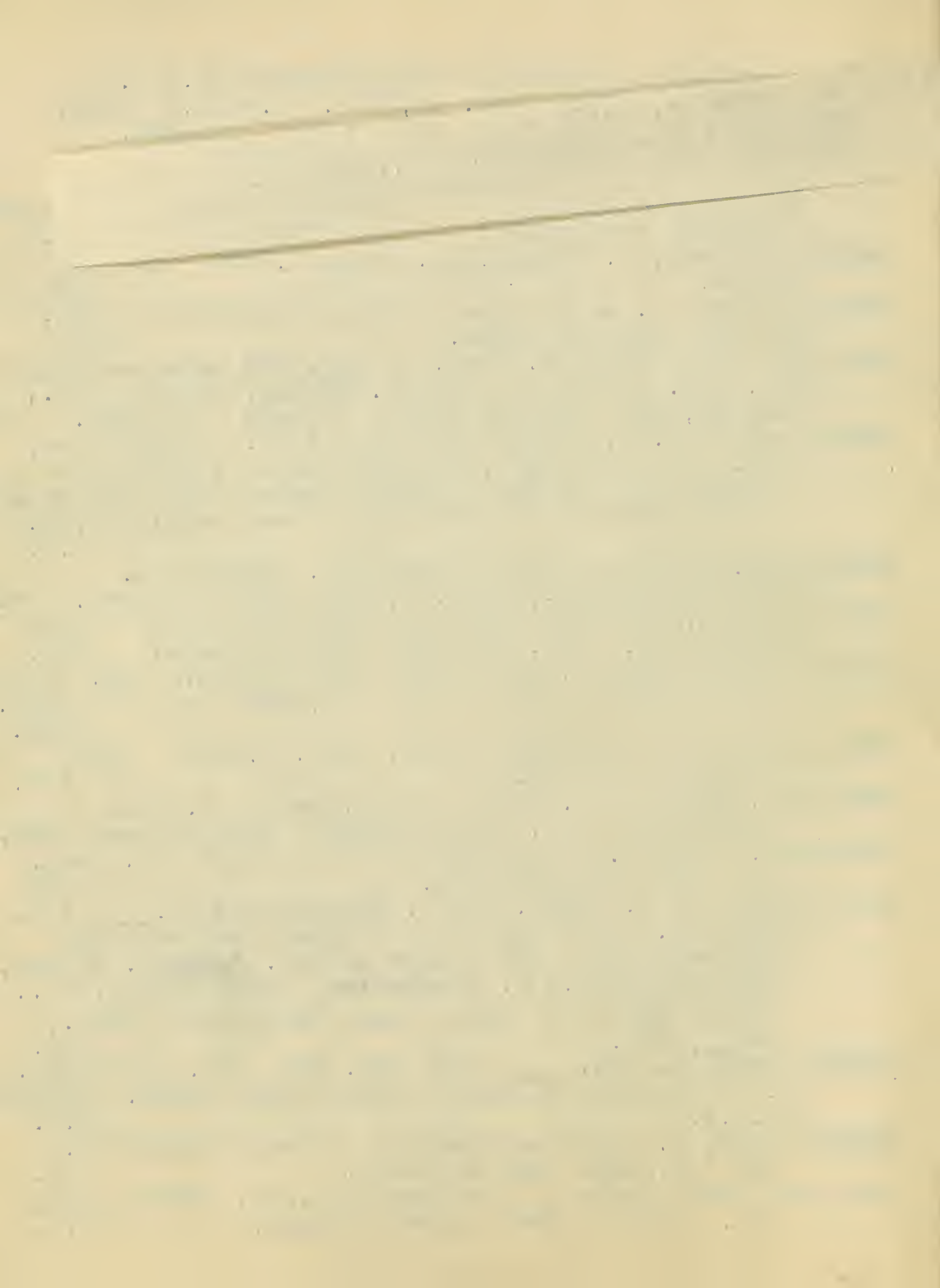

Prior to ^{about} 1880 the names of surviving children of deceased persons were seldom mentioned while nowadays they are rarely ever omitted.
