SUMMARY REPORT

JOHN HOWARD LAWSON, a playwright and screen writer by profession, is a United States citizen by virtue of his birth in New York City September 25, 1894. On October 27, 1947 LAWSON appeared as a witness before the House Committee on Un-American Activities at Washington D. C. where he refused to answer all questions concerning the Communist Party and as a result he was later voted a contempt citation by the United States Congress. He was subsequently indicted and convicted for contempt of Congress. His conviction was sustained on appeal and upon the United States Supreme Court's refusal to grant certiorari, he was incarcerated in the Federal Correctional Institution at Ashland, Kentucky from June 9, 1950 to April 9, 1951. Subsequent to his release from incarceration, LAWSON has resided at 9354 Burnet Avenue, San Fernando, California, however he makes periodic trips to New York City. LAWSON derives his livelihood from lectures given under the auspices of the Hollywood ASP which are based on his published book "The Hidden Heritage" and his forthcoming book on the culture of the United States. LAWSON was identified as a Communist Party member by the sworn testimony of fifteen witnesses before the House Committee on Un-American Activities. Informants have advised that subject
