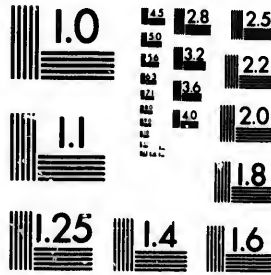

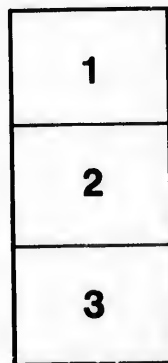
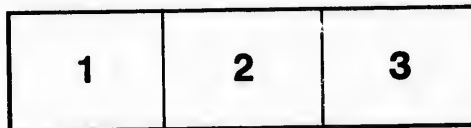

A CENTURY OF MUNICIPAL HISTORY.

The Development of Municipal Institutions, 1841-93.

A very important municipal act was passed in 1841. By it, District Councils were established in Upper Canada "capable in law of suing and being sued, and of purchasing and holding lands and tenements situate within the limits of such District, for the use of the said inhabitants and of making and entering into such contracts and agreements as may be necessary for the exercise of their corporate functions." These councils were authorized to "make by-laws" for making, maintaining, or improving existing roads or streets or stopping up, altering, or diverting them; for erecting, preserving and repairing bridges and public buildings; for purchasing and selling real property; for superintending and managing the property of the District; for defraying the expenses of the administration of justice; for the establishment and support of schools; for raising money for District purposes; for collecting and accounting for such moneys; for imposing penalties on persons elected and refusing to serve in municipal offices; for remunerating District and township officers, and for commuting statute labor. The Warden and Treasurer were appointed by the Governor, and the Clerk selected by him from among three persons nominated by the Council. Every township entitled to elect municipal officers was authorized to elect one Councillor, and each township having more than 300 inhabitant freeholders and householders, two Councillors, who were to be chosen on the first Monday in January, 1842, by the inhabitant freeholders and householders of such townships. No person was eligible for election unless he was a resident of the township for which he was elected, and the owner of real estate to the value of £300 over and

above all charges or encumbrances. One-third of the Councillors, to be determined by lot, were to retire each year, so that at the end of three years none of the Councillors elected at the first election should remain in office unless subsequently re-elected. It was provided that there should be four quarterly meetings of these Councils, beginning on the second Tuesday in February, May, August, and November, and not lasting more than six days each, besides which "extraordinary meetings" might be authorized by the Governor. One Auditor was to be appointed by the Warden, another by the Council. A District Surveyor was to be appointed by the Warden, subject to the approbation of the Governor, who was to superintend the execution of all public works undertaken by the Council, and take care of all "fixed property belonging to such District." All property was to be rated equally, except wild land, which could not be taxed more than a penny and a half per acre annually. Any by-law passed by the Council might be disallowed by the Governor within 30 days after a copy was received by the Secretary of the Province, to whom the Warden was obliged to transmit it immediately after passing it.

No Councillor was permitted to receive any wages, allowance, profit, or emolument whatever for his services.

The Municipal Act of 1841 was comprised in seventy-three sections, covering twenty pages of the Statute Book.

The District of Niagara as then constituted consisted of the twenty-two townships subsequently composing the Counties of Lincoln, Welland and Haldimand, having an area of 663,184½ acres. Bertie, Stamford, Pelham, and Thorold were found to be entitled to elect two members each, and the remaining townships of Welland one member, of the District Council. David Thorburn of Stamford was appointed Warden.

In 1846, an act of twenty-two sections was passed amending the Municipal Act of 1841. District Councillors were henceforth authorized to receive a daily stipend not exceeding six shillings and three pence for each day they actually sat in Council. They were

enabled to elect a Warden from among themselves and appoint a Treasurer, who was to retain office for three years, and appoint or remove the Clerk. Only two ordinary meetings in February and October, limited to nine days each, were to be held annually. They were authorized to raise money for the relief of the indigent, sick, or infirm. It was no longer made compulsory to employ the District Surveyor on works costing less than £50.

By the act of 1849, Municipal government was established practically in its existing form, but the powers of municipalities have from time to time been materially enlarged.

The Niagara District Council.

It is doubtful whether the original minutes of the Niagara District Council are now extant. During the last three years of its existence, however, these were printed, and some copies have thus been preserved. Judged by this record of its proceedings, it appears to have been a painstaking and hardworking body. The members assembled at 9 a. m., adjourned at 1 p. m.; met again at 3 p. m., adjourned at 6 p. m.; resumed at 7 p. m., and frequently sat until midnight and sometimes later. Their attention was engrossed by an ever-growing volume of petitions from all parts of the District, mostly referring to matters which would now be disposed of by the local township council. In 1847, 62 petitions were presented at the first meeting, and 59 at the second; in 1848 the number increased to 111 at the first session, and 85 at the second; in 1849 there were no less than 130 at the first session, and 54 at the second.

David Thorburn, appointed Warden by the Governor in 1842, acted under this commission until the end of 1846, when the office became elective. He was returned as one of the members for Stamford in January, 1847, and unanimously elected as Warden on the 2nd of February, when an address and a silver box was presented to him by the members of the Council. He was re-elected in

1848, and again in 1849. John G. Stevenson was appointed Clerk in 1847, succeeding John Simpson, and D. D'Everardo of Pelham became Superintendent of Education in August, 1846, when he was one of the members for that township.

Appropriation for public schools in County of Welland, £893. Number of public schools in the Niagara District, 183. Number of pupils, 8,948. Average attendance in summer term, 4,075 ; in winter term, 4,519. Whole number of children of school age resident in district, 12,963.

Private schools—One at Stamford Village, two at Drummondville, a "classical school" at the City of the Falls, and a German school in Humberstone, "principally supported by some Prussian settlers."

Feb. 10.—By-law passed to authorize "construction of a magnetic telegraph between the towns of Niagara and Queenston," on the public highway.

In October, Humberstone was declared entitled to a second member.

1848.

By-law to raise £325, by local assessment, in Township of Pelham for construction of a town hall.

By-law to provide for commutation of statute labor and repairs of public streets in the Village of Waterloo [Fort Erie], in the Township of Bertie.

By-law to enable inhabitants of Port Colborne to elect their pathmaster.

By-law for commuting statute labor in Village of Fonthill.

By-law to authorize inhabitants of Drummondville to appoint their pathmaster.

By-law fixing remuneration of township officers: Salary of the Clerks in all the townships of Welland fixed at £4 per annum. In Bertie, salary of Assessor fixed at £7, 15 ; of Collector, £10. Crowland, Assessor, £5 ; Collector, £7. Humberstone, Assessor, £7, 5 ;

Collector, £9. Pelham, Assessor, £7, 10; Collector, £10. Stamford, Assessor, £10; Collector, £12, 10. Thorold, Assessor, £10, 5; Collector, £13, 10; Wainfleet, Assessor, £6, 5; Collector, £8. Willoughby, Assessor, £6; Collector, £7.

Appropriation for Public Schools in Welland, £903.

Number of Public Schools, 184. Number of pupils, 10,328. Average attendance, summer term, 4,281; in winter term, 4,516. Number of resident children, 13,172. Private Schools—one in Village of Thorold; three in Drummondville; three in Chippawa; one German school in School Section No. 4, Humberstone.

1849.

The Council noticed the annexation movement of that period in the following manner on the 6th November:

“Moved by Mr. McMicken, seconded by Mr. Hagar, and ordered, that the Council resolve itself into Committee of the whole to consider the expediency of giving an expression in reference to the recent advocacy of annexation by certain parties within the Province, pursuant to notice.

“Moved in amendment by Mr. Foley, seconded by Mr. Gilleland, and resolved, That the Council do not now resolve itself into a committee of the whole, but that all after the word ‘that’ in the first line be expunged, and the following inserted:

“That this Council view with mingled feelings of disapprobation and regret the movement now being made in Montreal for the separation of Canada from the parent state; and that they are prepared and determined by all means in their power, to suppress any attempt at such separation, no matter from what source the same may originate.”

A Provisional Council formed for the County of Welland.

1855.

Warden, John Simpson, Reeve of Niagara.

Jan. 24.—Memorial to Legislature for the appointment of Crown Prosecutors; also for prohibition of sale and manufacture of intoxicating liquors.

May 16—£1000 voted to the Patriotic Fund.

Memorial to the Legislature to permanently unite the counties of Lincoln and Welland. The Reeves of Bertie, Crowland, Humberstone, and Deputy Reeve of St. Catharines voting nay; the Reeves of Stamford and Thorold township, and village of Thorold voting with the majority. The memorial recited that in the preceding year a majority of the Reeves from Welland had been in favor of separation, and had entered into a contract to erect County Buildings at Merrittsville, and prayed that the counties should be united until two-thirds of the Council of the united counties should pass a by-law for separation, and that in such case the village of Thorold should be the county seat.

1856.

Warden, George Rykert, Reeve of St. Catharines.

30th Jan.—Memorial to Legislature to impose the same duties on American manufactures entering Canada as were collected upon Canadian manufactures of the same description when imported into the United States.

30th Jan.—Memorial praying for the passage of an act to enable counties to establish Industrial Farms and Houses of Refuge.

30th Jan.—Memorial praying the Legislature to facilitate the separation of the counties of Lincoln and Welland—only the Reeves of Niagara town and township and the township of Louth voting nay.

Proclamation issued for the separation of the Counties.

Provisional Council of the County of Welland.

The first Provisional Council for the County of Welland was organized in 1850, and continued to hold sessions from time to time and to transact business, until 1854, when it was formally reorganized by proclamation, but it did not levy assessments or provide means, except about £25 in 1850 for the payment of members or officers, and these expenses were subsequently charged upon the Marsh Lands Fund. Unfortunately the minutes of this council are not obtainable at the present time.

3rd March.—Memorial praying for repeal of the Separate School Act.

3rd March.—Memorial praying for the abolition of tolls on the Welland Canal between Merrittsville and Port Robinson, on vessels ascending and descending the Welland River.

5th May.—Memorial for better observance of the Sabbath in respect to the administration of the Post Office and Canals.

20th May.—Report of Committee on Marsh Lands, giving the history of the purchase. The tract, containing 2,116 acres in Humberstone, and 10,796 acres in Wainfleet—in all 12,912 acres, was bought on the 10th Feb'y, 1854, for \$1 per acre, being £3,228 for the whole, to be paid in ten annual instalments, of which only one had been paid. As a condition of the sale the county was required to construct a main drain, commencing at or near the Lyon's Creek culvert, and extending westward to the western limit of the tract, to be not less than four feet in depth and five in width at the bottom, and to be begun on or before the 1st of June, 1854, and finished on or before the 1st November, 1855. The contract for this drain was actually let on the 30th Dec., 1854, and a contract made at the same time for a road along its margin. Finding that the drainage was obstructed by the mill-dam at Cook's Mills, the dam and mill privilege was purchased for £687, 10s. and the dam removed. In 1855, the back ditch was deepened at a cost of £205, and £335, 8s, 2d spent on the Marshville Tap Drain.

On the 4th of January, 1855, sixty-eight lots at Port Colborne were sold for £1494, 10s, and on the 13th of same month 3,365 acres in Humberstone and Wainfleet were sold for £6,334, 8s, 1½d.

Minor Municipalities.

The sober and stable disposition of the people generally is indicated in a marked degree by the long tenure of office in various municipalities by men who have gained the public confidence.

Of these, the late Edward Lee of Wainfleet was perhaps the most striking example. Elected clerk of the township in 1835, he held office in that capacity and subsequently as councillor, reeve or treasurer, until his death in 1887, a period of fifty-two years. For exactly a quarter of a century he continued to represent his municipality in the County Council. Daniel Near was councillor, reeve or clerk of Humberstone for thirty-six years in succession and, like Mr. Lee, died in office at an advanced age. James Cummings held some municipal office in Willoughby or Chippawa for upwards of thirty years. Both the last named gentlemen represented the county for

some time in the Provincial Parliament. Most of the successful and unsuccessful candidates for both Houses of Parliament have at some time been members of the County Council. Among these may be enumerated Messrs. Gilbert McMicking and Archibald Thompson, who were members of the District Council; John Frazer, T. C. Street, Wm. McCleary, W. M. German, J. A. Lowell, E. Lee, Edwin Hershey, Wm. Buchner, G. L. Hobson, A. Fraser, James Lawson, A. G. Hill and John Pew.

Mr. Joseph Garner, who was councillor and reeve for Pelham for twenty-three years, ranks next to Mr. Lee in length of service, and John A. Ramsden comes next, with a record of fifteen years.

The councils of most municipalities seem to be convinced that it is not wise to make frequent changes in the offices of treasurer and clerk. Mr. W. T. Fish has been clerk of the town of Thorold for twenty-six years, Mr. E. R. Hellems clerk of Welland for twenty-four, and Mr. Wm. Greenwood clerk of Chippawa for twenty-two. The late John B. Crow was clerk of Pelham for twenty-eight years, and Col. J. E. Morin held the same position in Bertie for twenty years. Mr. J. C. Woodruff was treasurer of Stamford for thirty-three years and Mr. H. D. Lock has been treasurer of Welland for eighteen.

As a municipality, Port Colborne has shown the most remarkable example of stability in retaining the same appointed officers although the composition of the council has frequently changed. Mr. David Hughes has held the office of treasurer since incorporation, a period of twenty-four years, Mr. James Twohey has been collector for twenty-two, and Mr. S. J. Hopkins clerk for twenty-one years.

Many other examples of a similar indisposition to change without very good reason will be observed in the following pages.
