The Health Protection (Coronavirus, Local COVID-19 Alert Level) (Medium, High and Very High) (England) (Amendment) (No. 2) Regulations 2020

Coming into force - 27th October 2020

The Secretary of State makes the following Regulations in exercise of the powers conferred by sections 45C(1), (3)(c), (4)(b), (4)(d), 45F(2) and 45P of the Public Health (Control of Disease) Act 1984(a).

These Regulations are made in response to the serious and imminent threat to public health which is posed by the incidence and spread of severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) in England.

The Secretary of State considers that the restrictions and requirements imposed by the Health Protection (Coronavirus, Local COVID-19 Alert Level) (Medium) (England) Regulations $2020(\mathbf{b})$, the Health Protection (Coronavirus, Local COVID-19 Alert Level) (High) (England) Regulations $2020(\mathbf{c})$ and the Health Protection (Coronavirus, Local COVID-19 Alert Level) (Very High) (England) Regulations $2020(\mathbf{d})$ as amended by these Regulations are proportionate to what they seek to achieve, which is a public health response to that threat.

In accordance with section 45R of that Act, the Secretary of State is of the opinion that, by reason of urgency, it is necessary to make this instrument without a draft having been laid before, and approved by a resolution of, each House of Parliament.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations subject the area of Warrington Borough Council to the restrictions set out in the Health Protection (Coronavirus, Local COVID-19 Alert Level) (Very High) (England) Regulations 2020 (the "Very High Regulations") and make corresponding amendments to remove Warrington from the Health Protection (Coronavirus, Local COVID-19 Alert Level) (High) (England) Regulations 2020. They impose closures on additional businesses in that area.

They also make a number of minor corrections to the Very High Regulations, the Health Protection (Coronavirus, Local COVID-19 Alert Level) (Medium) (England) Regulations 2020, and the Health Protection (Coronavirus, Local COVID-19 Alert Level) (High) (England) Regulations 2020.

No impact assessment has been prepared for these Regulations.
