Dear Ms. Katz, Ms. Banks, Mr. Abboud, and Mr. Bromwich:

I am pleased that Dr. Christine Blasey Ford has accepted the Committee's invitation to testify in an open hearing on Thursday, September 27. I will do everything in my power to provide a safe, comfortable, and dignified forum for Dr. Ford to testify.

This session of the hearing on Judge Brett M. Kavanaugh's nomination to serve as an Associate Justice on the Supreme Court is an important part of the Senate's constitutional duty to advise the President on his nominee and, if the circumstances merit, to consent to the nomination. To assist the Committee in performing this duty, and to make the hearing a productive one, I ask that you provide the Committee the following documents:

- 1. Copies of any and all written, audio-visual, or electronic materials relating to the allegations raised by Dr. Ford against Judge Kavanaugh that Dr. Ford or her representative previously provided to any member of the United States Senate, any Member of the House of Representatives, or any reporter or other agent of a press outlet;
- 2. Copies of all written, audio-visual, or electronic materials upon which Dr. Ford intends to rely for her written or oral testimony before the Committee;

3. Copies of the results of the polygraph which Dr. Ford has stated was administered to her in early August 2018, as well as the list of questions asked during the administration of that polygraph.

Please provide these materials to the Committee no later than Tuesday, September 25. Committee rules also require that Dr. Ford submit her biography and written testimony by 10:00 a.m. on Wednesday, September 26. I thank you for your assistance in this matter.
