(4) Average Strength for the Period: 720

b. Sequential Listing of Significant Events, Especially as they relate to:

- (1) Personnel: The battalion was at 91% T/O strength at the end of the reporting period. There are no shortages of critical personnel that would seriously hinder the mission of the battalion. The battalion had four combat casualties and three marines evacuated for non-combat medical reasons. Fifty marines participated in the R&R program during March.
- (2) Administration: There was no significant or unusual event to report.
- (3) Intelligence: Dissemination of pertinent intelligence information was accomplished by daily briefings for staff officers and distribution of intelligence summaries to the batteries. Active patrolling by the batteries has continued. Several positive contacts have been reported and on 21 March 1966 a patrol from Battery "E" uncovered two VC in an eight foot tunnel at coordinates AT 985-667. The two VC were killed



in an attempt to capture them for interrogation. Further investigation indicated that the VC killed were tax collectors. Such patrols have further increased the security of battery perimeters and aided personnel to become familiar with their respective surroundings. Patrols have continued to uncover and destroy pre-planned mortar positions and firing markers in the proximity of their battery positions. During this reporting period, an increase in VC contact by Marine units has been noted. VC units of estimated company size strength and possibly battalion size strength have engaged Marine units in combat during hours of darkness. Such engagements have been supported by VC mortars. Because the VC have stood and fought, the opportunity to direct effective artillery fires upon known and suspected enemy locations has resulted in decisive setbacks to VC operations. On 18 March 1966, F-2-9 moved into an area of an intended VC ambush but with the support of accurate artillery fires, Company "F" was able to regain the initiative and overcome the attempted ambush. See para(5) Operations for further details.

- (4) Training: Due to continued operational committments, formal training has been curtailed. Emphasis has been placed on fire direction procedure with specific time devoted to fire direction proficiency within the battalion and battery fire direction centers. Familiarization firing with the M-14 rifle and the rifle grenade was conducted for 40 personnel during March. The battalion sent four marines to Generator Operator's School conducted by the 3d Engineers. The Chaplain's lectures on Vietnamese religions was accomplished in all batteries. Three marines were sent to the 4th Battalion FO school at Phu Bai.
- (5) Operations: The battalion fired a total of 371 missions and 3,442 H&I fires in support of 9th Marines and ARVN operations, expending 711 rounds of 155mm howitzer ammunition, 6,318 rounds of 105mm howitzer ammunition, and 2,291 rounds of 107mm mortar ammunition. 10 rounds of 155mm Gun and 62 rounds of LVTH-6 ammunition. Enemy casualties for this period were 68 KIA, 40 KIA poss, and 90 WIA. The significant periods of this battalion's firing are as indicated:
- (a) 162315H fire mission in support of ARVN troops resulted in a surveillance of 21 KIA and 90 WIA. Encl. (1) line 30, 31, and late entry 171725H.
- (b) 181845H to 190147H fire missions conducted during this period were in support of F-2-9. This company was under heavy small arms and mortar fire, Encl(1)lines 37-49. On 19 March 1966 at 0024,0100 and 0147 countermortar fires were directed toward VC mortar positions with a surveillance of secondary explosions noted at 190100H, Encl(1)lines 5,7,and 8. On 19 March 1966 at 1300, FO E-2A, 1stLt COX, with F-2-9 reported that the local villagers indicated that approximately 100 VC had occupied the area where artillery fires had been directed at 0024, 0100, and 0147, entry of Encl(1). Villagers stated that the VC carried away at least twenty bodies from the area, Encl(1)line 35. Further reports from K-3-9, sweeping the area where secondary explosions were reported, stated that the area had discarded and damaged ammo cannisters, and what was believed to be pieces of mortar tubes. The company commander of Co. "K" reported that he had also observed artillery rounds bursting on mortar flashes in the area.

- (c) 250138H to 250500H fire missions conducted during this period resulted in 43 KIA, 40 KIA poss, Encl(1)lines 3 through 26. Body count confirmed through 9th Marines FSCC. It was further reported that a patrol from E-2-9 found mortar positions with base plate imprints at coordinates AT 961-597. Patrol discovered two additional mortar positions and 17 ammunition cannisters in the area at coordinates 961-597. Artillery craters were predominant throughout the area.
- (d) With the attachment of Mortar Battery, 3d Battalion, 12th Marines, the battery emplaced on Hill #55 on 7 March 1966 to provide available fires to marine units actively engaged in search and destroy operations.
- (e) During Operation "KINGS", Btry "E" displaced four 105mm howitzers to Hill #55 at coordinates AT975-625, 25 March 1966 and Btry "L" displaced two 155mm howitzers (SP) to Btry "E" position at coordinates AT 988-672. This movement was accomplished to provide adequate artillery support for the operation.
- (f) With the extension of the 9th Marines TAOR, the following batteries were positioned to afford adequate artillery support for respective supported units:
 - (1) Btry "E" moved to coordinates AT986-644, 31 March 66.
 - (2) Btry "F" moved to Hill #41 coordinates AT933-666 26 March 1966.
- (6) <u>Command and Control</u>: The command post location and mission of the 2d Battalion remains the same.
- (7) Communications/Electronics: The battalion received radio equipment AN/CRC 125's and AN/PRC-25's bringing the total issue to nine AN/CRC 125's and eight AN/PRC-25's. Distribution of this equipment was accomplished from 2-4 March to the following batteries:

On 19 March 1966 an FSR instruction team from Okinawa instructed communication personnel of the battalion on the operation and maintenance procedures for the AN/GRC 125's, AN/PRC 25's, switchboard and teletype equipment. The instruction given by the team provided valuable background for proper use of this equipment.

- (8) <u>Logistics</u>:The logistical posture of this command remains in a satisfactory status. The motor transport deadline rate has been lowered significantly since the last report and is currently rated at 7.1%. The lack of refrigeration is rapidly becoming a problem for the firing batteries. The occurance of food spoilage has increased and the need for corrective action is paramount.
 - (9) Air Defense: Our Air Defense capabilities remain the same.
 - (10) Civil Action/Military Government/Community Relations:
- (a) <u>Civic Action</u>: Medical personnel treated 232 Vietnamese for various ailments and 146 bars of soap were distributed.
 - (b) Miltiary Government: Nothing to report.
- (c) <u>Community Relations</u>: Headquarters Battery personnel visited a local **grammer** school and donated approximately 80 pounds of sports equipment to the school.
