SYNOPSIS			

Investigation requested by District Commander, DO #5, Wright-Patterson Air Force Base, Dayton, Ohio. Mr. [REDACTED] saw, while in back yard at [REDACTED], San Francisco, California, at approximately 2115 hours, on 29 November 1948, an unidentifiable glowing object passing from the East to the Northwest at a very great speed, finally disappearing from sight behind a fog bank to the North. Investigation failed to reveal identity of the object or produce other witnesses.

DETAILS:

1. Investigation requested by District Commander, DO # 5, Wright-Patterson Air Force Base, by letter dated 27 December 1949, File No. 5D-24-4, Subject, Project Sign, which letter advised that a Mr. [REDACTED] had reported the sighting of an unknown object on the night of 29 November 1948.

AT SAN FRANCISCO, CALIFORNIA

2. On 13 January 1949, Mr. [REDACTED] San Francisco, California, was interviewed and stated that he is a teacher in science at the Francisco Junior High School, San Francisco, California. In the course of his instruction it is necessary that he present the students with some basic astronomy, and in connection with this course Mr. [REDACTED] was studying the constellations on the night of 29 November 1948 while in back yard at [REDACTED], San Francisco, California, as it was an exceptionally clear night. To further aid his study [REDACTED] was using a pair of 4X binoculars. At 2115 [REDACTED] sighted a glowing object to the east and healing in a North-Northwesterly direction. Mr. [REDACTED] emphatically stated that the object did not appear to be either a comet or a meteor, in that the object did not stream fire or light, but was spherical in shape and emitted a steady glow. The only difference that could be observed by [REDACTED] between the normal sight and sight through the binoculars was that the object appeared brighter. [REDACTED] followed the object through the binoculars until it passed from view to the North over a low fog bank which was lying over the Golden Gate Bridge. [REDACTED] stated at no time did he hear any noise that seemed to come from the direction of the object. After the object had disappeared, [REDACTED] simulated his movements again and stated that the total time that the object was in sight was approximately seven seconds of which three or four seconds were through the binoculars. In [REDACTED] opinion, the object was approximately 35 to 40 degrees above the horizon.

3. [REDACTED] was in the Air Force as a Radar and Radio Mechanic and spent time overseas in England. While in England, [REDACTED] saw German buzz bombs at night and remarked that the object in no way appeared like one of these bombs in that the object emitted a steady glow which was bright yellowish and the buzz bombs seemed to him to emit spasmodically a rosy red flame. [REDACTED] s only hobby is radio which he has practiced since he was a boy.

4. The writer, through the fact that [REDACTED] is a science teacher and after speaking with him, believes that [REDACTED] is above

average intelligence and reliable. [REDACTED] is near-sighted and wears glasses; however he was not wearing glasses while using the binoculars. [REDACTED] vision with glasses is 20-20.

5. A thorough check of the residents in the vicinity of [REDACTED], San Francisco, California, failed to reveal any other persons who, on the night of 29 November 1948, saw this unidentifiable light or had seen anything unusual any other night.

6. On the night of 16 January 1949, the writer and Mr. [REDACTED] attempted to trace the course of the object with the aid of a star map. This attempt met with negative results. Mr. [REDACTED] could not even give an approximate course.

No derogatory information was revealed in a check of local law enforcement agencies on [REDACTED] or the Teachers' Union (A.F.L.), San Francisco, California, in which [REDACTED] was interested. This subject was not sighted by any employees of the air lines or personnel of the Air Force operating in the Bay Area.

AT SAN FRANCISCO, CALIFORNIA

1. Mr. [REDACTED] Francisco Junior High School, Powell and Francisco Streets, San Francisco, California, and Mrs. [REDACTED] Francisco Junior High School, were interviewed and stated in substance that [REDACTED] loyalty to the Government was above question in their estimation and his integrity and character were of the best. [REDACTED] is not known to drink heavily nor is his imagination known to be flamboyant. Further [REDACTED] is one of the better teachers in that he is conscientious, observant and able to handle and understand the younger people. Neither knew of any derogatory information concerning [REDACTED]. In the course of these interviews it was revealed that [REDACTED] is very interested in the Teachers' Union (A.F.L.) which is attempting to gather strength in San Francisco. A check of this Union revealed that out of approximately 3,000 teachers in San Francisco, only about 200 are members of the Union. There was no derogatory information available concerning the Teachers' Union (A.F.L.), San Francisco, California.

2. A check with the American Airlines, Pan American Airlines, Western Airlines, Mills Field, California; Operations, Hamilton Air Force Base; and Operations, Alameda (Navy), California, failed to reveal any reports of a strange object's being sighted on the night of 29 November 1948.

Incident #220 -- San Francisco, California -- 29 November 1948

There is good reason to believe that the object observed in this incident was a bolide. The fact that the observer, although a science teacher, confused the term comet with meteor is strong evidence that he is unacquainted with these phenomena: a comet appears stationary in the sky over a relatively long period of time. While the evidence is insufficient to establish with any certainty that the object was a bolide, it appears to this investigator, none the less, to be the most probable explanation.

1. Reference is made to letter from your headquarters, MCIAKS, dated 9 March 1949, subject "Unidentified Flying Objects," and first endorsement thereto by this headquarters, dated 31 March 1949.

2. The incident summaries 173 through 233 have been checked against routine weather-balloon ascents made by the Air Force, Navy and Weather Bureau. Comments based on this review are inclosed.

3. It is recommended that the "Guide To Investigation Of Unidentified Aerial Objects" be changed as follows: Item 13, "Direction of Flight of Object," should be clarified so that vertical and horizontal motions are distinguished if possible, and so that motion is specified as the direction towards which the object appears to move. "Relative to Radar Settings" should include a statement of the type of radar set used.
