authorities relative to the recent arrest of the subject for Attempted Extortion. GRAZIANO stated that GRANELLO and his associates are "all washed up" and he, GRAZIANO, has "nothing to do with them".

The informant was of the opinion that GRAZIANO remains in close association with GRANELLO and is skeptical concerning the reports that GRAZIANO will testify against GRANELLO. The informant added that he expects/GRANELLO will endeavor to "fix" the charges against him.

The informant further commented that several years ago GRAZIANO expected to develop a system whereby commercials would be played on juke boxes. However, this prospect did not materialize, but the informant believes that GRAZIANO expected to develop this set up with IRVING HOLZMAN, the victim of Attempted Extortion by GRANELLO.

Due to the sensitive nature of the foregoing information and the fact that it is mostly conjecture on the part of the informant, this information has not been included in the details of this report.

On 8/14/64, NY 4317-C advised that he heard from PETE PETRELLA that the subject owes his life to ROCKY CRAZIANO. The informant is of the opinion that GRAZIANO has probably made arrangements for a "fix" in the subject's pending income tax case.

On 8/24/64, NY 4461-C advised SA PAUL G. DURKIN that he has not seen the subject in the recent past, but was told that GRANELLO is not at all worried about his arrest for Attempted Extortion in Nassau County, NY. According to the information received by the informant, arrangements have been made to take care of the matter for the subject.
