1. Above-named off is placed on TDY and WP via air or water transportation to a US PD, reporting upon arrival thereat to the Debarkation O for instructions and movement to Reception Sta No 16, Camp McCoy, Wisconsin, where off WP for forty-five (45) days rehabilitation, recuperation, and recovery exclusive of travel time at 3450 20th Avenue, South; Minneapolis 7, Minnesota. Prior to departure from this theater off will report to CO Disposition Center 4th Repl Dep APO 703 for processing. Upon compl of recuperative TDY, off will ret to proper overseas sta. APR to US is SW-US-4-11395-WDP. Auth: WD Cir No 8, 1945 and WD Ltr, PRI, 16 Aug 1944.

2. The provisions of Par 25, C4, AR 35-4820, 11 Feb 46 apply while traveling by air and for period of TDY within the United States and the provisions of Par 26, AR 35-4820, 19 Apr 45 apply for travel outside the continental limits of the United States. No per diem auth while off is on recuperative TDY. 65-*** P432-02 A 212/60425.

3. Off accepts this privilege with the definite understanding that he will be returned to this theater upon compl of TDY within the US (Excel).

4. Off is excepted from screening procedures under par 4g(1)(b) of Ltr AG 370.01 (17 Jan 46) OB-S-A-M, 23 Jan 46, Subj: Screening of Personnel for Overseas Movement.

5. Personal baggage not to exceed 65 pounds auth while traveling by air.

6. Prior to departure from this theater off will have in his possession WD AGO Form No 8-117, Immunization Register; WD AGO Form No 65 or 65-1, Officer's Identification Card; WD AGO Form No 66-1, Officers and Warrant Officers Qualification Card, WD AGO Form No 77, Officer's Pay Data Card; ATC Air Tvl Clearance Certificate; personal cert of amount of lv of which off has availed himself since entry on AD as prescribed by par 23b AR 605-115; and will require physical inspection as prescribed by par 2, AFPAC Reg No 50-60, 30 Sep 45.
