

Certificate

1. Document issued by the Central ^{Military} Authority in the latter part of May 1939 (14 year of Showa), to the Kwantung Army ordering informing them to localize the Nomonhan Incident to that area and also stating hope for putting end to the incident by giving up plans of advancing west of the Harha ^{Harha} River.
2. Document issued by the Central Military Authority on ~~the~~ 29 June, 1939 (14th year of Showa), to the Kwantung Army informing them to limit the ground fighting of the Nomonhan Incident north of ~~the~~ Lake Boray ^{Beilnoh} and in the Manchuria-Mongolia border area, and also transmitting to them that aerial attack was not to be carried out on enemy basis.
3. Document sent to the Central Military Authority on July, 1939 (14 year of Showa), by the Kwantung Army informing the authority that there ~~was~~ ^{is} no alternative but to carry out a raid on Tamshuk ^{Tamshuk}.

area because of not being able to withstand damage any longer caused by limiting our air force's activity to intercepting the enemy within our own border.

4. Document issued in August 1939 (14th year of Showa), by the Central Military Authority permitted the Kwantung Army Air Force for the first time to carry out raids on the enemy after the Kwantung Air Force faced near annihilation.

I certify that the above mentioned four documents were in the custody of the Staff Headquarters, but were burnt and destroyed with other similar documents at the end of the war and they do not exist at the present time.
