A support group composed of 4 SHANROCK BAY TBM-3's lead by an air coordinator in a VC-91 FM-2, attacked a cave area in southern Okinawa at 1700 on 23 April, believed to contain enemy stores. All bombs, AR and ammo, consisting of 10x500 lb. and 5x100 lb. g.p.'s, 32 AR, and 2000 rds. of .50 cal., were expended in an area 150x80 yds.. 4 bombs were observed to hit at the mouths of caves, 2 on top of caves. Ens. H.A. ALLEN placed 2 AR in the mouth of 1 cave.

At 1715 I of the same day Lt(jg) R.H. AULT, upon completion of an observer mission in a TBM-3, attacked with 8 AR and burned a 50x25 foot bldg. in the town of Konesu.
