It is possible that SAM is identical with SAMUEL QUARCINI, a confidential informant known to the Bureau as BU 259-C who has furnished information regarding the activities of hoodlums in the Hod Carriers and Common Laborers Union, Local 91, at Niagara Falls, New York.

The informant also stated that RANDACCIO and MAGADDINO had a lengthy discussion concerning matters involving ANGELO BRUNO of Philadelphia and his arrearance at the Peace Bridge Hotel in Buffalo, New York. The source stated that RANDACCIO made reference to his meeting BRUNO at the airport upon his arrival from Philadelphia with (FNU) SINATRA.

Due to the fact that most of the conversations between RANDACCIO and MAGADDINO are in a Sicilian dialect a large portion of the conversation was not reported by this informant.

On 9/1, 2 and 3/62, the informant reported no pertinent information relating to the subject or his associates.

On 9/4/62, BU 82-C\* advised that STEVE MAGADDINO again appeared in Buffalo, New York, and visited with VINCENT A. SCRO, JAMES V. LA DUCA and CHARLES A. MONTANA.

Later during the day JAMES P. SALAMONE and DOMINIC ADIUTURI, of Erie, Pa., visited with STEVE MAGADDINO and discussed the operation of laundry businesses in Erie, Pa., Cleveland and Youngstown, Ohio. During the conversation ADIUTURI and SALAMONE expressed their desires to sell the J-Dee Linen Supply Company to the Keystone Company.

On 9/5/62 the informant reported no pertinent information relating to the subject or his associates.

On 9/6/62 informant reported that LA DUCA, MONTANA and SCRO discussed the business problems of the Camellia Linen Supply Company, Inc.

On 9/7/62 the informant reported that VINCENT A. SCRO informed PIERRE MODABER that he had been to Fort Myers, Fla., on his vacation and that the room had cost him \$65 a week. PIERRE MODABER informed SCRO that he has rented an apartment in Philadelphia on a temporary basis.
