Lieutenant G. A. BRAUN in a PB4Y-1P Aircraft of Fleet Air Photographic Squadron FIVE took off from Agaña Airfield, Guam, M. I. on 18 May 1945 at 0725 King to photograph enemy installations on Truk Islands. He arrived over the target at 1220 King and took good vertical photographs of Dublon Island from an altitude of 19,000 ft. and vertical photographs of Eten, Param, Moen North and Moen South airfields from an altitude of 18,000 ft. Heavy, neager, accurate antiaircraft fire was encountered coming from Dublon Island. There was no enemy interception. Lieut. BRAUN returned to base at 1500 King.
