# NATIONAL INSURANCE AND INDUSTRIAL INJURIES

### **Classification and Collection of Contributions**

REGULATIONS, DATED 2ND JULY 1974, MADE BY THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES, IN CONJUNCTION WITH THE DEPARTMENT OF FINANCE, UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND) 1966 AND THE NATIONAL INSURANCE (INDUSTRIAL INJURIES) ACT (NOR-THERN IRELAND) 1966.

The Department of Health and Social Services, in conjunction with the Department of Finance so far as relates to matters with regard to which the Department of Finance has so directed, in exercise of powers conferred by sections 1(3) and 8(5) of the National Insurance Act (Northern Ireland) 1966(a) and section 3(3)(b) of the National Insurance (Industrial Injuries) Act (Northern Ireland) 1966(b), and of all other powers enabling it in that behalf, hereby makes the following regulations being regulations subject to negative resolution in accordance with sections 101(3) and 80(2) respectively of those Acts:

#### Citation and commencement

1. These regulations may be cited as the National Insurance and Indus-trial Injuries (Classification and Collection of Contributions) Amendment Regulations (Northern Ireland) 1974 and shall come into operation on 5th August 1974.

### Amendment of the National Insurance (Classification) Regulations

2. In Schedule 1 to the National Insurance (Classification) Regulations (Northern Ireland) 1972(c) (classification of insured persons)-

- (a) for the sum "£7.00" in paragraphs 9 in column (B), 13 in columns (A) and (B), 40 to 57 in column (B) there shall be substituted the sum "£9.00", and
- (b) for the sum "£6.00" in paragraph 25 in column (A) there shall be substituted the sum "£8.00".

### Amendment of the National Insurance and Industrial Injuries (Collection of Contributions) Regulations

3. In regulation 10A (contributions in weeks in which no services are rendered and remuneration does not exceed the specified amount) and in the proviso to regulation 11 (contributions during holidays) of the National Insurance and Industrial Injuries (Collection of Contributions) Regulations (Northern Ireland) 1948(d) for the sum "£7.00" there shall be substituted the sum " $\pounds 9.00$ ".

# EXPLANATORY NOTE

(This note is not part of the regulations, but is intended to indicate their general purport.)

These regulations, by amending various paragraphs of Schedule 1 to the National Insurance (Classification) Regulations (Northern Ireland) 1972 and regulations 10A and 11 of the National Insurance and Industrial Injuries (Collection of Contributions) Regulations (Northern Ireland) 1948, raise the sum of weekly earnings in the case of certain insured persons in specified employments where classification is modified or where liability for contributions is determined by reference to their earnings.
