1. Telephone conversation between this headquarters and Shiga Military Government Team revealed the fact that there is a correspondence file in Headquarters Shiga Military Government Team on the case of William Van West.

2. SCAPIN-3903-A, 3 June 1947, attached hereto as Inclosure 2, directs the Central Liaison Office in Tokyo to restore the title of this property to William Van West.

3. The property of William Van West was used by the Japanese Navy during the war in connection with Shiga Naval Air Base. At the end of the war the Shiga Naval Air Base was taken over by Occupation Forces for operational use. The well in question is still in use by the Hydroponic Farm.

4. Due to the fact this property was used by the Japanese Navy and subsequently taken over by the Occupation Forces for operations, it is classed as a military installation under OD 26/16, Headquarters Eighth Army, dated 24 December 1947.

5. This case appears as a matter between William Van West, Shiga Military Government Team and the Hydroponic Farm.

6. Request this headquarters be notified if this property is declared a military installation so that proper records can be made.

b. The new policy prohibits the receipt of additional claims by CPC unless they have been processed through the respective Diplomatic Missions and a special Claims Board now functioning in the Diplomatic Section of GHQ.

c. In the future any Foreign National making application for the settlement of property disputes will be referred to their respective diplomatic representatives. In the event a Foreign National has no diplomatic representative in Japan, he should be instructed to make his application to Central Liaison Office, Japanese Government, through Prefectural Government.
