

GUY CORDON

Republican, Candidate for Nomination for United States Senator



Guy Cordon, Oregon's senior Senator, was appointed by Governor Earl Snell to succeed Senator Charles L. McNary. He was elected in 1944 for the balance of Senator McNary's term and again in 1948 for a full six years.

Senator Cordon is eighth ranking Senate Republican in length of service. This invaluable seniority and his qualities of leadership give him membership on three vital Senate committees: Appropriations, Interior and Insular Affairs, Joint Committee on Atomic Energy. He also is on five major subcommittees of the powerful Appropriations Committee: Armed Services, Civil Functions, Independent Offices. Interior (Chairman) and Treasury—Post Office. In addition, he is a member of the Republican Policy Committee.

His senior position on the Appropriations Committee

continues to be of tremendous value to the Pacific Northwest for obtaining funds to build multiple purpose dams for Electrical Energy, flood control and

development of navigation and irrigation.

His connection with the Interior and Insular Affairs Committee gives him a significant voice in formulating legislation affecting all of Oregon's interests. Under the reorganization act, this committee has jurisdiction over matters previously considered by the committees on Public Lands and Surveys—Mines and Mining, Territories and Insular Affairs, Irrigation and Reclamation and Indian Affairs. His assignment to the Republican Policy Committee permits him to assist in the formulation of national and international Republican legislative policies in the Senate.

An idea of the esteem in which Senator Cordon is held by other members of the Senate may be gained from an article written by Senator Margaret Chase Smith of Maine and published in the newspapers of her home state in

the fall of 1953. She states:

Senator Cordon is one of the "quiet and effective" senators who "get results. If everyone performed as he did, the Senate would complete its work much sooner each year. Senator Cordon has the disciplined, straightforward kind of thinking that makes you keep your eye on the ball. There are no frills to Senator Cordon. He is a man of proved political courage."

to keep U.S. Senator Guy Cordon on the job!







Entering the University of Oregon in 1919, he waited on tables, washed dishes and corrected examination papers to earn a degree in business administration. An appointment as a graduate assistant made it possible for him to attend law school. He worked nights, weekends and summers to complete his law course. He graduated in 1926 with exceptionally high honors in a wide field of scholastic activities. The same year he moved to Hillsboro where he has since achieved outstanding success as a practicing attorney.

The civic record of Paul Patterson is the record of jobs effectively and well done. A member of the State Senate in 1945, 1947, 1949 and 1951, he was elected President of the Senate in 1951. In his home town of Hillsboro he has been President of the Chamber of Commerce, President of the Hillsboro Rotary Club, President of the Washington County Veterans Council, Commander of Hillsboro Post No. 6 of the American Legion and President of the Washington County Chapter of the Izaak Walton League. 
I will protect working people and their organizations in the exercise of their rights. But no organization, labor or employer, shall override the public interest nor the authority of the state.







ROBERT F. COOK

Mr. Cook was born in Texas in 1899, being the great-great grandson of Captain James Cook, who explored the Oregon Coast in 1778. He was educated in the University of Nebraska for public service, taking degrees in political science. His thesis on the unicameral legislature was used as a guide by Senator George Norris in influencing the people of Nebraska to adopt the plan.

In the political field, Mr. Cook worked as a research assistant for the Legislature of Nebraska, and later was Sergeant-at-Arms in the House of Representatives there.

In 1936 he took direction of a real estate development and sales program in the lower Rio Grande Valley of Texas. The press of war in 1941 caused him to move to the West Coast for work with the Maritime Commission. He took delivery of the first ship that Kaiser built in the Swan Island yard, the S. S. Schenectady, and logged 143,000 miles on her.

In the Navy during World War I and the Merchant Marine during World War

If he has sailed all seven seas and visited most of the major ports of the world.

On leaving the Merchant Marine in 1947 Mr. Cook purchased a farm in Marion County, where he now lives, and is one of the largest hog raisers in the Willamette Valley. He is married and has one son, now serving in the Army.

All that know him are impressed by his keen grasp of the government of Oregon, and its problems and weaknesses. He is especially concerned over the injustice of high taxes on farms, which at times equal or exceed the income. Mr. Cook is especially indignant over the fact that while the State borrows money for less than 2%, it charges a taxpayer 8% if he is unable to pay his tribute on time. He would reduce delinquent tax interest to 3%.

Our candidate contends that much of the loose spending by the various state departments and agencies could be curtailed. Article IX, paragraph 6 of the Oregon Constitution breeds this condition by requiring the legislature to find revenue for whatever is spent. Mr. Cook feels that this should be changed.


