SUBJECT : Location and Requirements - MRBM/IRBM & AE Sites

1. Selections from these requirements should be passed to any and all assets with possible access to the below listed areas:

a. Medium Range Ballistic Missile Sites (MRBM):

- 1) *San Diego de los Baños N22-40-05 W83-17-15
- 2) San Diego de los Baños N22-40-50 W83-15-00
- 3) *San Cristobal N22-42-50 W83-08-15
- 4) *Sagua la Grande N22-43-45 W80-01-15
- 5) Sagua la Grande (near Calabazar de Sagua) N22-39-15 W79-51-45
- 6) Candelaria N22-47-45 W82-58-40

b. Intermediate Range Ballistic Missile Sites (IRBM):

- 1) *Guanajay N22-57-20 W82-37-05
 - 2) *Guanajay N22-56-50 W82-39-20
 - 3) *Caibarien/Remedios Area N22-25 W79-35
- ~~(Danzon, etc.) N22-22 W79-00~~

c. Possible Nuclear Storage Areas:

- 1) All areas above with * before the name. Also:
- 2) Punta Gerardo (Bahia Honda Bay) N22-56-08 W83-11-10

2. Requirements for MRBM and IRBM Sites:

a. Report physical security details around site:

- 1) How many guards at one time.
- 2) Are they Soviet, Cubans or mixture.
- 3) Hours guards changed
- 4) How far out from site are guards posted.
- 5) Do they form ring around site.

b. Soviet personnel assigned:

- 1) Estimate number Soviets assigned and basis for estimate.
- 2) Give hours of day or night when groups of Soviets leave the site to go to town, etc.
- 3) Report any state of alert noted at the site.

c. Ground photos and detailed description:

- 1) Mi iles, radar vans and vans containing generators entering or observed on site.
 - 2) Give careful estimate of dimensions of any boxes, crates, or missiles.
 - 3) Describe any communications antenna or towers inside the sites.
- d. Tank trucks and fuel tanks:
- 1) Report details of large kerosene tank trucks entering sites.
 - 2) If able to observe inside a site, report number and dimensions of large fuel tanks above the ground.
 - 3) Report details on transferring fuel into the tanks.
- e. Cubans in sites: Report if any Cubans or certain individuals are allowed access into a site. Give detail.
- f. Anti-aircraft: Report all details and pinpoint locations of conventional anti-aircraft around any site.
3. Requirements for suspected nuclear storage areas: Observe and report all details:
- a. Any indications of maximum 24 hour physical security of the entire site area. Report double fencing: (This would be one ring of fence within another.)
 - b. Earth-covered drive-through structures (buildings) for trucks. Also same for truck drive-through in caves. (Buildings would be about 115 x 60 feet.)
 - c. Observe or listen for large ventilation machinery operating on top of the drive-through buildings or caves.
 - d. Report any unusually heavy objects or boxes (size at least $1\frac{1}{2}$ x $1\frac{1}{2}$ x 2 or $2\frac{1}{2}$ meters) on trucks or on their own dollies. Note: If these are being moved, they will receive extra careful handling.
 - e. Any large amounts of test electronic equipment (which will look like radio repair shop equipment). Note: Need very detailed description.
