DEPENDENT HOUSING

1. In order for this headquarters to maintain accurate data as to status of individuals who have submitted applications for dependent travel, all ground force units in the Fukuoka Area and the Commanding Officer, 610th Aircraft Control and Warning Squadron, will furnish this headquarters the following report on the 15th and last day of each month.

- a. Names of individuals and house number whose dependent are occupying housing in the area with departure dates.
- b. Names of individuals who have submitted applications through this headquarters and who are still stationed in the area.
- c. Names of individuals who have submitted applications and have been transferred to another area, indicating area to which they have been transferred.

2. This report will be submitted in time to reach this headquarters on the dates indicated in paragraph 1 above.

4. The Commanding Officer of each major unit will appoint a Dependent Housing Officer. This officer will be considered a member of the Dependent Housing Advisory Council, established for the purpose of maintaining close liaison, on dependent housing matters, between this headquarter and the units concerned.

5. Principal duties of the Dependent Housing Officer so appointed are as follows:

- a. Meet as a member of the council at least once each month to discuss and aid in the solution of common and problems developed by the present housing shortage/to aid in their solution.

Radio cite EX 31366 DH, Headquarters Eighth Army, dated 28 December 48 is quoted for your information and guidance:

"General Headquarters Radio CX 66465 dated 20 December 48 is quoted for your information and necessary action."

"In order to effect the most economical use of limited housing available in the Far East Command and to reduce to a minimum the waiting time of eligible personnel for their families to join them, the following policy is announced concerning assignments of abodes:

a. Dependent Housing, temporary or permanent, will not be assigned to personnel below General Officer rank, until actual departure of the dependent from the Port of Embarkation.

b. Dependent Housing, except that which is established for assignment to General Officers, will not be held vacant or occupied by officers in bachelor status pending establishment of eligibility of any individual for travel of his dependents.

c. Specific dependent houses desired to be occupied eventually by certain personnel because of position or duties be assigned to other authorized persons with dependents to a temporary assignment basis pending arrival of dependents of personnel to be permanently assigned there to. The foregoing refers only to the assignment of dependent quarters to personnel entitled to Government Transportation and quarters for dependents under criteria previously announced."
