I, MITSUAKI KAKEHI, do hereby certify:

1. That I am presently employed by the Japanese Government as a non-regular member of the staff of the Central Liaison Office and am engaged with the International Military Tribunal for the Far East as language arbiter. That I worked during the period of June 1937 to December 1938 as an adviser or associate editor of the "Tokyo Gazette", and as editor and publisher of the "Tokyo Gazette" as an employee of the Japanese Government in the capacity of a non-regular member of the governmental agency supervising the publication of the "Tokyo Gazette" from January 1939 to March 1942.
