RE INFORMANT-S STATEMENT IN RETEL WHERE HE STATED HE WAS WITH ALBERT ANASTASIA EVERY DAY FOR A PERIOD OF THREE YEARS, TERMINATING ABOUT A WEEK BEFORE ANASTASIA WAS KILLED, INFORMANT EXPLAINED AS FOLLOWS..

AT THE TIME HE WAS MADE IN FIFTY THREE, HIS BROTHER-IN-LAW, JOSEPH PARISI, WAS A BUTTON MAN WHO HAD BEEN REPORTING DIRECTLY TO ALBERT ANASTASIA, WHO WAS AN UNDERBOSS AT THAT TIME. PARISI HAD BEEN A CLOSE ASSOCIATE OF ANASTASIA FOR FIFTEEN YEARS PRIOR TO FIFTY THREE.

ANASTASIA ATTENDED THE CEREMONY WHEN INFORMANT WAS MADE AND SUBSEQUENTLY TOOK A LIKING TO HIM BECAUSE HE WAS THE BROTHER-IN-LAW OF PARISI. AFTER INFORMANT BECAME A BUTTON, ANASTASIA GAVE HIM A JOB IN A CRAP GAME WHICH INFORMANT HELD UNTIL ANASTASIA WAS KILLED. THROUGH HIS CONNECTION WITH THIS CRAP GAME INFORMANT HAD SOME CONTACT WITH ANASTASIA ALMOST EVERY DAY. ALSO DURING THIS PERIOD ANASTASIA GAVE HIM NUMEROUS ODD JOBS TO HANDLE. ABOUT FIFTY SIX, ANASTASIA GAVE INFORMANT A CONTRACT TO GIVE A BEATING TO BERNARD ADELSTEIN, SECRETARY AND TREASURER, LOCAL EIGHT ONE THREE, OF PRIVATE SANITATION, TWO TWO ONE PARK AVE., SOUTH, NYC. THIS CAME ABOUT AS FOLLOWS..

*W/S* JOSEPH SCHIPANI AND VINCENT SQUILLANTE WERE GIVEN INSTRUCTIONS TO COLLECT TWO HUNDRED DOLLARS FROM EACH PRIVATE SANITATION FIRM IN NYC SO AS A PAY OFF COULD BE MADE TO THE NYC POLITICIANS TO GET THEM TO DO AWAY WITH PUBLIC SANITATION FOR BUSINESS FIRMS IN NYC AND TO GET THEM TO ISSUE NO ADDITIONAL LICENSES TO PRIVATE SANITATION FIRMS, CONSEQUENTLY ALLOWING THOSE EXISTING PRIVATE SANITATION FIRMS TO MAKE MILLION

OF DOLLARS. SUPPOSEDLY, FORTY THOUSAND DOLLARS WAS COLLECTED AND GIVEN TO ADELSTEIN. ADELSTEIN TOLD ANASTASIA HE GAVE THE MONEY TO PARISI AND ABOUT THAT TIME PARISI DIED. ANASTASIA DID NOT BELIEVE ADELSTEIN-S STORY AND SENT INFORMANT TO GIVE ADELSTEIN A BEATING SO HE WOULD COME UP WITH THE MONEY. INFORMANT GAVE ADELSTEIN A BEATING BUT ADELSTEIN STUCK TO HIS STORY. ANASTASIA SENT INFORMANT TO GIVE ADELSTEIN A SECOND AND THIRD BEATING. INFORMANT ADMINISTERED THE FIRST TWO BEATINGS, BUT DID NOT ADMINISTER THE THIRD BEATING BECAUSE ABOUT THAT TIME SQUILLANTE AND HIS CARTAGE BUSINESS BEGAN HAVING TROUBLE WITH THE POLICE AND THINGS WERE GETTING TOO HOT. INFORMANT STATED ONLY TWO OR THREE PERSONS KNOW THE ABOVE FACTS.

IN RETEL, INFORMANT STATED THAT ~~JOHN SCALES~~ <sup>W. J. O'Brien</sup> WAS ON THE "COMMISSION". HE POINTED OUT THAT THE "COMMISSION" IS ~~ACTUALLY REFERRED TO AS~~ <sup>W. J. O'Brien</sup> THE "HIGH COMMISSION" TO DISTINGUISH IT FROM THE "COMMISSION" WITHIN EACH RESPECTIVE FAMILY. INFORMANT ADVISED THAT AT A MEETING IN FIFTY FIVE OF HIS "REGINA OR REGIMA", HIS IMMEDIATE GROUP, MEANING HIS CAPTAIN, ~~CHARLES DONGARRA~~, AND THOSE UNDER HIM WERE ADVISED THAT JOHN

"HIGH COMMISSION" WANTS NO TROUBLE WHATSOEVER AND IF THE FBI IS CONDUCTING AN INVESTIGATION RE THE BOMBING OF CHARLES CAVALLARO THIS COULD WELL HAVE BEEN THE REASON FOR THE NO MORE BOMBINGS ORDER. HE STATED THE "HIGH COMMISSION" HAD SENT OUT WORD IN THE PAST THAT NO ONE WAS TO HANDLE NARCOTICS AND NOW AND THEN THIS ORDER IS REPEATED. INFORMANT STATED HE HAD BEEN TALKING WITH BENNY ~~VALVO~~, A BUTTON MAN IN THE BONANNO FAMILY, ON DEC. THREE ONE, SIXTY TWO, AND ~~VALVO~~ TOLD HIM THAT GAROFALO IS BONANNO-S UNDERBOSS AND HE WENT TO ITALY ABOUT FIVE TO SIX YEARS AGO. HE WAS HANDLING NARCOTICS AND HE GOT FRIGHTENED. BENNY VALVO ADVISED INFORMANT THAT HIS BROTHER, ~~MATTIE VALVO~~ IS A CAPTAIN IN THE BONANNO FAMILY.
