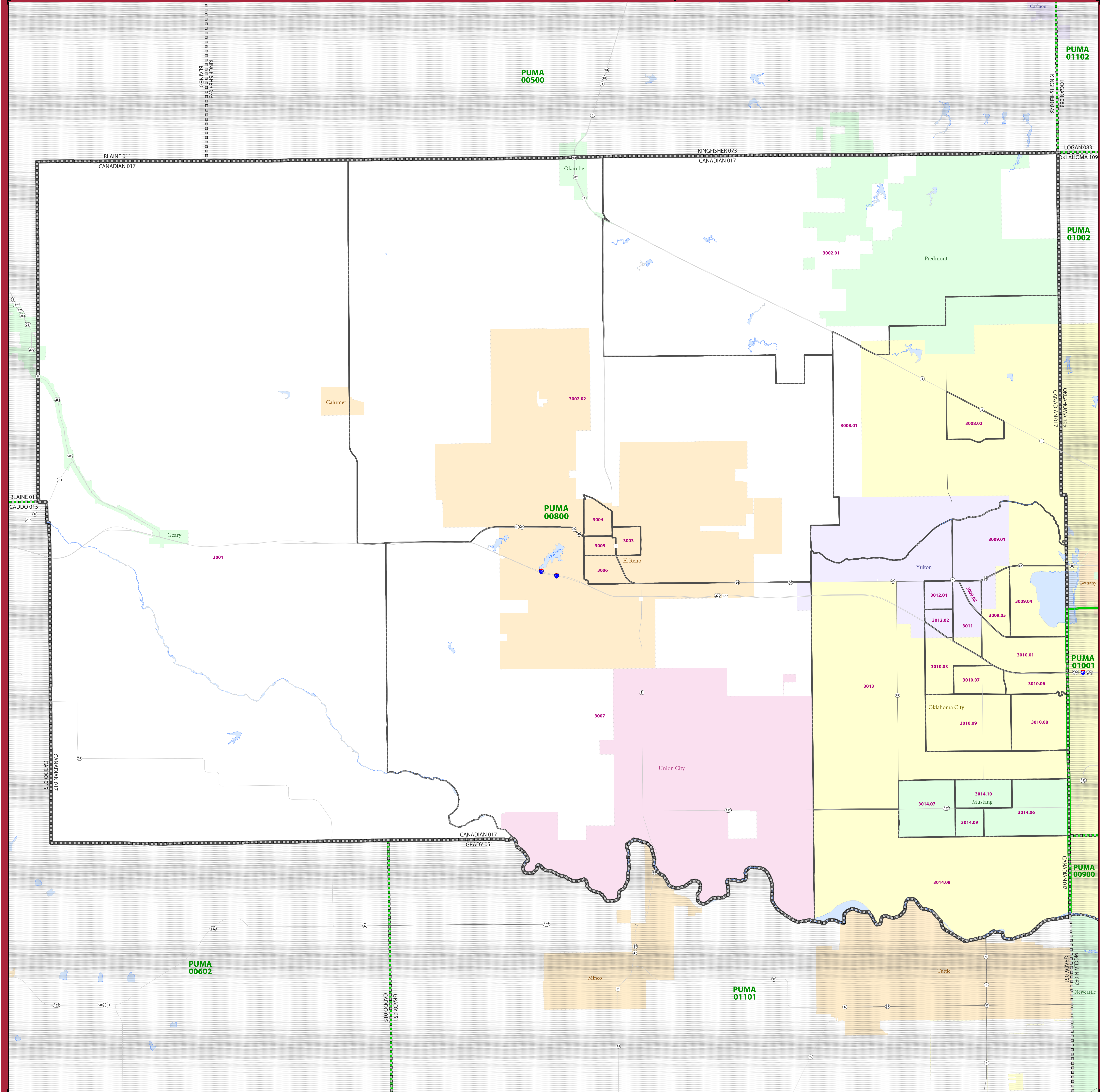


2010 CENSUS - PUMA REFERENCE MAP: Canadian County--Oklahoma City (West)
