Eight FM-2s of VC-35, led by Lieutenant William A. JAMES, USNR, took off from parent ship for combat air patrol over Okinawa Shima.

The group was assigned a sector 30 miles west of the island. Upon being relieved they were given instructions to strafe targets of opportunity over the island of Kume Shima.

Results are as follows:

- 1. Group set fire to three small boats on west beach.**
- 2. Also set small fires in two towns on east coast.**
- 3. Strafed suspected gas stowage dumps near airfield.**

No enemy opposition was encountered and all planes returned safely to base.
