NOTICE TO VOTERS

Chapter 154, Oregon Laws 1955, directs that there be placed in each Voters' Pamphlet a page setting forth certain information regarding registration and voting. This information as summarized from the Oregon Election Laws, is as follows:

(1) **Requirements for a Citizen to Qualify as a Voter.** Every citizen of the United States of the age of 21 years and over, who shall have resided in Oregon during the six months immediately preceding a primary or general election, and who shall be **duly registered**, shall be entitled to vote, provided such citizen is able to read and write the English language.

Registration as a voter is effected by appearing at the office of the County Clerk in the courthouse at the County Seat, and signing the form that is prescribed by law for that purpose, or by appearing before an official Registrar appointed by the County Clerk to function in the community in which the prospective voter resides. The name and address of a local Registrar can be obtained at a newspaper office, or from the City Recorder. No registrations are permitted during 30 days immediately preceding an election.

Registration continues to be valid indefinitely except as noted in topic (2) following.

(2) **When a Voter is Required to Reregister.** Reregistration is required when:

(A) The elector (used synonymously in the law with voter), has failed to vote at one election at least in any biennial election period.

(B) The elector changes his or her address by removing to another precinct or county.

(C) The elector desires to change his or her political party.

(D) The name of a woman elector is changed by marriage.

The procedure for reregistering is the same as for registering originally except that electors who have moved to a different precinct within the same county, or whose names have been changed by marriage, have the option of reregistering by mail.

(3) **How a Voter may Obtain and Use an Absentee Ballot.** A registered voter in any of the following categories may apply to his or her County Clerk for an Absent Voter's Ballot.

(A) Those who are to be absent from their County on the day of election.

(B) Those who reside more than 15 miles by nearest traveled road from the polling place in their precinct.

(C) Those who are physically unable to attend the polls in person.

Applications for the ballot may be filed with, or mailed to the County Clerk at any time within 60 days preceding the election. No special form of application is prescribed; an informal request is sufficient. The ballot must be returned in time to reach the County Clerk not less than five days prior to the election.

Chapter 332, Laws of 1955, provides a special procedure for absentee registration and voting by members of the armed forces, and certain classes of service civilians on duty in foreign countries.

(4) **How a Voter may Obtain and Use a Certificate of Registration.**

(A) A registered voter who changes his residence within the County after the registration period terminates 30 days prior to an election, may procure from the County Clerk's office a certificate which will authorize him to vote in the precinct to which he has moved.

(B) If the voter is to be absent from his County on election day he may obtain from the Clerk's office a certificate which will entitle him to vote in another county for candidates for State and District offices and on State measures.

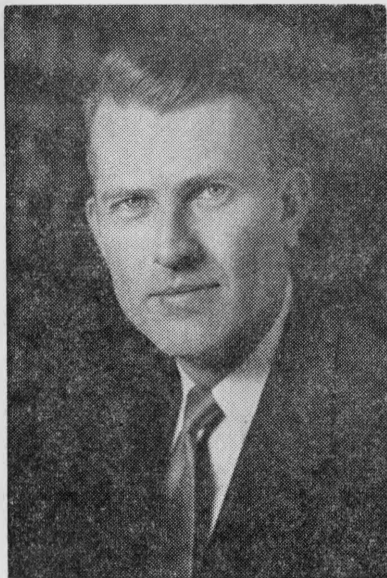

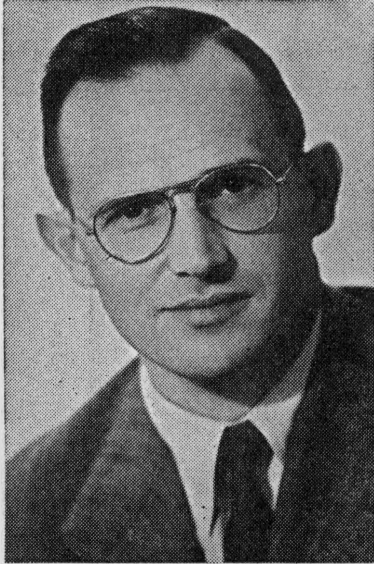

location of industry. I know the importance of cheap electric power to the prosperity of the Northwest.

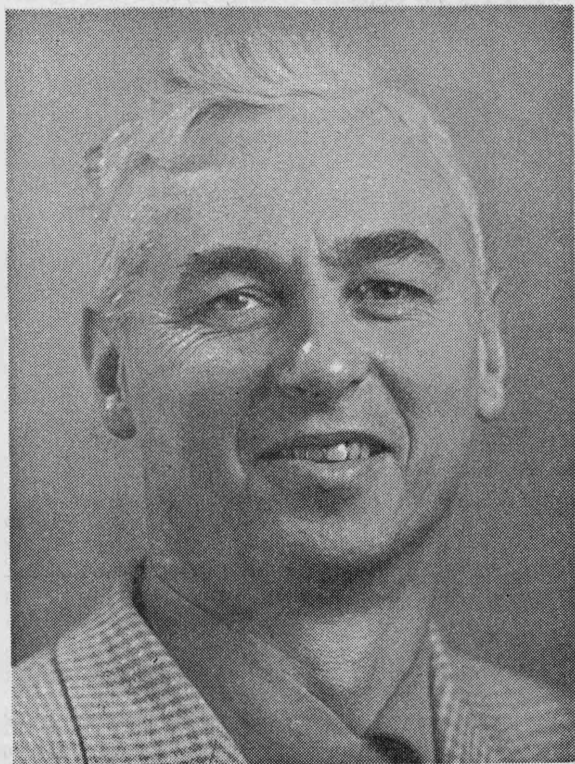

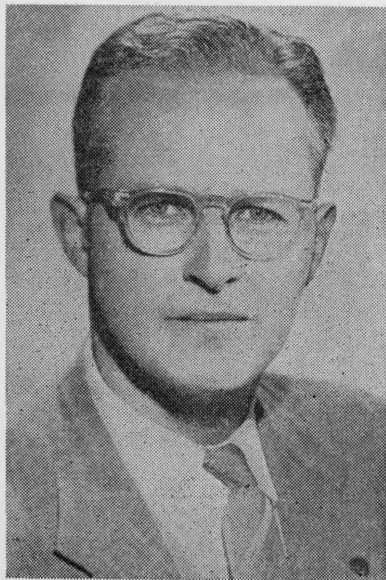

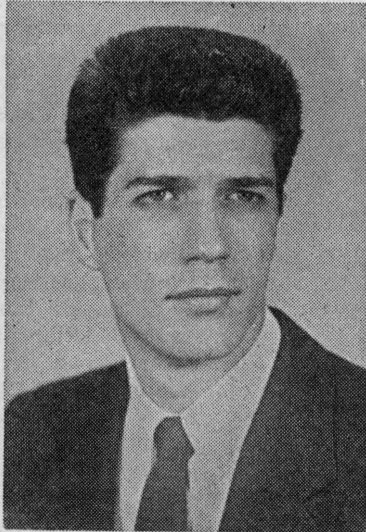

Your vote for me as a delegate at large to the National Democratic Convention will be proof that you share with me the conviction that Hells Canyon has a vital role in the comprehensive development of the water resources of the Columbia River Basin. Along with this goes the inescapable conclusion that the Democratic party is the only political party that can be relied upon to restore this program.

The high dam was approved by Oregon's voters in 1948 when they defeated Oxbow S.B. 99 by a vote of 173,004 to 242,100. Full coordination in 1948 between upstream interests of reclamation and downstream interests of flood control and navigation resulted in the decision that high Hells Canyon dam should be the next great power producer of the Columbia River system. Nevertheless, certain Republican members of Oregon's Congressional delegation failed to support storage projects, particularly Hells Canyon, the key to this system, committing the tragic error which Senator Morse described thus: "Anything less than full development is selfish, uneconomical and definitely harmful to the best interests of the general public".

Events following 1952 are crystal clear. Hells Canyon was abandoned by Secretary McKay. The Federal Power Commission was completely reshaped. The private utility blocking Hells Canyon switched its plan from a five to a three-dam scheme. Within weeks the FPC hearing began. The hearing examiner concluded: The high dam is superior to the low dams by 400,000 kws of power; superior by 3 million acre-feet of flood control storage; superior in navigation; superior in recreational values. Furthermore, the examiner concluded the costs of high dam power "would not affect the current Bonneville rate of \$17.50" but that the cost of power from the low dams would be 6.6 mills which he termed "fancy priced power in the Northwest area".

But the administration's agency ignored these findings and granted a low dam license. After the license grant, the company filed new plans for the low dams. An appeal from the license was taken to the federal courts. Oregon had not granted the company a permit to build the dam. The Army Engineers had not granted a permit to build a bridge at the dam. Notwithstanding this, the low dam work was commenced on the Snake. At the same time, the low dam company applied for millions of dollars in quick amortization tax write-offs to help finance construction, partially at other taxpayers' expense.

Democratic Senators Morse and Neuberger have stood firm against all this. Consider these words of Senator Morse: "Without qualification I say Hells Canyon Dam is necessary to the welfare of the people of the Northwest. It is needed to keep pace with the ever-growing demand for power for industry and for our growing population, to control devastating floods on the lower Columbia, to improve navigation on the Columbia and Snake, and to enhance opportunities for new irrigation."

Oregon's Democratic voters can help end this abdication of comprehensive development irresponsibly engineered by the Republican administration at Hells Canyon. The Democratic party recognizes the importance of high Hells Canyon not only for our generation, but also for generations of Americans to come. This is worth a hard fight. We should battle now for Hells Canyon to the best of our abilities.

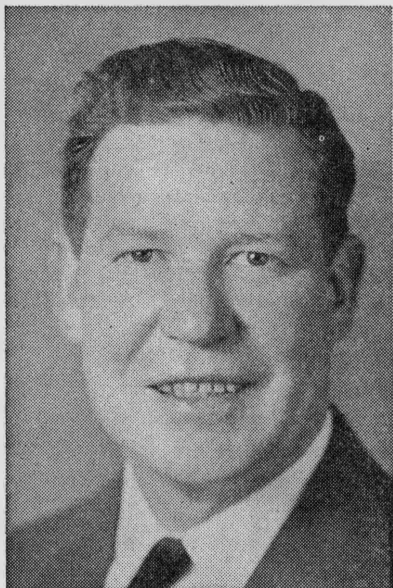

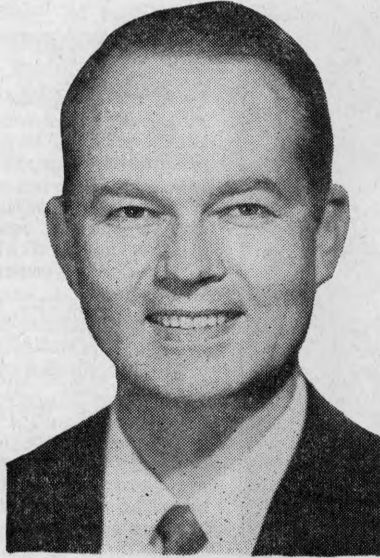

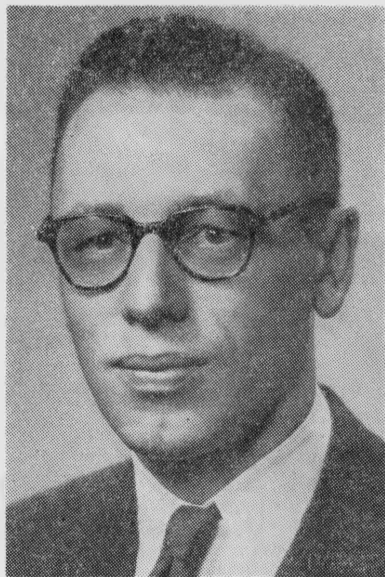
