Success Story

In cooperation with county Extension agents (CEA's), personnel at the Extension Poultry Science Department, University of Georgia, have initiated a management program for service personnel at specific poultry companies. A short program is presented at the service managers weekly management meeting. The objectives of the current topic are to summarize water quality factors influencing performance of poultry, to discuss water sampling procedures, types of analyses available and where analyses may be obtained, and to discuss cost:benefit relationships of monitoring water quality. This type program has several advantages; among them are: increase interest of CEA in poultry; improve visibility of the CEA to the local poultry industry; increase the knowledge level of service/management personnel at the poultry company; maintain contact with the poultry industry. 2) The FDA has approved a supplemental new animal drug application (NADA) filed by Elanco Products Co., which provides for the use of monensin in broiler and replacement chickens with NO withdrawal period. The regulations are also amended to revoke the tolerance for negligible residues and to establish the safe concentrations for monensin residues in chicken tissues. The safe concentrations for total residues of monensin in chickens are 1.5 ppm in muscle, 3.0 ppm in skin with adhering fat, and 4.5 ppm in liver. A tolerance for a marker residue of monensin is not needed. Effective: August 12, 1985. For more information, contact:

3) The Animal and Plant Health Inspection Service (APHIS), USDA, has affirmed the interim rule which amended regulations concerning the importation into the U.S. of carcasses and/or parts thereof, and certain (hatching) eggs by Great Britain. This change occurred because Great Britain has been declared to be free of viscerotropic velogenic Newcastle disease (VVND). The effect of this ruling is to relieve certain restrictions on the importation of the previously mentioned products. Only four comments were received regarding this proposed change -- 2 in favor and 2 opposed. The effective date is July 15, 1985. For more information, contact:

4) The USDA has withdrawn the proposed rule to allow birds originating in the U.S. and the offspring of such birds to be imported into the U.S. without quarantine (Federal Register, May 3, 1985, pp. 18865-18869; this newsletter, May 10, 1985). Approximately 850 comments were received, with only seven being in favor of the proposal. Evidently it pays to voice your opinion.
