## TYRRANOUS TACTICS

Leitrim's Protest Against the Kidnapping of T.D.

There was a large attendance at the pro-Treaty meeting in Carrick-on-Shannon, Co. Leitrim. A band headed contingents from the Drumlish district of Co. Roscommon, and a large party of men from the South Leitrim Brigade, I.R.A., were paraded prior to the meeting, to which they later marched, joining the general public.

Mr. A. Lavin, T.D., who had been kidnapped the previous night, made a powerful speech, in which he explained what such conduct led to. His listeners loudly applauded in approval.

Very Rev. Canon O'Reilly, P.P., V.F., in moving Mr. Thos. Carter, T.D., to the chair, said that ground gained should be maintained, and when the country recovered they could make further advances. They should maintain unity now and during the election.

Mr. Carter said it was for the people to decide whether they would accept what they had got or drive the country into chaos, war, and ruination.

Rev. Malachy Brennan, C.C., Mantua, said North Roscommon was unanimous and altogether whole-hearted for the Treaty. If the Treaty were smashed they would have to travel another forty years in the desert without ever seeing the promised land of freedom.

Mr. Lavin said some people told him he had subverted the Republic by voting for the Treaty; but some of them would have to live another few generations before they would be able to say they did as much he he did for the Republic.

They would be better able to fight for a Republic when they had their own army than when a few men on the run around the hill-sides, with an old shotgun between five, were trying to get a crack at an odd old peeler (cheers).

He said the tactics of their opponents was one of intimidation, and an effort to prevent the right of free speech. He referred to his kidnapping, and said some young men who now stood on the rock of a Republic arrested him the previous night.

He pointed out to them that the action they were taking would do more good than if he spoke at six public meetings.

Referring to the men who arrested him, Mr. Lavin aded emphatically, "When the row rises again I'll see they will be in the fight as well as me."

Mr. James N. Dolan said the British Empire was driven bag and baggage out of the country and they won a tremendous victory.

If it were not for the men behind the guns they would not be enjoying the freedom they had. He protested against the arrest of Mr. Lavin and against tyranny, no matter from whom it came.
